11 expenses of various agencies of the executive,
12 legislative and judicial departments of the state;
13 making appropriations to the State Board of

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of
Education from any monies not otherwise appropriated from the
General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2018, the sum of _____ Dollars (\$0.00) or so much
2 thereof as may be necessary for the financial support of public
3 schools.

4 SECTION 2. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 Education Reform Revolving Fund created in Section 34.89 of Title 62
7 of the Oklahoma Statutes, the sum of _____ Dollars (\$0.00) or
8 so much thereof as may be necessary for the financial support of
9 public schools.

10 SECTION 3. The State Board of Education is hereby authorized to
11 expend during the fiscal year ending June 30, 2018, from the Common
12 Education Technology Revolving Fund of the State Treasury, the sum
13 of _____ Dollars (\$0.00) or so much thereof as may be necessary
14 for the financial support of public schools.

15 SECTION 4. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Mineral Leasing Fund of the State Treasury for the fiscal year
18 ending June 30, 2018, the sum of _____ Dollars (\$0.00) or so
19 much thereof as may be necessary for the financial support of public
20 schools.

21 SECTION 5. There is hereby appropriated to the State Board of
22 Education from any monies not otherwise appropriated from the
23 Mineral Leasing Fund of the State Treasury for the fiscal year
24 ending June 30, 2016, the sum of _____ Dollars (\$0.00) or so

1 much thereof as may be necessary for the financial support of public
2 schools.

3 SECTION 6. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2018, the sum of _____ (\$0.00) or
7 so much thereof as may be necessary for the financial support of
8 public schools.

9 SECTION 7. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 Oklahoma Education Lottery Trust Fund of the State Treasury for the
12 fiscal year ending June 30, 2016, the sum of _____ Dollars
13 (\$0.00) or so much thereof as may be necessary for the financial
14 support of public schools.

15 SECTION 8. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 General Revenue Fund of the State Treasury for the fiscal year
18 ending June 30, 2018, the sum of _____ Dollars (\$0.00) or so
19 much thereof as may be necessary for the support of public schools
20 activities.

21 SECTION 9. There is hereby appropriated to the State Board of
22 Education from any monies not otherwise appropriated from the
23 Special Cash Fund of the State Treasury, the sum of _____

1 Dollars (\$0.00) or so much thereof as may be necessary for the
2 purchase of textbooks and instructional materials.

3 SECTION 10. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2018, the sum of _____ Dollars (\$0.00) or so
7 much thereof as may be necessary for administrative and support
8 functions of the State Department of Education.

9 SECTION 11. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 Oklahoma Education Lottery Trust Fund of the State Treasury for the
12 fiscal year ending June 30, 2018, the sum of _____ Dollars
13 (\$0.00) or so much thereof as may be necessary for transfer to the
14 School Consolidation Assistance Fund.

15 SECTION 12. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2016, the sum of _____ Dollars
19 (\$0.00) or so much thereof as may be necessary for transfer to the
20 School Consolidation Assistance Fund.

21 SECTION 13. There is hereby appropriated to the State Board of
22 Education from any monies not otherwise appropriated from the
23 Oklahoma Education Lottery Trust Fund of the State Treasury for the
24 fiscal year ending June 30, 2018, the sum of _____ Dollars

3 SECTION 14. There is hereby appropriated to the State Board of

7 (\$0.00) or so much thereof as may be necessary for transfer to the

9 SECTION 15. There is hereby appropriated to the Oklahoma Arts
10 Council from any monies not otherwise appropriated from the General
11 Revenue Fund of the State Treasury for the fiscal year ending June
12 30, 2018, the sum of _____ Dollars (\$0.00) or so much thereof
13 as may be necessary to perform the duties imposed upon the Oklahoma
14 Arts Council by law.

15 SECTION 16. There is hereby appropriated to the State Board of
16 Career and Technology Education from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2018, the sum of _____ Dollars
19 (\$0.00) or so much thereof as may be necessary to perform the duties

1 allocation by the Oklahoma State Regents for Higher Education
2 pursuant to the provisions of Article XIII-A of the Oklahoma
3 Constitution for the education and general operating budgets of the
4 institutions and for other programs, construction, renovations or
5 repairs administered by the Oklahoma State Regents for Higher
6 Education.

7 SECTION 23. The Oklahoma State Regents for Higher Education are
8 hereby authorized to expend during the fiscal year ending June 30,
9 2018, the sum of _____ Dollars (\$0.00) from the Oklahoma
10 Student Aid Revolving Fund of the State Treasury for allocation by
11 the Oklahoma State Regents for Higher Education pursuant to the
12 provisions of Article XIII-A of the Oklahoma Constitution for the
13 education and general operating budgets of the institutions and for
14 other programs, construction, renovations or repairs administered by
15 the Oklahoma State Regents for Higher Education.

16 SECTION 24. There is hereby appropriated to the Oklahoma State
17 Regents for Higher Education from any monies not otherwise
18 appropriated from the Special Cash Fund of the State Treasury the
19 sum of _____ Dollars (\$0.00) for allocation by the Oklahoma
20 State Regents for Higher Education pursuant to the provisions of
21 Article XIII-A of the Oklahoma Constitution for the education and
22 general operating budgets of the institutions and for other
23 programs, construction, renovations or repairs administered by the

1 SECTION 25. There is hereby appropriated to the Oklahoma State

2 _____ Dollars (\$0.00) or so much thereof as may be necessary to
3 perform the duties imposed upon the Oklahoma Center for the
4 Advancement of Science and Technology by law. Of those funds
5 appropriated, the sum of _____ Dollars (\$0.00) shall be
6 deposited in the Research Support Revolving Fund, created pursuant
7 to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those

13 (\$0.00) or so much thereof as may be necessary to be transferred to
14 the Building and Facility Revolving Fund created in Section 63.1 of
15 Title 74 of the Oklahoma Statutes for the purpose of maintaining
16 state buildings operated by the Office of Management and Enterprise
17 Services.
