8 An Act relating to sunset; amending 3A O.S. 2011,  
9 Section 604.1, as last amended by Section 1, Chapter  
10 461, O.S.L. 2019 (3A O.S. Supp. 2020, Section 604.1),  
11 which relates to the Oklahoma State Athletic  
12 Commission; re-creating the Commission; and modifying  
13 termination date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 3A O.S. 2011, Section 604.1, as  
16 last amended by Section 1, Chapter 461, O.S.L. 2019 (3A O.S. Supp.  
17 2020, Section 604.1), is amended to read as follows:

18 Section 604.1. A. There is hereby re-created, until July 1,  
19 ~~2021~~ 2024, in accordance with the Oklahoma Sunset Law, the Oklahoma  
20 State Athletic Commission, which shall be composed of nine (9)  
21 members appointed by the Governor with the advice and consent of the  
22 Senate. The ~~member~~ members of the Commission initially appointed  
23 pursuant to this act shall serve a term of three (3) years that  
24 shall expire on June 30, 2006. Members appointed to the Commission  
shall serve for terms of three (3) years. Terms of office shall

1 expire on June 30. All vacancies and unexpired terms shall be  
2 filled in the same manner as the original appointment and within  
3 sixty (60) days from the date of the vacancy. Members may be  
4 removed by the Governor for incompetence, willful neglect of duty,  
5 corruption in office, or malfeasance in office.

6 B. Members appointed to the Commission shall reside in this  
7 state and shall have the following qualifications:

8 1. Two members shall have experience as a professional  
9 combative sports practitioner, other than as a professional wrestler  
10 or in professional combative sports promotions;

11 2. One member shall have experience as a professional wrestler  
12 or in professional wrestling promotions;

13 3. One member shall have experience in sports medicine;

14 4. One member shall have experience in the cable television  
15 business; and

16 5. Four members shall represent the public at large as lay  
17 members.

18 C. No member of the Commission or any person related to a  
19 member within the third degree by consanguinity or affinity shall  
20 promote, sponsor, or have any financial interest in the promotion or  
21 sponsorship of any professional combative sports event or amateur  
22 mixed martial arts event while a member of the Commission.

23 D. The members of the Commission shall elect from their  
24 membership a chair and vice-chair to serve for one-year terms. A

1 majority of the members shall constitute a quorum for the purpose of  
2 conducting the business of the Commission. The Commission shall  
3 meet at least quarterly, and special meetings may be called by the  
4 chair.

5 E. The Commission shall comply with the provisions of the  
6 Oklahoma Open Meeting Act, the Oklahoma Open Records Act, and the  
7 Administrative Procedures Act.

8 F. All members of the Commission and such employees as  
9 determined by the Commission shall be bonded as required by Sections  
10 ~~85.26~~ 85.58Q through ~~85.31~~ 85.58V of Title 74 of the Oklahoma  
11 Statutes.

12 G. Members of the Commission shall serve without compensation  
13 but shall be reimbursed for expenses incurred in the performance of  
14 their duties as provided in the State Travel Reimbursement Act.
