9 COMMITTEE SUBSTITUTE

10 An Act relating to the Oklahoma Commission on
11 Children and Youth; amending 10 O.S. 2011, Section
12 601.4, which relates to powers and duties of the
13 Oklahoma Commission on Children and Youth; permitting
14 Commission to maintain certain information as
15 confidential; authorizing certain requests; and
16 providing an effective date.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. AMENDATORY 10 O.S. 2011, Section 601.4, is
19 amended to read as follows:

20 Section 601.4. The Oklahoma Commission on Children and Youth is
21 further authorized to:

22 1. Facilitate joint planning and service coordination among
23 public and private agencies that provide services to children and
24 youth and maintain as confidential information provided to the
Commission regarding persons using such services;

- 1 2. Prepare and publish reports;
- 2 3. Review the programs, policies, and services for children and
3 youth provided by public and private agencies for compliance with
4 established state policies and progress towards goals identified in
5 planning documents relating to children and youth services and to
6 make reports regarding such compliance and progress;
- 7 4. Accept appropriations, gifts, loans, and grants from the
8 state and federal government and from other sources, public or
9 private;
- 10 5. Enter into agreements or contracts for the development of
11 test models or demonstration programs and projects and for programs
12 of practical research for effective services to children and youth;
13 provided that the administration of contract for such model programs
14 and projects shall, within five (5) years of their inception, be
15 transferred to an appropriate agency or the program or project shall
16 be discontinued;
- 17 6. Secure necessary statistical, technical, administrative,
18 operational, and staff services by interagency agreement or
19 contract;
- 20 7. Examine all records, plans, budgets, and budget documents
21 pertaining to the children and youth service system;
- 22 8. Exercise all incidental powers as necessary and proper for
23 the performance of the duties and responsibilities of the
24 Commission;

1 9. Promulgate rules as necessary to carry out the duties and
2 responsibilities assigned to the Oklahoma Commission on Children and
3 Youth; ~~and~~

4 10. Recommend that a facility providing services to children
5 and youth be closed or that its contract with the state be
6 terminated; and

7 11. Request that cases involving children within its
8 jurisdiction be transferred to the jurisdiction of the Oklahoma
9 State Bureau of Investigation.

10 SECTION 2. This act shall become effective November 1, 2015.
