10	An Act relating to schools; defining term; requiring biennial administration of the Oklahoma Prevention
11	Needs Assessment Survey beginning in certain school year; providing for assistance by the Department of
12	Mental Health and Substance Abuse Services; allowing alternative survey; directing administration of
13	survey subject to certain funding; allowing for promulgation of rules; providing for codification;
14	and providing an effective date.

17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
18	SECTION 1. NEW LAW A new section of law to be codified
19	in the Oklahoma Statutes as Section 24-157 of Title 70, unless there
20	is created a duplication in numbering, reads as follows:
21	A. The "Oklahoma Prevention Needs Assessment Survey" means the
22	biennial mental health prevention survey of public school students
23	in grades six, eight, ten and twelve managed by the Department of
24	Mental Health and Substance Abuse Services.

1 B. Beginning in the 2022-2023 school year, and biennially 2 thereafter, public schools shall administer the Oklahoma Prevention 3 Needs Assessment Survey, or an alternative survey as provided in subsection D of this section, for the purpose of providing direction 4 5 to schools, school districts and communities to effectively improve the lives of students regarding a variety of issues with a focus on 6 alcohol, tobacco, other drug use, mental health, academic failure 7 and violence. 8

9 C. The Department of Mental Health and Substance Abuse Services 10 shall maintain the Oklahoma Prevention Needs Assessment Survey and 11 shall provide technical assistance for schools in survey 12 administration, reporting, planning and development of school mental 13 health prevention and intervention strategies informed by the survey 14 results.

D. If a school or school district chooses to administer an
alternative survey or assessment tool to fulfill the purpose
described in subsection B of this section, it may apply for a waiver
through the Department of Mental Health and Substance Abuse
Services.

E. The provisions of this section shall be subject to the availability of federal funding. If federal funding is insufficient to provide the Oklahoma Prevention Needs Assessment Survey to public schools on a biennial basis, administration of the survey shall not be required.
