9	AS INTRODUCED
10	An Act relating to schools; amending Section 3,
11	Chapter 327, O.S.L. 2014 (70 O.S. Supp. 2016, Section 27-103), which relates to prohibiting a school
12	district from being a member of a school athletic association unless certain requirements are met;
13	requiring association to apply rules in equal and nondiscriminatory manner; requiring rules of
14	association to be in compliance with the Administrative Procedures Act; requiring decisions
15	and certain actions of associations to be in compliance with the Administrative Procedures Act;
16	requiring appeals of decisions of associations to be in compliance with the Administrative Procedures Act;
17	providing criteria for appeals; and declaring an emergency.

20	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
21	SECTION 1. AMENDATORY Section 3, Chapter 327, O.S.L.
22	2014 (70 O.S. Supp. 2016, Section 27-103), is amended to read as
23	follows:
24	

1 Section 27-103. A public school or school district shall not be 2 a member of any school athletic association unless that association 3 has adopted a written policy that requires the following: 4 1. All rules, regulations and policies of the association to be 5 applied in an equal and nondiscriminatory manner to both public and 6 private school members; 7 2. All records of the association to be made accessible consistent with the provisions of the Oklahoma Open Records Act; 8 9 2.3. All meetings of the association to be open and conducted 10 in a manner consistent with the provisions of the Oklahoma Open 11 Meeting Act, including specifically the notice and agenda, voting 12 and executive session requirements; and 13 3.4. All rules, regulations and policies of the association 14 shall be adopted and implemented consistent with the provisions of 15 the Administrative Procedures Act; 16 5. All determinations of student eligibility, assessment of 17 penalties for violations of the rules and policies of the 18 association and actions taken to regulate coaches and school staff 19 shall be conducted in a manner that is consistent with the 20 provisions of the Administrative Procedures Act; 21 6. All appeals of decisions of the association regarding 22 eligibility of students and schools shall be conducted in a manner 23 that is consistent with the provisions of the Administrative 24

1	Procedures Act and shall be expedited and heard by an administrative
2	law judge whose decision may be appealed to the district court; and
3	7. An annual financial audit and a compliance audit of all
4	funds of the association in accordance with the auditing standards
5	set forth in the Oklahoma Public School Audit Law. In addition, the
6	association shall have performance audits conducted of the
7	operations of the association. A performance audit shall be
8	conducted no later than December 31, 2014, and by December 31 every
9	five (5) years thereafter.
10	SECTION 2. It being immediately necessary for the preservation
11	of the public peace, health or safety, an emergency is hereby
12	declared to exist, by reason whereof this act shall take effect and
13	be in full force from and after its passage and approval.
