9 AS INTRODUCED

10 An Act relating to the Office of Educational Quality
11 and Accountability; making an appropriation; stating
12 purpose; requiring budgeting in certain categories
13 and amounts; providing for duties and compensation of
14 employees; providing budgetary limitations; requiring
15 budgeting of certain funds in certain years;
16 providing lapse dates; requiring certain budget
17 procedures; prohibiting certain budget procedures;
18 and providing an effective date.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. There is hereby appropriated to the Office of
21 Educational Quality and Accountability from any monies not otherwise
22 appropriated from the General Revenue Fund of the State Treasury for
23 the fiscal year ending June 30, 2016, the sum of _____
24 Dollars (\$0.00) or so much thereof as may be necessary to perform

1 the duties imposed upon the Office of Educational Quality and
2 Accountability by law.

3 SECTION 2. For the fiscal year ending June 30, 2016, the Office
4 of Educational Quality and Accountability shall budget all funds in
5 the following categories and amounts:

10 SECTION 3. The duties and compensation of employees, not
11 otherwise prescribed by law, necessary to perform the duties imposed
12 upon the Office of Educational Quality and Accountability by law
13 shall be set by the Executive Director of the Office of Educational
14 Quality and Accountability. The Office of Educational Quality and
15 Accountability for the fiscal year ending June 30, 2016, shall be
16 subject to the following budgetary limitations on full-time-
17 equivalent employees and expenditures excluding expenditures for
18 capital and special projects, except as may be authorized pursuant
19 to the provisions of Section 3603 of Title 74 of the Oklahoma
20 Statutes:

1 SECTION 4. Appropriations made by this act, not including
2 appropriations made for capital outlay purposes, may be budgeted for
3 the fiscal year ending June 30, 2016 (hereafter FY-16) or may be
4 budgeted for the fiscal year ending June 30, 2017 (hereafter FY-17).
5 Funds budgeted for FY-16 may be encumbered only through June 30,
6 2016, and must be expended by November 15, 2016. Any funds
7 remaining after November 15, 2016, and not budgeted for FY-17, shall
8 lapse to the credit of the proper fund for the then current fiscal
9 year. Funds budgeted for FY-17 may be encumbered only through June
10 30, 2017. Any funds remaining after November 15, 2017, shall lapse
11 to the credit of the proper fund for the then current fiscal year.
12 These appropriations may not be budgeted in both fiscal years
13 simultaneously. Funds budgeted in FY-16, and not required to pay
14 obligations for that fiscal year, may be budgeted for FY-17, after
15 the agency to which the funds have been appropriated has prepared
16 and submitted a budget work program revision removing these funds
17 from the FY-16 budget work program and after such revision has been
18 approved by the Office of Management and Enterprise Services.

19 SECTION 5. This act shall become effective July 1, 2015.
