9 AS INTRODUCED

10 An Act relating to the State Bond Advisor; making an
11 appropriation to the State Bond Advisor; stating
12 purpose; providing for the duties and compensation of
13 employees; providing budgetary limitations; providing
14 exceptions to the budgetary limitations; making
15 appropriation nonfiscal; providing lapse dates; and
16 providing an effective date.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. There is hereby appropriated to the State Bond
19 Advisor from any monies not otherwise appropriated from the General
20 Revenue Fund of the State Treasury for the fiscal year ending June
21 30, 2016, the sum of _____ Dollars (\$0.00) or so much thereof as
22 may be necessary to perform the duties imposed upon the State Bond
23 Advisor by law.

24 SECTION 2. The duties and compensation of employees, not
otherwise prescribed by law, necessary to perform the duties imposed

1 upon the State Bond Advisor by law shall be set by the State Bond
2 Advisor. The State Bond Advisor for the fiscal year ending June 30,
3 2016, shall be subject to the following budgetary limitations on
4 full-time-equivalent employees and expenditures excluding
5 expenditures for capital and special projects, except as may be
6 authorized pursuant to the provisions of Section 3603 of Title 74 of
7 the Oklahoma Statutes:

11 SECTION 3. Appropriations made by this act, not including
12 appropriations made for capital outlay purposes, may be budgeted for
13 the fiscal year ending June 30, 2016 (hereafter FY-16) or may be
14 budgeted for the fiscal year ending June 30, 2017 (hereafter FY-17).
15 Funds budgeted for FY-16 may be encumbered only through June 30,
16 2016, and must be expended by November 15, 2016. Any funds
17 remaining after November 15, 2016, and not budgeted for FY-17, shall
18 lapse to the credit of the proper fund for the then current fiscal
19 year. Funds budgeted for FY-17 may be encumbered only through June
20 30, 2017. Any funds remaining after November 15, 2017, shall lapse
21 to the credit of the proper fund for the then current fiscal year.
22 These appropriations may not be budgeted in both fiscal years
23 simultaneously. Funds budgeted in FY-16, and not required to pay
24 obligations for that fiscal year, may be budgeted for FY-17, after

1 the agency to which the funds have been appropriated has prepared
2 and submitted a budget work program revision removing these funds
3 from the FY-16 budget work program and after such revision has been
4 approved by the Office of Management and Enterprise Services.

5 SECTION 4. This act shall become effective July 1, 2015.
