9 AS INTRODUCED

10 An Act relating to the Oklahoma State University
11 Medical Center; making an appropriation to the
12 Oklahoma State University Medical Center; stating
13 purpose; providing for duties and compensation of
14 employees; requiring compliance with and providing
15 budgetary limitations; providing lapse dates;
16 requiring and prohibiting certain budget procedures;
17 and providing an effective date.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. There is hereby appropriated to the Oklahoma State
20 University Medical Center from any monies not otherwise appropriated
21 from the General Revenue Fund of the State Treasury for the fiscal
22 year ending June 30, 2016, the sum of _____ (\$0.00) or
23 so much thereof as may be necessary to perform the duties imposed
24 upon the Oklahoma State University Medical Center by law.

1 SECTION 2. The duties and compensation of employees, not
2 otherwise prescribed by law, necessary to perform the duties imposed
3 upon the Oklahoma State University Medical Center by law shall be
4 set by the Executive Director of the Oklahoma State University
5 Medical Center. The Oklahoma State University Medical Center for
6 the fiscal year ending June 30, 2016, shall be subject to the
7 following budgetary limitations on full-time-equivalent employees
8 and expenditures excluding expenditures for capital and special
9 projects, except as may be authorized pursuant to the provisions of
10 Section 3603 of Title 74 of the Oklahoma Statutes:

13 SECTION 3. Appropriations made by this act, not including
14 appropriations made for capital outlay purposes, may be budgeted for
15 the fiscal year ending June 30, 2016 (hereafter FY-16) or may be
16 budgeted for the fiscal year ending June 30, 2017 (hereafter FY-17).
17 Funds budgeted for FY-16 may be encumbered only through June 30,
18 2016, and must be expended by November 15, 2016. Any funds
19 remaining after November 15, 2016, and not budgeted for FY-17, shall
20 lapse to the credit of the proper fund for the then current fiscal
21 year. Funds budgeted for FY-17 may be encumbered only through June
22 30, 2017. Any funds remaining after November 15, 2017, shall lapse
23 to the credit of the proper fund for the then current fiscal year.
24 These appropriations may not be budgeted in both fiscal years

1 simultaneously. Funds budgeted in FY-16, and not required to pay
2 obligations for that fiscal year, may be budgeted for FY-17, after
3 the agency to which the funds have been appropriated has prepared
4 and submitted a budget work program revision removing these funds
5 from the FY-16 budget work program and after such revision has been
6 approved by the Office of Management and Enterprise Services.

7 SECTION 4. This act shall become effective July 1, 2015.
