BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of  
Education from any monies not otherwise appropriated from the  
General Revenue Fund of the State Treasury for the fiscal year  
ending June 30, 2016, the sum of \_\_\_\_\_ Dollars (\$0.00) or so much

1 thereof as may be necessary for the financial support of public  
2 schools.

3 SECTION 2. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 Education Reform Revolving Fund created in Section 34.89 of Title 62  
6 of the Oklahoma Statutes, the sum of \_\_\_\_\_ Dollars (\$0.00) or  
7 so much thereof as may be necessary for the financial support of  
8 public schools.

9 SECTION 3. The State Board of Education is hereby authorized to  
10 expend during the fiscal year ending June 30, 2016, from the Common  
11 Education Technology Revolving Fund of the State Treasury, the sum  
12 of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary  
13 for the financial support of public schools.

14 SECTION 4. There is hereby appropriated to the State Board of  
15 Education from any monies not otherwise appropriated from the  
16 Mineral Leasing Fund of the State Treasury for the fiscal year  
17 ending June 30, 2016, the sum of \_\_\_\_\_ Dollars (\$0.00) or so  
18 much thereof as may be necessary for the financial support of public  
19 schools.

20 SECTION 5. There is hereby appropriated to the State Board of  
21 Education from any monies not otherwise appropriated from the  
22 Mineral Leasing Fund of the State Treasury for the fiscal year  
23 ending June 30, 2014, the sum of \_\_\_\_\_ Dollars (\$0.00) or so

1 much thereof as may be necessary for the financial support of public  
2 schools.

3 SECTION 6. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
6 fiscal year ending June 30, 2016, the sum of \_\_\_\_\_ (\$0.00) or  
7 so much thereof as may be necessary for the financial support of

9 SECTION 7. There is hereby appropriated to the State Board of

18 SECTION 19. There is hereby appropriated to the Office of  
19 Educational Quality and Accountability from any monies not otherwise  
20 appropriated from the General Revenue Fund of the State Treasury for  
21 the fiscal year ending June 30, 2016, the sum of \_\_\_\_\_ Dollars  
22 (\$0.00) or so much thereof as may be necessary to perform the duties  
23 imposed upon the Office of Educational Quality and Accountability by

1 SECTION 20. There is hereby appropriated to the Oklahoma

3 appropriated from the General Revenue Fund of the State Treasury for

16 the Oklahoma State Regents for Higher Education. Of those funds

7 SECTION 23. The Oklahoma State Regents for Higher Education are  
8 hereby authorized to expend during the fiscal year ending June 30,  
9 2016, the sum of \_\_\_\_\_ Dollars (\$0.00) from the Oklahoma  
10 Student Aid Revolving Fund of the State Treasury for allocation by  
11 the Oklahoma State Regents for Higher Education pursuant to the  
12 provisions of Article XIII-A of the Oklahoma Constitution for the  
13 education and general operating budgets of the institutions and for  
14 other programs, construction, renovations or repairs administered by  
15 the Oklahoma State Regents for Higher Education.

16 SECTION 24. There is hereby appropriated to the Oklahoma State  
17 Regents for Higher Education from any monies not otherwise  
18 appropriated from the Special Cash Fund of the State Treasury the  
19 sum of \_\_\_\_\_ Dollars (\$0.00) for allocation by the Oklahoma  
20 State Regents for Higher Education pursuant to the provisions of  
21 Article XIII-A of the Oklahoma Constitution for the education and  
22 general operating budgets of the institutions and for other

24 Oklahoma State Regents for Higher Education.

1 SECTION 25. There is hereby appropriated to the Oklahoma State  
2 Regents for Higher Education from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2016, the sum of \_\_\_\_\_ Dollars

6 concurrent enrollment pursuant to Section 628.13 of Title 70 of the  
7 Oklahoma Statutes.

9 Regents for Higher Education from any monies not otherwise  
10 appropriated from the Oklahoma Education Lottery Trust Fund of the  
11 State Treasury for the fiscal year ending June 30, 2016, the sum of  
12 \_\_\_\_\_ Dollars (\$0.00) pursuant to paragraph 2 of subsection C  
13 of Section 713 of Title 3A of the Oklahoma Statutes for allocation  
14 by the Oklahoma State Regents for Higher Education pursuant to the

24 otherwise appropriated from the General Revenue Fund of the State

1 Treasury for the fiscal year ending June 30, 2016, the sum of  
2 \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary to  
3 perform the duties imposed upon the Oklahoma Center for the  
4 Advancement of Science and Technology by law. Of those funds  
5 appropriated, the sum of \_\_\_\_\_ Dollars (\$0.00) shall be  
6 deposited in the Research Support Revolving Fund, created pursuant  
7 to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those

13 State Auditor and Inspector from any monies not otherwise  
14 appropriated from the General Revenue Fund of the State Treasury for  
15 the fiscal year ending June 30, 2016, the sum of \_\_\_\_\_ Dollars  
16 (\$0.00) or so much thereof as may be necessary to perform the duties  
17 imposed upon the Office of the State Auditor and Inspector by law.

18 SECTION 36. There is hereby appropriated to the Office of the  
19 State Auditor and Inspector from any monies not otherwise  
20 appropriated from the General Revenue Fund of the State Treasury for  
21 the fiscal year ending June 30, 2016, the sum of \_\_\_\_\_ Dollars  
22 (\$0.00) or so much thereof as may be necessary to perform the duties  
23 imposed upon the Commission on County Government Personnel Education  
24 and Training. The appropriation made in this section shall be

1 expended exclusively for the purpose so stated and shall not be  
2 transferable.

13 as may be necessary to perform the duties imposed upon the State
