13 AMENDMENT NO. 1. Page 1, strike the stricken title, enacting clause  
14 and entire bill and insert

15 "An Act relating to teachers; requiring emergency-  
16 certified teachers who do not hold certain  
17 certificate to complete professional development  
18 training prior to entering the classroom if hired  
19 before a school year begins; requiring emergency-  
20 certified teachers who are hired after a school year  
21 begins to complete professional development training  
22 within certain time period; allowing a school  
23 district to require training for new certified  
24 teachers; directing an employing school district to  
provide training; permitting cooperation with other  
districts or higher education institutions; providing  
content for training; requiring additional training  
throughout the year; requiring mentor for support,  
guidance and advice; providing for codification; and  
providing an effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. NEW LAW A new section of law to be codified  
3 in the Oklahoma Statutes as Section 6-195.3 of Title 70, unless  
4 there is created a duplication in numbering, reads as follows:

5 A. A person who is issued an emergency certificate by the State  
6 Board of Education pursuant to subsection F of Section 6-187 of  
7 Title 70 of the Oklahoma Statutes and who does not already hold a  
8 standard certificate shall complete no less than one (1) day of  
9 professional development training as provided in subsection C of  
10 this section prior to entering the classroom if he or she is hired  
11 before the school year begins. If a person who is issued an  
12 emergency certificate by the State Board of Education pursuant to  
13 subsection F of Section 6-187 of Title 70 of the Oklahoma Statutes  
14 is hired after the school year begins, a school district shall  
15 provide six (6) hours of professional development training as  
16 provided in subsection C of this section within two (2) weeks of  
17 entering the classroom. A school district may also require a new  
18 certified teacher to complete no less than one (1) day of  
19 professional development training as provided in subsection C of  
20 this section prior to entering the classroom.

21 B. The training shall be offered by the employing school  
22 district. School districts may cooperate with other districts or  
23 contract with an institution of higher education to offer the  
24 training.

1 C. The training described in this section shall include, but  
2 not be limited to, the following professional development:

- 3 1. Classroom management skills; and
- 4 2. School and classroom procedures and policies.

5 D. The school district shall provide additional training  
6 opportunities for teachers with emergency certification throughout  
7 the school year. Pursuant to Section 6-195 of Title 70 of the  
8 Oklahoma Statutes, the school principal shall also arrange a mentor  
9 to provide support, guidance and advice to the emergency-certified  
10 teacher on an ongoing basis. The mentor shall be in addition to any  
11 instructional coach that may be provided by the district.

12 SECTION 2. This act shall become effective November 1, 2019."

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 3. NEW LAW A new section of law to be codified  
14 in the Oklahoma Statutes as Section 6-195.3 of Title 70, unless  
15 there is created a duplication in numbering, reads as follows:

16 A. A person who is issued an emergency certificate by the State  
17 Board of Education pursuant to subsection F of Section 6-187 of  
18 Title 70 of the Oklahoma Statutes and who does not already hold a  
19 standard certificate shall complete no less than two (2) days of  
20 professional development training as provided in subsection C of  
21 this section prior to entering the classroom. A school district may  
22 also require a new certified teacher to complete no less than two  
23 (2) days of professional development training as provided in  
24 subsection C of this section prior to entering the classroom.

1 B. The training shall be offered by the employing school  
2 district. School districts may cooperate with other districts or  
3 contract with an institution of higher education to offer the  
4 training.

5 C. The training described in this section shall include, but  
6 not be limited to, the following professional development:

- 7 1. Classroom management skills;
- 8 2. School and classroom procedures and policies;
- 9 3. Subject-specific instructional methods; and
- 10 4. Writing lesson plans.

11 D. The school district shall provide additional training  
12 opportunities for teachers with emergency certification throughout  
13 the school year. Pursuant to Section 6-195 of Title 70 of the  
14 Oklahoma Statutes, the school principal shall also arrange a mentor  
15 to provide support, guidance and advice to the emergency-certified  
16 teacher on an ongoing basis. The mentor shall be in addition to any  
17 instructional coach that may be provided by the district.

18 SECTION 4. This act shall become effective November 1, 2019.
