Section 1, Chapter 87, O.S.L. 2014 14 AMENDATORY 15 (51 O.S. Supp. 2016, Section 24A.30), is amended to read as follows: 16 Section 24A.30 All A. Subject to the restrictions provided in subsection B of this section, all court records, as defined by 17 Section 32.1 of Title 12 of the Oklahoma Statutes, shall be 18 considered public records and shall be subject to the provisions of 19 the Oklahoma Open Records Act, unless otherwise identified by 20 statute to be confidential. If confidentiality is not required by 21 statute, the court may seal a record or portion of a record only if 22 a compelling privacy interest exists which outweighs the public's 23 interest in the record. In all cases where the court is sealing a 24

- 1 record or portion of a record, the court shall enter an order which 2 shall be public and shall:
- 1. Make findings of fact which identify the facts which the court relied upon in entering its order;
 - 2. Make conclusions of law specific enough so that the public is aware of the legal basis for the sealing of the record;
- 7 3. Utilize the least restrictive means for achieving 8 confidentiality; and
- 9 4. Be narrowly tailored so that only the portions of the record subject to confidentiality are sealed and the remainder of the record is kept open.
- B. The following documents, if they contain complete personal identifier numbers in the case file, shall be viewable internally and available at the office of the court clerk and shall not be viewable on the Internet or the World Wide Web:
 - Arrest warrants;
