22	benefits on or after November 1, 2019, shall receive a four-percent
23	increase in said benefits on November 1, 2019.

1	B. Any increase in benefits a person is eligible to receive
2	pursuant to repealed Section 50-120 of Title 11 of the Oklahoma
3	Statutes, after November 30, 2017, shall be offset by the increase
4	in benefits, if any, provided by this section.
5	SECTION 2. NEW LAW A new section of law to be codified
6	in the Oklahoma Statutes as Section 930.11 of Title 74, unless there
7	is created a duplication in numbering, reads as follows:
8	Any person receiving benefits from the Oklahoma Public Employees
9	Retirement System as of November 30, 2018, who continues to receive
10	benefits on or after November 1, 2019, shall receive a four-percent
11	increase in said benefits beginning in November 2019.
