Supp. 15 2018, Section 1210.284), is amended to read as follows: 16 Section 1210.284 A. 1. The parent or guardian of each student 17 enrolled in kindergarten at a public school in this state shall 18 provide certification to school personnel that the student passed a 19 vision screening within the previous twelve (12) months or during 20 the school year. Such screening shall be conducted by personnel 21 listed on the statewide registry as maintained by the State 22 Department of Health, which may include, but not be limited to, 23 Oklahoma licensed optometrists. 24

2. The parent or guardian of each student enrolled in first or
 third grade at a public school in this state shall provide within
 thirty (30) days of the beginning of the school year certification
 to school personnel that the student passed a vision screening
 within the previous twelve (12) months. Such screening shall be
 conducted by personnel listed on the statewide registry as
 maintained by the State Department of Health.

3. The parent or guardian of each student who receives a vision
9 screening as required by this section shall receive notification
10 that a vision screening is not the equivalent of a comprehensive eye
11 exam.

B. 1. The Infant and Children's Health Advisory Council
created in Section 44 of this act <u>1-103a.1 of Title 63 of the</u>
<u>Oklahoma Statutes</u> shall make recommendations to the State Board of
Health on:

5 the Infant and Children's Health Advisory Council created in Section
6 44 of this act 1-103a.1 of Title 63 of the Oklahoma Statutes, shall
7 promulgate rules to implement the provisions of this section.

8 C. 1. The parent or guardian of each student who fails the 9 vision screening required in subsection A of this section shall 10 receive a recommendation to undergo a comprehensive eye examination 11 performed by an ophthalmologist or optometrist.

12 2. The ophthalmologist or optometrist shall forward a written 13 report of the results of the comprehensive eye examination to the 14 student's school, parent or guardian, and primary health care 15 provider designated by the parent or guardian. The report shall 16 include, but not be limited to:

- a. date of report,

18 b. name, address and date of birth of the student,

19 c. name of the student's school,

20 d. type of examination,

e. a summary of significant findings, including
diagnoses, medication used, duration of action of
medication, treatment, prognosis, whether or not a
return visit is recommended and, if so when,

1 f. recommended educational adjustments for the child, if 2 any, which may include: preferential seating in the 3 classroom, eyeglasses for full-time use in school, 4 eyeglasses for part-time use in school, sight-saving 5 eyeglasses, and any other recommendations, and 6 g. name, address and signature of the examiner.

D. No student shall be prohibited from attending school for a parent's or guardian's failure to furnish a report of the student's vision screening or an examiner's failure to furnish the results of a student's comprehensive eye examination required by this section.

E. School districts shall notify parents or guardians of students who enroll in kindergarten, first, or third grade for the 2007-08 school year and each year thereafter of the requirements of this section.

15 The State Board of Education shall adopt rules for the F. 16 implementation of this section except as provided in subsection B of 17 this section. The State Department of Education shall issue a 18 report annually on the impact and effectiveness of this section. 19 SECTION 2. This act shall become effective November 1, 2019. 20 21 22 23 24
