14	SECTION 1. AMENDATORY 21 O.S. 2011, Section 1716, is

18	as defined in Section 1-125 of Title 47 of the Oklahoma Statutes

20	be guilty of a felony punishable by confinement in the State
21	Penitentiary custody of the Department of Corrections for a term of
22	not less than three (3) years $_{ au}$ nor more than ten (10) fifteen (15)
23	years; and any, and by a fine in an amount that is equal to three

3 B. Any person in this state who shall steal any dog, sheep, or 4 goat, shall, upon conviction, be guilty of a felony and upon 5 conviction therefor shall be punished punishable by confinement in the State Penitentiary custody of the Department of Corrections for 6 7 a term of not less than six (6) months \overline{r} nor more than three (3) years, or and by a fine in an amount that is equal to three times 8 9 the value of the animals and machinery or implement of husbandry 10 that were was stolen but not more than Five Hundred Thousand Dollars 11 (\$500,000.00), or by both such fine and imprisonment.

12 <u>C. Two-thirds (2/3) of the fine collected in subsection A or B</u> 13 <u>of this section shall be paid to the owner of the animal or</u> 14 <u>implement of husbandry and one-third (1/3) of the fine collected</u> 15 <u>shall be paid to the State Department of Agriculture Revolving Fund</u> 16 <u>and shall be utilized solely for the benefit of the agriculture law</u> 17 <u>enforcement agents commissioned pursuant to the provisions of</u> 18 Section 6-310 of Title 2 of the Oklahoma Statutes.

19 <u>D.</u> The word "horse" as used in this section includes all 20 animals of the equine species and the word "cow" includes all 21 animals of bovine species.

SECTION 2. This act shall become effective November 1, 2015.
