6 AS INTRODUCED

7 An Act relating to developmental disability programs;
8 amending 74 O.S. 2011, Section 129.7, as renumbered
9 by Section 43, Chapter 209, O.S.L. 2013, and as last
10 amended by Section 9, Chapter 286, O.S.L. 2014 (61
11 O.S. Supp. 2014, Section 331), which relates to
12 leases of certain surplus lands; modifying authorized
13 use of lease revenues; amending 62 O.S. 2011, Section
14 166d, as amended by Section 455, Chapter 304, O.S.L.
15 2012 (62 O.S. Supp. 2014, Section 166d), which
16 relates to certain bonuses and royalties; modifying
17 authorized disposition of royalties; providing for
18 use of revenues in programs to assist developmentally
19 disabled persons; providing an effective date; and
20 declaring an emergency.

21 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

22 SECTION 1. AMENDATORY 74 O.S. 2011, Section 129.7, as
23 renumbered by Section 43, Chapter 209, O.S.L. 2013, and as last
24 amended by Section 9, Chapter 286, O.S.L. 2014 (61 O.S. Supp. 2014,
Section 331), is amended to read as follows:

Section 331. In addition to the land described in Section 329
of this title, the Department of Human Services, with approval of
the Director, may lease other surplus land and property at the

1 Southern Oklahoma Resource Center of Pauls Valley to an individual
2 or individuals or to an entity. Revenue from such lease shall be
3 placed in a special agency clearing account to be used for the
4 benefit of the ~~residents of the Southern Oklahoma Resource Center of~~
5 ~~Pauls Valley~~ Department of Human Services' programs for individuals
6 with developmental disabilities.

7 SECTION 2. AMENDATORY 62 O.S. 2011, Section 166d, as
8 amended by Section 455, Chapter 304, O.S.L. 2012 (62 O.S. Supp.
9 2014, Section 166d), is amended to read as follows:

10 Section 166d. All royalty monies received upon behalf of this
11 state, any and all bonus monies received upon behalf of this state,
12 and any and all delay rentals received upon behalf of this state, in
13 connection with or pursuant to the provisions of any oil and gas
14 lease covering any of the lands occupied by, or assigned to the use
15 of, the Southern Oklahoma Resource Center of Pauls Valley, entered
16 into by the Office of Management and Enterprise Services, shall be
17 ~~deposited in the revolving fund of the Southern Oklahoma Resource~~
18 ~~Center of Pauls Valley and shall be expended by said institution in~~
19 ~~the same manner that other treasury funds of said institution are~~
20 ~~expended~~ used to support the Department of Human Services' programs
21 for individuals with developmental disabilities.

22 SECTION 3. This act shall become effective July 1, 2015.

23 SECTION 4. It being immediately necessary for the preservation
24 of the public peace, health and safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
