A new section of law not to be NEW LAW 18 codified in the Oklahoma Statutes reads as follows: 19 There is hereby created until December 31, 2017, the "Long 20 Term Care Insurance Accessibility Task Force". The purpose of the 21 Task Force shall be to evaluate the use of tax credits and other 22 incentives to encourage the purchase of long term care insurance

thereby making the long term care insurance more accessible to the

citizens of Oklahoma.

- 1 B. The Task Force shall be comprised of the following persons:
 - 1. The Commissioner of the Oklahoma Insurance Department;
 - 2. The three members of the Oklahoma Tax Commission; and
 - 3. One member who represents the interests of the long term care industry, selected by the Speaker of the Oklahoma House of Representatives from a list of recommendations submitted by a long term care organization.
 - C. Appointment to the Task Force shall be made within thirty

 (30) days after the effective date of this act. The Task Force

 shall meet within sixty (60) days of the effective date of this act.

 The Task Force shall select from among its membership a chair and vice-chair or cochairs.
 - D. A majority of the members who are present at a meeting shall constitute a quorum for the conduct of any business authorized or required by the provisions of this section.
 - E. The Task Force shall be authorized to meet as often as required to perform the duties imposed upon it by law.
 - F. The Task Force shall:

- 1. Examine the existing conditions related to long term care insurance availability in the state, including current premiums, cost and policies available in this state;
- 2. Examine methods to provide incentives to potential purchasers of long term care insurance, including but not limited to, any tax incentives for the purchase of long term care insurance; and

- 1 3. Such other matters that the Task Force deems to be in the interest of promoting, developing, supporting and communicating with interested stakeholders regarding the purchase of long term care insurance.
 - G. Members of the Task Force shall receive no compensation for serving on the task force, but shall be reimbursed by the public entity which the member is employed by or by their respective appointing authorities for necessary travel expenses incurred in the performance of their duties in accordance with the State Travel Reimbursement Act.
 - The Task Force shall submit its recommendations and final Η. report by November 30, 2017, to the Governor, the Speaker of the House of Representatives and the President Pro Tempore of the Senate.
 - SECTION 2. This act shall become effective July 1, 2017.
 - SECTION 3. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
