NEW LAW A new section of law to be codified 18 in the Oklahoma Statutes as Section 139.1 of Title 52, unless there 19 is created a duplication in numbering, reads as follows: 20 In exercising jurisdiction over Class II disposal wells as Α. 21 provided for in Section 139 of Title 52 of the Oklahoma Statutes, 22 the Corporation Commission shall implement a system of regulations 23 which substantially duplicates the administration, hearing and

- penalty assessment process outlined in the Oklahoma Storage Tank Regulation Act.
- B. 1. Any Class II disposal site operator who has been determined by the Commission to have violated any provisions of a disposal well volume cutback plan issued by the Commission shall be liable for an administrative penalty in an amount of not more than three times the penalty established in subsection A of Section 311 of Title 17 of the Oklahoma Statutes for each day that violation continues.
- 2. The amount of the penalty shall be assessed by the Commission pursuant to the provisions of paragraph 1 of this subsection, after notice and hearing. In determining the amount of the penalty, the Commission shall include but not be limited to consideration of the nature, circumstances and gravity of the violation and, with respect to the person found to have committed the violation, the degree of culpability, the effect on ability of the person to continue to do business, and any show of good faith in attempting to achieve compliance with the provisions of this section.
- 3. All penalties collected pursuant to the provisions of this section shall be deposited in the Oklahoma Storage Tank Regulation Revolving Fund.
- SECTION 2. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby

1	declared to exist, by reason whereof this act shall take effect and
2	be in full force from and after its passage and approval.
