12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. AMENDATORY 59 O.S. 2011, Section 1607, as
14	last amended by Section 1, Chapter 236, O.S.L. 2015 (59 O.S. Supp.
15	2018, Section 1607), is amended to read as follows:
16	Section 1607. A. There is hereby re-created, to continue until
17	July 1, <del>2019</del> 2025, in accordance with the provisions of the Oklahoma
18	Sunset Law, the Board of Examiners for Speech-Language Pathology and
19	Audiology whose duty it is to administer the provisions of the
20	Speech-Language Pathology and Audiology Licensing Act. The members
21	of the Board shall be residents of this state and shall be appointed
22	by the Governor with the advice and consent of the Senate. The
23	Board shall be composed of five (5) members consisting of three
24	licensed speech-language pathologists or audiologists, provided that

1 at least one of the three shall be a licensed speech-language 2 pathologist and at least one a licensed audiologist; one 3 otolaryngologist who is certified by the American Board of 4 Otolaryngology and one lay member.

5 Β. The members of the original Board shall serve the following terms: one member for one (1) year, two members for two (2) years, 6 7 and two members for three (3) years. Thereafter, at the expiration of the term, or termination of the member's service for any reason, 8 9 the Governor shall appoint each successor for a term of three (3) 10 years, or for the remainder of an unexpired term. The successor for 11 any of the three speech-language pathologists or audiologists will be selected from a list of five licensed speech-language 12 13 pathologists or audiologists, furnished by the Oklahoma Speech-14 Language-Hearing Association. The re-creation of the Board shall 15 not affect the staggered terms of office for Board members 16 established with the original Board.

17 C. Before entering upon the duties of the member's office, each 18 member of the Board shall take the Constitutional oath of office and 19 file it with the Secretary of State.

D. Board members may be reappointed to serve one additional three-year term. Three (3) years after the termination of a previous appointment to the Board, a member may be reappointed for one additional three-year term.
