17	B. The purpose of the Women's Bill of Rights is to bring
18	clarity, certainty, and uniformity under the laws of this state with
19	respect to natural persons of both biological sexes and the manner
20	in which they are treated as such under the laws of this state. All
21	laws where the application thereof is contingent upon the
22	classification of a person as being female or male, woman or man,
23	girl or boy, are hereby superseded and interpreted to the extent
24	necessary by this act, including, but not limited to, any

This act provides for exclusive remedies 2 within the state of the policies for individuals alleging discrimination in employment on the basis of race, color, national 3 origin, sex, religion, creed, age, disability or genetic 4 5 information. This act shall be construed according to the fair import of 6 Β. its terms to further the general purposes stated in this section and 7 the special purposes of the particular provision involved. 8 9 C. Any policy, program, or statute that prohibits sex 10 discrimination shall be construed to forbid unfair treatment of 11 females or males in relation to similarly situated members of the 12 opposite sex. The state or its political subdivisions shall not be prohibited from establishing distinctions between sexes when such 13 distinctions are substantially related to an important government 14 objective, including, but not limited to, biology, privacy, safety, 15 16 or fairness. labor union, legal representative, mutual company, partnership,
receiver, trust, trustee, trustee in bankruptcy, unincorporated
organization, any other legal or commercial entity, the state, or
any governmental entity or agency.

11 SECTION 5. NEW LAW A new section of law to be codified 12 in the Oklahoma Statutes as Section 1202 of Title 25, unless there 13 is created a duplication in numbering, reads as follows:

The state, any political subdivision, or any state agency or department, including, but not limited to, public school districts, that collects vital statistics for the purpose of gathering accurate public health, crime, economic, or other data shall include, but not be limited to, the identification of any natural person who is part of the collected data as either male or female as defined in Section 16 of Title 25 of the Oklahoma Statutes.
