"Motor vehicle" shall mean any type of conveyance or device in, upon or by which a person or property is or may be transported from one location to another upon the avenues of public access within this state. Motor vehicle shall include the passenger compartment of pickups, vans, minivans and sport utility vehicles. Motor vehicle shall not include trucks, truck-tractors, recreational vehicles, motorcycles or motorized bicycles.
- SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1-1528 of Title 63, unless there is created a duplication in numbering, reads as follows:
 - A. It shall be unlawful for the operator or passenger of a motor vehicle to smoke cigarettes, pipes or cigars if a child is also present in the motor vehicle.
 - B. Any person who is convicted of violating the provisions of this section shall be subject to a fine of not less than One Hundred Dollars (\$100.00).
