1 amending 47 O.S. 2021, Section 156, as last amended  
2 by Section 53, Chapter 452, O.S.L. 2024 (47 O.S.  
3 Supp. 2024, Section 156), which relates to  
4 prohibiting the purchase of automobiles or buses with  
5 public funds; authorizing Service Oklahoma to make  
6 certain purchases; amending 47 O.S. 2021, Section  
7 752, as amended by Section 22, Chapter 310, O.S.L.  
8 2023 (47 O.S. Supp. 2024, Section 752), which relates  
9 to the administration of tests; requiring certain  
10 collections of blood and breath samples to be valid  
11 and admissible as evidence; requiring samples of  
12 blood to be considered valid and admissible as  
13 evidence; stating requirements for collection;  
14 amending 47 O.S. 2021, Section 759, as amended by  
15 Section 1, Chapter 93, O.S.L. 2023 (47 O.S. Supp.  
16 2024, Section 759), which relates to the Board of  
17 Tests for Alcohol and Drug Influence; removing  
18 language requiring certain collections of blood and  
19 breath to be valid and admissible as evidence;  
20 removing language requiring analysis of blood to be  
21 considered valid and admissible as evidence; stating  
22 requirements for collection; amending 47 O.S. 2021,

2024, Section 1105A), which relates to program to  
permit electronic filing, storage and delivery of  
certificates of title; modifying type of verification  
for the submission of certain documents; amending 47  
O.S. 2021, Section 1106, as amended by Section 114,  
Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2024, Section  
1106), which relates to refusal or revocation of  
title; authorizing Service Oklahoma to refuse to  
issue certificate of title or register vehicle;  
authorizing the revocation of certificate of title  
and registration; modifying certain notice of hearing  
requirements; requiring certain appearance; requiring  
hearing adhere to certain act; authorizing the  
promulgation of certain rules; amending 47 O.S. 2021,  
Section 1104, as last amended by Section 1, Chapter  
442, O.S.L. 2024 (47 O.S. Supp. 2024, Section 1104),  
which relates to apportionment of fees; modifying  
reference to certain collected monies; amending 47  
O.S. 2021, Section 1137.1, as last amended by Section

1 11, Chapter 236, O.S.L. 2024 (47 O.S. Supp. 2024,  
2 Section 1137.1), which relates to used dealer  
3 license, registration, and certificate of title;  
4 modifying description of certain temporary license  
5 plates; authorizing the display of certain temporary  
6 license plates for two months; amending 47 O.S. 2021,  
7 Section 1141.1, as last amended by Section 14,  
8 Chapter 236, O.S.L. 2024 (47 O.S. Supp. 2024, Section  
9 1141.1), which relates to retention of taxes and  
10 fees; modifying statutory reference; authorizing  
11 retention of certain collected fees; amending 47 O.S.  
12 2021, Section 1143, as amended by Section 180,  
13 Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2024, Section  
14 1143), which relates to compensation for licensed  
15 operators; authorizing retention of certain fees;  
16 amending 63 O.S. 2021, Section 4021, as amended by  
17 Section 215, Chapter 282, O.S.L. 2022 (63 O.S. Supp.  
18 2024, Section 4021), which relates to fee required  
19 with application; modifying retention of certain  
20 fees; amending 68 O.S. 2021, Section 2103, as amended  
21 by Section 236, Chapter 282, O.S.L. 2022 (68 O.S.  
22 Supp. 2024, Section 2103), which relates to tax on  
23 transfer of legal ownership, use and first  
24 registration of vehicles; removing certain agency as  
collector of fees; modifying the distribution of  
certain collected penalties; repealing 47 O.S. 2021,  
Sections 6-110.2 and 1113.3, which relate to  
computerized finger imaging and the Oklahoma License  
Plate Design Task Force; providing an effective date;  
and declaring an emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. AMENDATORY 47 O.S. 2021, Section 1-168, is  
20 amended to read as follows:

21 Section 1-168. State.

22 A state, territory or possession of the United States, the  
23 District of Columbia, the Commonwealth of Puerto Rico or a province  
24 or territory of the Dominion of Canada.

1 SECTION 2. AMENDATORY 47 O.S. 2021, Section 2-116, as  
2 amended by Section 34, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2024,  
3 Section 2-116), is amended to read as follows:

4 Section 2-116. A. Whenever the Department of Public Safety or  
5 the Oklahoma Insurance Department is authorized or required to give  
6 any notice under this act or other law regulating the operation of  
7 vehicles, unless a different method of giving such notice is  
8 otherwise expressly prescribed, such notice shall be given either by  
9 personal delivery thereof to the person to be so notified or by  
10 deposit in the United States mail of such notice in an envelope with  
11 first class postage prepaid, addressed to such person at the address  
12 as shown by the records of the Department. The giving of notice by  
13 mail is complete upon the expiration of ten (10) days after such  
14 deposit of said notice. Proof of the giving of notice in either  
15 such manner may be made by the certificate of any officer or  
16 employee of the Department or affidavit of any person over eighteen  
17 (18) years of age, naming the person to whom such notice was given  
18 and specifying the time, place and manner of the giving thereof.  
19 Failure of the person to receive notice because of failure to notify  
20 the Department of a change in his or her current mailing address, as  
21 required by Section 6-116 of this title, shall not be sufficient  
22 grounds for the person to protest the notice.

23 B. Whenever Service Oklahoma is authorized or required to give  
24 any notice under this title, unless a different method of giving

1 such notice is otherwise expressly prescribed, such notice shall be  
2 given by mailing such notice by United States mail, in an envelope  
3 with first class postage prepaid, addressed to such person at the  
4 address as shown by the records of Service Oklahoma. The giving of  
5 notice by mail is complete upon the expiration of ten (10) days  
6 after such mailing. Service Oklahoma may show proof of such mailing  
7 by certificate of any officer or employee of Service Oklahoma or  
8 affidavit of any person over eighteen (18) years of age, naming the  
9 person to whom such notice was given and specifying the time, place  
10 and manner of the giving thereof. Failure of the person to receive  
11 notice because of failure to notify Service Oklahoma of a change in  
12 his or her current mailing address, as required by Section 6-116 of  
13 this title, shall not be sufficient grounds for the person to  
14 protest the notice.

15 SECTION 3. AMENDATORY 47 O.S. 2021, Section 6-101, as  
16 last amended by Section 34, Chapter 452, O.S.L. 2024 (47 O.S. Supp.  
17 2024, Section 6-101), is amended to read as follows:

18 Section 6-101. A. No person, except those hereinafter  
19 expressly exempted in Sections 6-102 and 6-102.1 of this title,  
20 shall operate any motor vehicle upon a highway in this state unless  
21 the person has a valid Oklahoma driver license for the class of  
22 vehicle being operated under the provisions of this title. No  
23 person shall be permitted to possess more than one valid license at  
24

1 any time, except as provided in paragraph 4 of subsection F of this  
2 section.

3 B. 1. No person shall operate a Class A commercial motor  
4 vehicle unless the person is eighteen (18) years of age or older and  
5 holds a valid Class A commercial license, except as provided in  
6 paragraph 5 of this subsection and subsection F of this section.  
7 Any person holding a valid Class A commercial license shall be  
8 permitted to operate motor vehicles in Classes A, B, C and D, except  
9 as provided for in paragraph 4 of this subsection.

10 2. No person shall operate a Class B commercial motor vehicle  
11 unless the person is eighteen (18) years of age or older and holds a  
12 valid Class B commercial license, except as provided in paragraph 5  
13 of subsection F of this section. Any person holding a valid Class B  
14 commercial license shall be permitted to operate motor vehicles in  
15 Classes B, C and D, except as provided for in paragraph 4 of this  
16 subsection.

17 3. No person shall operate a Class C commercial motor vehicle  
18 unless the person is eighteen (18) years of age or older and holds a  
19 valid Class C commercial license, except as provided in subsection F  
20 of this section. Any person holding a valid Class C commercial  
21 license shall be permitted to operate motor vehicles in Classes C  
22 and D, except as provided for in paragraph 4 of this subsection.

23 4. No person under twenty-one (21) years of age shall be  
24 licensed to operate any motor vehicle which is required to be

1 placarded for hazardous materials pursuant to 49 C.F.R., Part 172,  
2 subpart F, except as provided in subsection F of this section;  
3 provided, a person eighteen (18) years of age or older may be  
4 licensed to operate a farm vehicle which is required to be placarded  
5 for hazardous materials pursuant to 49 C.F.R., Part 172, subpart F,  
6 except as provided in subsection F of this section.

7 5. A person at least seventeen (17) years of age who  
8 successfully completes all examinations required by law may be  
9 issued by Service Oklahoma:

- 10 a. a restricted Class A commercial license which shall  
11 grant to the licensee the privilege to operate a Class  
12 A or Class B commercial motor vehicle for harvest  
13 purposes or a Class D motor vehicle, or
- 14 b. a restricted Class B commercial license which shall  
15 grant to the licensee the privilege to operate a Class  
16 B commercial motor vehicle for harvest purposes or a  
17 Class D motor vehicle.

18 6. No person shall operate a Class D motor vehicle unless the  
19 person is sixteen (16) years of age or older and holds a valid Class  
20 D license, except as provided for in Section 6-102 or 6-105 of this  
21 title. Any person holding a valid Class D license shall be  
22 permitted to operate motor vehicles in Class D only.

1 C. Any person issued a driver license pursuant to this section  
2 may exercise the privilege thereby granted upon all streets and  
3 highways in this state.

4 D. No person shall operate a motorcycle or motor-driven cycle  
5 without having a valid Class A, B, C or D license with a motorcycle  
6 endorsement. Except as otherwise provided by law, any new applicant  
7 for an original driver license shall be required to successfully  
8 complete a written examination, vision examination and driving  
9 examination for a motorcycle as prescribed by the Department of  
10 Public Safety, in conjunction with Service Oklahoma, and a certified  
11 state-approved motorcycle basic rider course approved by the  
12 Department, in conjunction with Service Oklahoma, if the applicant  
13 is seventeen (17) years of age or younger to be eligible for a  
14 motorcycle endorsement thereon. The written examination and driving  
15 examination for a motorcycle shall be waived by Service Oklahoma  
16 upon verification that the person has successfully completed a  
17 certified Motorcycle Safety Foundation rider course approved by the  
18 Department, in conjunction with Service Oklahoma.

19 E. Except as otherwise provided by law, any person who lawfully  
20 possesses a valid Oklahoma driver license which is eligible for  
21 renewal shall be required to successfully complete a written  
22 examination, vision examination and driving examination for a  
23 motorcycle as prescribed by the Department, in conjunction with  
24 Service Oklahoma, and a certified state-approved motorcycle basic

1 rider course approved by the Department, in conjunction with Service  
2 Oklahoma, if the person is seventeen (17) years of age or younger to  
3 be eligible for a motorcycle endorsement. The written examination  
4 and driving examination for a motorcycle shall be waived by Service  
5 Oklahoma upon verification that the person has successfully  
6 completed a certified Motorcycle Safety Foundation rider course  
7 approved by the Department, in conjunction with Service Oklahoma.

8 F. 1. Any person eighteen (18) years of age or older may apply  
9 for a restricted Class A, B or C commercial learner permit. Service  
10 Oklahoma, after the applicant has passed all parts of the  
11 examination for a Class D license and has successfully passed all  
12 parts of the examination for a Class A, B or C commercial license  
13 other than the driving examination, may issue to the applicant a  
14 commercial learner permit which shall entitle the person having  
15 immediate lawful possession of the commercial learner permit and a  
16 valid Oklahoma driver license or provisional driver license pursuant  
17 to Section 6-212 of this title to operate a Class A, B or C  
18 commercial motor vehicle upon the public highways solely for the  
19 purpose of behind-the-wheel training in accordance with rules  
20 promulgated by the Department.

21 2. This commercial learner permit shall be issued for a period  
22 as provided in Section 6-115 of this title of one (1) year;  
23 provided, such commercial learner permit may be suspended, revoked,  
24 canceled, denied or disqualified at the discretion of the

1 Department, with notice to Service Oklahoma, for violation of the  
2 restrictions, for failing to give the required or correct  
3 information on the application or for violation of any traffic laws  
4 of this state pertaining to the operation of a motor vehicle.  
5 Except as otherwise provided, the lawful possessor of a commercial  
6 learner permit who has been issued a commercial learner permit for a  
7 minimum of fourteen (14) days may have the restriction requiring an  
8 accompanying driver removed by satisfactorily completing a driver's  
9 examination; provided, the removal of a restriction shall not  
10 authorize the operation of a Class A, B or C commercial motor  
11 vehicle if such operation is otherwise prohibited by law.

12 3. No person shall apply for and Service Oklahoma shall not  
13 issue an original Class A, B or C driver license until the person  
14 has been issued a commercial learner permit and held the permit for  
15 at least fourteen (14) days. Any person who currently holds a Class  
16 B or C license and who wishes to apply for another class of  
17 commercial driver license shall be required to apply for a  
18 commercial learner permit and to hold the permit for at least  
19 fourteen (14) days before applying for the Class A or B license, as  
20 applicable. Any person who currently holds a Class A, B or C  
21 license and who wishes to add an endorsement or remove a restriction  
22 for which a skills examination is required shall be required to  
23 apply for a commercial learner permit and to hold the permit for at  
24 least fourteen (14) days before applying for the endorsement.

1           4. A commercial learner permit shall be issued by Service  
2 Oklahoma as a separate and unique document which shall be valid only  
3 in conjunction with a valid Oklahoma driver license or provisional  
4 driver license pursuant to Section 6-212 of this title, both of  
5 which shall be in the possession of the person to whom they have  
6 been issued whenever that person is operating a commercial motor  
7 vehicle as provided in this subsection.

8           5. After one renewal of a commercial learner permit, as  
9 provided in paragraph 2 of this subsection, a commercial permit  
10 shall not be renewed again. Any person who has held a commercial  
11 learner permit for the initial issuance period and one renewal  
12 period shall not be eligible for and Service Oklahoma shall not  
13 issue another renewal of the permit; provided, the person may  
14 reapply for a new commercial learner permit, as provided for in this  
15 subsection.

16           G. 1. For purposes of this title:

17           a. "REAL ID Compliant Driver License" or "Identification  
18 Card" means a driver license or identification card  
19 issued by this state that has been certified by the  
20 United States Department of Homeland Security (USDHS)  
21 as compliant with the requirements of the REAL ID Act  
22 of 2005, Public Law No. 109-13. A REAL ID Compliant  
23 Driver License or Identification Card and the process  
24 through which it is issued incorporate a variety of

1 security measures designed to protect the integrity  
2 and trustworthiness of the license or card. A REAL ID  
3 Compliant Driver License or Identification Card will  
4 be clearly marked on the face indicating that it is a  
5 compliant document, and

- 6 b. "REAL ID Noncompliant Driver License" or  
7 "Identification Card" means a driver license or  
8 identification card issued by this state that has not  
9 been certified by the United States Department of  
10 Homeland Security (USDHS) as being compliant with the  
11 requirements of the REAL ID Act of 2005. A REAL ID  
12 Noncompliant Driver License or Identification Card  
13 will be clearly marked on the face indicating that it  
14 is not compliant with the federal REAL ID Act of 2005  
15 and is not acceptable for official federal purposes.  
16 The driver license or identification card will have a  
17 unique design or color indicator that clearly  
18 distinguishes it from a compliant license or card.  
19 Service Oklahoma may continue to issue REAL ID  
20 Noncompliant Driver Licenses or REAL ID Noncompliant  
21 Identification Cards through December 31, 2025. Any  
22 REAL ID Noncompliant Driver License or REAL ID  
23 Noncompliant Identification Card issued through

1                   December 31, 2025, shall be valid through the  
2                   expiration date printed on the face of the credential.

3           2. Original Driver License and Identification Card Issuance:

4           a. Application for an original REAL ID Compliant or REAL  
5           ID Noncompliant Driver License or Identification Card  
6           shall be made to Service Oklahoma or a licensed  
7           operator provided such licensed operator is authorized  
8           to process application for REAL ID Compliant Driver  
9           Licenses and Identification Cards. Application for a  
10           REAL ID Noncompliant Driver License or Identification  
11           Card shall be made ~~to Service Oklahoma~~ through  
12           December 31, 2025. Applications for an original REAL  
13           ID Noncompliant Driver License or Identification card  
14           will not be accepted beginning January 1, 2026.

15           b. Service Oklahoma employees or authorized licensed  
16           operators shall perform all document recognition and  
17           other requirements needed for approval of an original  
18           REAL ID Compliant Driver License or Identification  
19           Card application. Service Oklahoma employees shall  
20           perform all document recognition and other  
21           requirements needed for approval of a REAL ID  
22           Noncompliant Driver License or Identification Card  
23           application through December 31, 2025. Applications  
24           for an original REAL ID Noncompliant Driver License or

1           Identification card will not be accepted beginning  
2           January 1, 2026.

3           c.    Upon approval of an original REAL ID Compliant or REAL  
4           ID Noncompliant Driver License or Identification Card  
5           application, the applicant may take the approved  
6           application document to a licensed operator to receive  
7           a temporary driver license or identification card.

8           d.    The licensed operator shall process the approved REAL  
9           ID Compliant or REAL ID Noncompliant Driver License or  
10          Identification Card application and upon payment shall  
11          provide the applicant a temporary driver license or  
12          identification card. A temporary driver license or  
13          identification card shall afford the holder the  
14          privileges otherwise granted by the specific class of  
15          driver license or identification card for the period  
16          of time listed on the temporary driver license or  
17          identification card or the period of time prior to the  
18          applicant receiving a REAL ID Compliant or REAL ID  
19          Noncompliant Driver License or Identification Card,  
20          whichever time period is shorter. Service Oklahoma  
21          may continue to issue REAL ID Noncompliant Driver  
22          Licenses or REAL ID Noncompliant Identification Cards  
23          through December 31, 2025. Any REAL ID Noncompliant  
24          Driver License or REAL ID Noncompliant Identification

1                   Card issued through December 31, 2025, shall be valid  
2                   through the expiration date printed on the face of the  
3                   credential.

4           3. REAL ID Compliant Driver License and Identification Card

5 Renewal and Replacement:

6           a. Application for renewal or replacement of a REAL ID  
7           Compliant Driver License or Identification Card may be  
8           made to Service Oklahoma or to a licensed operator;  
9           provided, such licensed operator is authorized to  
10           process application for REAL ID Compliant Driver  
11           Licenses and Identification Cards. A licensed  
12           operator may process the voluntary downgrade of a REAL  
13           ID Compliant Commercial Driver License to any lower  
14           class license upon request of the licensee; provided,  
15           no additional endorsements or restrictions are placed  
16           on the license.

17           b. Service Oklahoma employees or authorized licensed  
18           operators shall perform all document recognition and  
19           other requirements needed for approval of a renewal or  
20           replacement REAL ID Compliant Driver License or  
21           Identification Card application.

22           c. Upon approval of a renewal or replacement REAL ID  
23           Compliant Driver License or Identification Card  
24           application, the applicant may receive a temporary



1 driver license or identification card from Service  
2 Oklahoma or an authorized licensed operator.

3 d. A temporary driver license or identification card  
4 acquired under the provisions of this paragraph shall  
5 afford the holder the privileges otherwise granted by  
6 the specific class of driver license or identification  
7 card being renewed or replaced for the period of time  
8 listed on the temporary driver license or  
9 identification card or the period of time prior to the  
10 applicant receiving a REAL ID Compliant Driver License  
11 or Identification Card, whichever time period is  
12 shorter.

13 e. For purposes of this title, an application for a REAL  
14 ID Compliant Driver License or Identification Card by  
15 an individual with a valid Oklahoma-issued driver  
16 license or identification card shall be considered a  
17 renewal of a REAL ID Compliant Driver License or  
18 Identification Card.

19 4. REAL ID Noncompliant Driver License and Identification Card

9 direct the court clerk to prepare and furnish a complete transcript  
10 of all pleadings and proceedings, together with a complete  
11 transcript taken at the hearing at no cost to Service Oklahoma,  
12 except the cost of transcribing.

13 J. Upon Service Oklahoma's receipt of a petition challenging  
14 Service Oklahoma's action against the driving privileges of any  
15 person under this title, Service Oklahoma shall withhold taking the  
16 action which is the subject of the appeal or stay the order which is  
17 the subject of the appeal. During the pendency of the appeal,  
18 Service Oklahoma shall grant or restore driving privileges to the  
19 person if the person is otherwise eligible.

20 K. An appeal may be taken by the person or by Service Oklahoma  
21 from the order or judgment of the district court to the Supreme  
22 Court of the State of Oklahoma as otherwise provided by law.

- 1 c. is restricted to such an extent that the person's  
2 forced (respiratory) expiratory volume for one (1)  
3 second, when measured by spirometry, is less than one  
4 (1) liter, or the arterial oxygen tension is less than  
5 sixty (60) mm/hg on room air at rest,
- 6 d. must use portable oxygen,
- 7 e. has functional limitations which are classified in  
8 severity as Class III or Class IV according to  
9 standards set by the American Heart Association,
- 10 f. is severely limited in the person's ability to walk  
11 due to an arthritic, neurological or orthopedic  
12 condition, or from complications due to pregnancy,
- 13 g. is certified legally blind, or is missing one or more

15 B. Service Oklahoma shall issue a detachable placard indicating  
16 physical disability to any person who submits an application on a  
17 form furnished by Service Oklahoma and certified by a physician,

20 attestation of the physician, physician assistant, or advanced  
21 registered nurse practitioner shall denote "temporary" as the type

8 Improvements for Roads and Bridges Fund, to the

4 dealer, wholesale used motor vehicle dealer, used travel trailer  
5 dealer or used commercial trailer dealer, subsequently referred to  
6 in this section as "dealer", the dealer shall affix a used dealer's  
7 plate visible from the rear of the vehicle, travel trailer or  
8 commercial trailer. Such license plate shall expire on December 31  
9 of each year. When the vehicle, travel trailer or commercial  
10 trailer is parked on the dealer's licensed place of business, it  
11 shall not be required to have a license plate of any kind affixed.  
12 A dealer shall obtain from Service Oklahoma at a cost of Ten Dollars  
13 (\$10.00) a dealer license plate for demonstrating, transporting or  
14 any other normal business of a dealer including use by an individual  
15 holding a valid salesperson's license issued by the Oklahoma Used  
16 Motor Vehicle, Dismantler, and Manufactured Housing Commission. Any  
17 dealer who operates a wrecker or towing service licensed pursuant to  
18 Sections 951 through 957 of this title shall register each wrecker  
19 vehicle and display a wrecker license plate on each vehicle as  
20 required by Section 1134.3 of this title. A dealer may obtain as  
21 many additional license plates as may be desired upon the payment of  
22 Ten Dollars (\$10.00) for each additional license plate. Use of the  
23 used dealer license plate by a licensed dealer for other than the  
24 purposes as set forth herein shall constitute grounds for revocation

1 of the dealer's license. Service Oklahoma shall design the official  
2 used dealer license plate to include the used dealer's license  
3 number issued to him or her each year by Service Oklahoma or the  
4 Oklahoma Used Motor Vehicle, Dismantler, and Manufactured Housing  
5 Commission.

6 B. Upon the purchase or transfer of ownership of an out-of-  
7 state used motor vehicle, travel trailer or commercial trailer to a  
8 licensed dealer, the dealer shall make application for an Oklahoma  
9 certificate of title pursuant to the Oklahoma Vehicle License and  
10 Registration Act, Section 1101 et seq. of this title. Upon receipt  
11 of the Oklahoma certificate of title, the dealer shall follow the  
12 procedure as set forth in subsection A of this section. Provided,  
13 nothing in this title shall be construed as requiring a dealer to  
14 register a used motor vehicle, travel trailer or commercial trailer  
15 purchased in another state which will not be operated or sold in  
16 this state.

17 C. Upon sale or transfer of ownership of the used motor vehicle  
18 or travel trailer, the dealer shall place upon the reassignment  
19 portion of the certificate of title a tax stamp issued by the county  
20 treasurer of the county in which the dealer has his or her primary  
21 place of business. The tax stamp shall be issued upon payment of a  
22 fee of Three Dollars and fifty cents (\$3.50) and shall be in lieu of  
23 the dealer's ad valorem tax on the inventories of used motor

1 vehicles or travel trailers but shall not relieve any other property  
2 of the dealer from ad valorem taxation.

3 D. Upon sale of a used motor vehicle or travel trailer to  
4 another licensed dealer, the selling dealer shall place the tax  
5 stamp required in subsection C of this section upon the certificate  
6 of title. The used dealer license plate or wholesale dealer license  
7 plate shall be removed by the selling dealer. The purchasing dealer  
8 shall, at time of purchase, place his or her dealer license plate on  
9 the used motor vehicle, travel trailer or commercial trailer as  
10 provided in subsection A of this section; provided, for vehicles,  
11 travel trailers or commercial trailers purchased by a licensed used  
12 dealer at an auction, in lieu of such placement of the dealer  
13 license plate, the auction may provide temporary documentation as  
14 approved by the Director of the Motor Vehicle Division of Service  
15 Oklahoma for the purpose of transporting such vehicle to the  
16 purchaser's point of destination. Such temporary documentation  
17 shall be valid for two (2) days following the date of sale.

18 E. 1. The purchaser of every used motor vehicle, travel  
19 trailer, or commercial trailer, except as otherwise provided by law,  
20 shall obtain registration and title for the vehicle or trailer  
21 within two (2) months from the date of purchase of same. It shall  
22 be the responsibility of the selling dealer to place a temporary  
23 license plate, in size similar to the permanent Oklahoma license  
24 plate but of a ten-mil weatherproof plastic-impregnated paper

1 approved by the Oklahoma Used Motor Vehicle, Dismantler, and  
2 Manufactured Housing Commission, upon a used motor vehicle, travel  
3 trailer or commercial trailer when a transaction is completed for  
4 the sale of such vehicle. Provided, upon a determination by the  
5 Commission that there exists a national shortage of ten-mil  
6 weatherproof plastic-impregnated paper, eight-mil weatherproof  
7 plastic-impregnated paper may be approved by the Commission until it  
8 has been determined by the Commission the shortage has ended. The  
9 temporary license plate under this subsection shall be placed at the  
10 location provided for the permanent motor vehicle license plate.  
11 The temporary license plate shall show the license number which is  
12 issued to the dealer each year by Service Oklahoma or the Oklahoma  
13 Used Motor Vehicle, Dismantler, and Manufactured Housing Commission,  
14 the date of expiration, and the company name of the selling dealer.

15 2. The Oklahoma Used Motor Vehicle, Dismantler, and  
16 Manufactured Housing Commission is hereby directed to develop the  
17 motor vehicle temporary license plate design to incorporate these  
18 requirements in a manner that will permit law enforcement personnel  
19 to readily identify the dealer license number and date of  
20 expiration. The Oklahoma Used Motor Vehicle, Dismantler, and  
21 Manufactured Housing Commission is hereby authorized to develop  
22 additional requirements and parameters as deemed appropriate to  
23 discourage or prevent illegal duplication and use of the temporary  
24 license plate. Such motor vehicle temporary license plate shall be

1 valid for a period of ten (10) days from the date of purchase. Use  
2 of the motor vehicle temporary license plate by a dealer for other  
3 than the purposes set forth herein shall constitute grounds for  
4 revocation of the dealer's license to conduct business. Purchasers  
5 of a commercial trailer shall affix the commercial trailer temporary  
6 license plate to the rear of the commercial trailer. The purchaser  
7 of a motor vehicle shall display the motor vehicle temporary license  
8 plate for a period not to exceed ten (10) days or until registration  
9 and title are obtained as provided in this section. The purchaser  
10 of a commercial trailer shall display the commercial trailer  
11 temporary license plate for a period not to exceed two (2) months or  
12 until registration and title are obtained as provided in this  
13 section.

14 3. The provisions of this subsection on temporary licenses  
15 shall apply to nonresidents who purchase a used motor vehicle,  
16 travel trailer, or commercial trailer within this state that is to  
17 be licensed in another state. The nonresident purchaser shall be  
18 allowed to operate the vehicle or trailer within the state with a  
19 temporary license plate for a period not to exceed ten (10) days  
20 from date of purchase. Any nonresident purchaser found to be  
21 operating a used motor vehicle, travel trailer, or commercial  
22 trailer within this state after two (2) months shall be subject to  
23 the registration fees of this state upon the same terms and  
24 conditions applying to residents of this state. Additionally,

1 within two (2) business days of the date of the sale or transfer of  
2 the vehicle or trailer, the parties shall submit the requisite  
3 documentation to Service Oklahoma or licensed operator identifying  
4 the vehicle or trailer subject to the sale or transfer, purchaser  
5 information, and any associated license plate on the vehicle,  
6 pursuant to the requirements of Section 1112.2 of this title.

7 F. It shall be unlawful for any dealer to procure the  
8 registration and licensing of any used motor vehicle, travel trailer  
9 or commercial trailer sold by the dealer or to act as the agent for  
10 the purchaser in the procurement of the registration and licensing  
11 of the purchaser's used vehicle, travel trailer, or commercial  
12 trailer. A license of any dealer violating the provision of this  
13 section may be revoked.

14 G. Dealers following the procedure set forth herein shall not  
15 be required to register vehicles, travel trailers, or commercial  
16 trailers to which this section applies, nor will the registration  
17 fee otherwise required be assessed. Provided, dealers shall not  
18 purchase or trade for a used motor vehicle, travel trailer, or  
19 commercial trailer on which the registration therefor has been  
20 expired for a period exceeding two (2) months without obtaining  
21 current registration therefor.

22 H. A nonprofit charitable organization which is exempt from  
23 taxation pursuant to the provisions of the Internal Revenue Code, 26  
24 U.S.C., Section 501(c)(3), and which accepts donations of used motor



1 vehicles previously titled in Oklahoma to be subsequently  
2 transferred to another owner, upon the qualifying organization  
3 providing sufficient documentation of its tax-exempt status, may  
4 obtain from Service Oklahoma charitable nonprofit organization  
5 license plates for demonstrating, transporting, or test-driving  
6 donated vehicles, provided that no organization shall possess or use  
7 at any one time more than eight such plates. Service Oklahoma shall  
8 design distinctive license plates for that purpose. The cost for  
9 such plates shall be the same as provided in subsection A of this  
10 section for dealer plates.

11 I. The transfer of ownership from the vehicle donor to the  
12 qualifying nonprofit organization described in subsection H of this  
13 section shall be made without the payment of motor vehicle excise  
14 tax levied pursuant to Section 2103 of Title 68 of the Oklahoma  
15 Statutes.

16 SECTION 21. AMENDATORY 47 O.S. 2021, Section 1141.1, as  
17 last amended by Section 14, Chapter 236, O.S.L. 2024 (47 O.S. Supp.

17       12. One Dollar (\$1.00) for each certificate of ownership filed  
18 pursuant to subsection R of Section 1105 of this title;

19       13. One Dollar (\$1.00) for each temporary permit issued  
20 pursuant to Section 1124 of this title;

21       14. One Dollar and fifty cents (\$1.50) for processing each  
22 proof of financial responsibility, driver license information,  
23 insurance verification information, and other additional information  
24 as provided in Section 7-602 of this title;

1 15. The mailing fees and registration fees provided in Sections  
2 1131 and 1140 of this title;

3 16. The notary fee provided in Section 1143 of this title;

4 17. Three Dollars (\$3.00) for each lien entry form completed  
5 and recorded on a certificate of title pursuant to subsection G of  
6 Section 1105 of this title;

7 18. Seven Dollars (\$7.00) for each notice of transfer as  
8 provided by subsection B of Section 1107.4 of this title;

9 19. Seven Dollars (\$7.00) for each certificate of title or each  
10 certificate of registration issued for repossessed vehicles pursuant  
11 to Section 1126 of this title;

12 20. Any amount specifically authorized by law to be retained by  
13 the licensed operator for the furnishing of a summary of a traffic  
14 record;

15 21. Beginning July 1, 2009, and through June 30, 2023, each  
16 licensed operator shall also be entitled to a portion of the  
17 penalties for delinquent registration or payment of excise tax as  
18 provided for in subsection C of Section 1115, subsection F of

19           compensation those taxes and fees collected and retained pursuant to  
20           Section 1141.1 of this title, and shall additionally retain:

21           1. All amounts remaining from notary and mailing fees and those  
22           provided by Section 1105A of this title received by such licensed  
23           operator, after payment of all costs of handling and mailing;



1       2. All profits from any concessions operated in the licensed  
2 operator's office; and

3       3. All amounts collected pursuant to subsection H of Section  
4 1111 of this title.

5       B. A licensed operator shall receive a fee as regulated in  
6 Title 49 of the Oklahoma Statutes for each document notarized.

7       C. Service Oklahoma shall initiate a mail order vehicle  
8 registration notification program, which shall consist of  
9 notification annually to all vehicle owners in this state of such  
10 time an owner shall register and license a vehicle as provided for  
11 in Section 1101 et seq. of this title. The notification issued by  
12 Service Oklahoma shall include a breakdown of all charges to be paid

17 delivered price" shall represent the recommended retail selling  
18 price and shall not mean the wholesale price to a dealer.

19 C. Service Oklahoma shall assess the registration fees and  
20 penalties for the year or years a vessel or motor was not registered  
21 as provided in the Oklahoma Vessel and Motor Registration Act. For  
22 vessels or motors not registered for two (2) or more years, the  
23 registration fees and penalties shall be due only for the current  
24 year and one (1) previous year.

1 D. Upon each vessel or motor repossessed by a mortgagee, a fee

23 3. By organizations which are exempt from taxation pursuant to  
24 the provisions of Section 501(c)(3) of the Internal Revenue Code, 26

1 U.S.C., Section 501(c)(3), and which are primarily devoted to the  
2 establishment, development, operation, promotion, and participation  
3 in, alone or in conjunction with others, educational and training  
4 programs and competitive events to provide knowledge, information,  
5 or comprehensive skills related to the sports of sailing, fishing,  
6 boating, and other aquatic-related activities;  
7 are hereby exempt from the payment of registration fees required by  
8 this section. Provided all of such vessels or motors shall be

11 one-half percent (4 1/2%) of the actual sales price of each new and  
12 used all-terrain vehicle and motorcycle used exclusively off roads  
13 and highways before any discounts or credits are given for a trade-  
14 in. Provided, the minimum excise tax assessment for such all-  
15 terrain vehicles, utility vehicles and motorcycles used exclusively  
16 off roads and highways shall be Five Dollars (\$5.00). The excise  
17 tax for new vehicles shall be levied at three and one-fourth percent  
18 (3 1/4%) of the value of each new vehicle. The excise tax for used  
19 vehicles shall be as follows:

- 20 a. from October 1, 2000, until June 30, 2001, Twenty  
21 Dollars (\$20.00) on the first One Thousand Dollars  
22 (\$1,000.00) or less of value of such vehicle, and  
23 three and one-fourth percent (3 1/4%) of the remaining  
24 value of such vehicle,

1           b.    for the year beginning July 1, 2001, and ending June  
2                    30, 2002, Twenty Dollars (\$20.00) on the first One  
3                    Thousand Two Hundred Fifty Dollars (\$1,250.00) or less  
4                    of value of such vehicle, and three and one-fourth  
5                    percent (3 1/4%) of the remaining value of such  
6                    vehicle, and

7           c.    for the year beginning July 1, 2002, and all  
8                    subsequent years, Twenty Dollars (\$20.00) on the first  
9                    One Thousand Five Hundred Dollars (\$1,500.00) or less  
10                  of value of such vehicle, and three and one-fourth  
11                  percent (3 1/4%) of the remaining value of such  
12                  vehicle.

13           2.    There shall be levied an excise tax of Ten Dollars (\$10.00)

14 for any:

15           a.    truck or truck-tractor registered under the provisions  
16                   of subsection A of Section 1133 of Title 47 of the  
17                   Oklahoma Statutes, for a laden weight or combined  
18                   laden weight of fifty-five thousand (55,000) pounds or  
19                   more,

20           b.    trailer or semitrailer registered under subsection C  
21                   of Section 1133 of Title 47 of the Oklahoma Statutes,  
22                   which is primarily designed to transport cargo over  
23                   the highways of this state and generally recognized as  
24                   such, and

1 c. frac tank, as defined by Section 54 of Title 17 of the  
2 Oklahoma Statutes, and registered under subsection C  
3 of Section 1133 of Title 47 of the Oklahoma Statutes.

4 Except for frac tanks, the excise tax levied pursuant to this  
5 paragraph shall not apply to special mobilized machinery, trailers,  
6 or semitrailers manufactured, modified or remanufactured for the  
7 purpose of providing services other than transporting cargo over the  
8 highways of this state. The excise tax levied pursuant to this  
9 paragraph shall also not apply to pickup trucks, vans, or sport  
10 utility vehicles.

11 3. The tax levied pursuant to this section shall be due at the  
12 time of the transfer of legal ownership or first registration in  
13 this state of such vehicle; provided, the tax shall not be due at  
14 the time of the issuance of a certificate of title for an all-  
15 terrain vehicle, utility vehicle or motorcycle used exclusively off  
16 roads and highways which is not required to be registered but which  
17 the owner chooses to register pursuant to the provisions of  
18 subsection B of Section 1115.3 of Title 47 of the Oklahoma Statutes,  
19 and shall be collected by Service Oklahoma ~~or the Corporation~~  
20 ~~Commission, as applicable,~~ or an appointed licensed operator, at the  
21 time of the issuance of a certificate of title for any such vehicle.  
22 In the event an excise tax is collected on the transfer of legal  
23 ownership or use of the vehicle during any calendar year, then an  
24 additional excise tax must be collected upon all subsequent

1 transfers of legal ownership. In computing the motor vehicle excise  
2 tax, the amount collected shall be rounded to the nearest dollar.  
3 The excise tax levied by this section shall be delinquent from and  
4 after the thirtieth day after the legal ownership or possession of  
5 any vehicle is obtained. Any person failing or refusing to pay the  
6 tax as herein provided on or before date of delinquency shall pay in  
7 addition to the tax a penalty of One Dollar (\$1.00) per day for each  
8 day of delinquency, but such penalty shall in no event exceed the  
9 amount of the tax. Of each dollar penalty collected pursuant to  
10 this subsection:

- 11 a. ~~twenty-five cents (\$0.25)~~ fifty cents (\$0.50) shall be  
12 apportioned as provided in Section 1104 of this title,  
13 and  
14 b. ~~twenty-five cents (\$0.25) shall be retained by the~~  
15 ~~licensed operator, and~~  
16 ~~e.~~ fifty cents (\$0.50) shall be deposited in the General  
17 Revenue Fund for the fiscal year beginning on July 1,  
18 2011, and for all subsequent fiscal years, shall be  
19 deposited in the State Highway Construction and  
20 Maintenance Fund.

21 B. The excise tax levied in subsection A of this section and  
22 assessed on all commercial vehicles registered pursuant to Section  
23 1120 of Title 47 of the Oklahoma Statutes and trailers and  
24 semitrailers registered under subsection C of Section 1133 of Title

1 47 of the Oklahoma Statutes to transport cargo over the highways of  
2 this state shall be in lieu of all sales and use taxes levied  
3 pursuant to the Sales Tax Code or the Use Tax Code. The transfer of  
4 legal ownership of any motor vehicle as used in this section and the  
5 Sales Tax Code and the Use Tax Code shall include the lease, lease  
6 purchase or lease finance agreement involving any truck in excess of  
7 eight thousand (8,000) pounds combined laden weight or any truck-  
8 tractor provided the vehicle is registered in Oklahoma pursuant to  
9 Section 1120 of Title 47 of the Oklahoma Statutes or any frac tank,  
10 trailer, semitrailer or open commercial vehicle registered pursuant  
11 to Section 1133 of Title 47 of the Oklahoma Statutes. The excise  
12 tax levied pursuant to this section shall not be subsequently  
13 collected at the end of the lease period if the lessee acquires  
14 complete legal title of the vehicle.

15 C. The provisions of this section shall not apply to transfers  
16 made without consideration between:

- 17 1. Husband and wife;
- 18 2. Parent and child; or
- 19 3. An individual and an express trust which that individual or  
20 the spouse, child or parent of that individual has a right to  
21 revoke.

22 D. 1. There shall be a credit allowed with respect to the  
23 excise tax paid for a new vehicle which is a replacement for:  
24

- 1           a.    a new original vehicle which is stolen from the  
2                    purchaser/registrant within ninety (90) days of the  
3                    date of purchase of the original vehicle as certified  
4                    by a police report or other documentation as required  
5                    by Service Oklahoma, or
- 6           b.    a defective new original vehicle returned by the  
7                    purchaser/registrant to the seller within six (6)  
8                    months of the date of purchase of the defective new  
9                    original vehicle as certified by the manufacturer.

10           2.    The credit allowed pursuant to paragraph 1 of this  
11 subsection shall be in the amount of the excise tax which was paid  
12 for the new original vehicle and shall be applied to the excise tax  
13 due on the replacement vehicle. In no event shall the credit be  
14 refunded.

15           E.    Despite any other definitions of the terms "new vehicle" and  
16 "used vehicle", to the contrary, contained in any other law, the  
17 term "new vehicle" as used in this section shall also include any  
18 vehicle of the latest manufactured model which is owned or acquired  
19 by a licensed used motor vehicle dealer which has not previously  
20 been registered in this state and upon which the motor vehicle  
21 excise tax as set forth in this section has not been paid. However,  
22 upon the sale or transfer by a licensed used motor vehicle dealer  
23 located in this state of any such vehicle which is the latest  
24



1 manufactured model, the vehicle shall be considered a used vehicle  
2 for purposes of determining excise tax.

3 F. The provisions of this section shall not apply to state  
4 government entities.

5 SECTION 25. REPEALER 47 O.S. 2021, Sections 6-110.2 and  
6 1113.3, are hereby repealed.

7 SECTION 26. This act shall become effective July 1, 2025.

8 SECTION 27. It being immediately necessary for the preservation  
9 of the public peace, health or safety, an emergency is hereby  
10 declared to exist, by reason whereof this act shall take effect and  
11 be in full force from and after its passage and approval.
