4. "Foreign protective order" means any valid order of

"Harassment" means a knowing and willful course or pattern 20 of conduct by a family or household member or an individual who is 21 or has been involved in a dating relationship with the person, 22 directed at a specific person which seriously alarms or annoys the 23 person, and which serves no legitimate purpose. The course of 24 conduct must be such as would cause a reasonable person to suffer

substantial emotional distress, and must actually cause substantial distress to the person. "Harassment" shall include, but not be limited to, harassing or obscene telephone calls in violation of Section 1172 of Title 21 of the Oklahoma Statutes and fear of death or bodily injury;

- 6. "Intimate partner" means:
- 7 a. current or former spouses,
- 8 b. persons who are or were in a dating relationship,
- 9 c. persons who are the biological parents of the same 10 child, regardless of their marital status or whether 11 they have lived together at any time, and
- 12 d. persons who currently or formerly lived together in an 13 intimate way, primarily characterized by affectionate 14 or sexual involvement. A sexual relationship may be 15 an indicator that a person is an intimate partner, but 16 is never a necessary condition;

7. "Mutual protective order" means a final protective order or 17 orders issued to both a plaintiff who has filed a petition for a 18 protective order and a defendant included as the defendant in the 19 plaintiff's petition restraining the parties from committing 20 domestic violence, stalking, harassment or rape against each other. 21 If both parties allege domestic abuse, violence, stalking, 22 harassment or rape against each other, the parties shall do so by 23 separate petition pursuant to Section 60.4 of this title; 24

8. "Rape" means rape and rape by instrumentation in violation
 of Sections 1111 and 1111.1 of Title 21 of the Oklahoma Statutes;

"Stalking" means the willful, malicious, and repeated following or harassment of a person by an adult, emancipated minor, 4 5 or minor thirteen (13) years of age or older, in a manner that would cause a reasonable person to feel frightened, intimidated, 6 7 threatened, harassed, or molested and actually causes the person being followed or harassed to feel terrorized, frightened, 8 9 intimidated, threatened, harassed or molested. Stalking also means 10 a course of conduct composed of a series of two or more separate 11 acts over a period of time, however short, evidencing a continuity 12 of purpose or unconsented contact with a person that is initiated or continued without the consent of the individual or in disregard of 13 the expressed desire of the individual that the contact be avoided 14 or discontinued. Unconsented contact or course of conduct includes, 15 but is not limited to: 16

17 a. following or appearing within the sight of that

18 individual,

- b. approaching or confronting that individual in a public
  place or on private property,
- c. appearing at the workplace or residence of thatindividual,
- d. entering onto or remaining on property owned, leasedor occupied by that individual,

2	f. sending mail or electronic communications to that

8	domestic violence, sexual assault or adult human sex trafficking
9	program, certified by the Attorney General or operating under a
10	tribal government, who provides support and assistance for a person
11	who files a petition under the Protection from Domestic Abuse Act.
