16	SECTION 1. SECTION 1. NEW LAW A new section of law
17	not to be codified in the Oklahoma Statutes reads as follows:
18	This act shall be known and may be cited as the "Bond
19	Transparency Act of 2017".
20	SECTION 2. NEW LAW A new section of law to be codified
21	in the Oklahoma Statutes as Section 896.1 of Title 62, unless there
22	is created a duplication in numbering, reads as follows:
23	A. At least thirty (30) days after the approval for a vote on a
24	bond or other evidence of indebtedness to be issued by the local

government entities described in subsection C of this section, the governing board of such entity shall cause to be published on that local government website:

- A description of the projects or assets that will be acquired, improved or repaired with the proceeds from the issuance of the bonds;
- 2. A description of any unpaid or unfinished bond approved by the voters of that jurisdiction preceding the date of the vote on the bonds to be issued; and
- 3. A detailed description of the use of the previous bond proceeds. If the bond proceeds were used to acquire or improve real property, the description shall include a physical address using a street number or some other method by which the location of the property can be identified.
- B. If the local government entity does not have a website, then it shall make the information accessible through some other method using the Internet to persons who reside in the geographic area of the local government entity. Should there be no reasonable method as described in this section, the entity shall cause to be published at least once in a newspaper of general circulation in the geographic area in which the voters of the local government jurisdiction reside.
- C. The provisions of subsection A of this section shall be applicable to any bond or other evidence of indebtedness the
