6 AS INTRODUCED

7 An Act relating to professions and occupations;
8 amending 59 O.S. 2021, Section 161.10a, which relates
9 to the Oklahoma Chiropractic Practice Act; modifying
10 continuing education requirements; and providing an
11 effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 59 O.S. 2021, Section 161.10a, is
14 amended to read as follows:

15 Section 161.10a A. ~~At least ninety (90) calendar days prior to~~
16 ~~the date of a proposed continuing education course, an~~ Applications
17 to provide chiropractic continuing education seminars shall be
18 submitted for review and approval by the Board of Chiropractic
19 Examiners. An applicant, association or entity shall submit to the
20 Board for approval:

- 21 1. An application to provide continuing education in this
22 state;
- 23 2. The agenda for the continuing education seminar;
- 24 3. The professional background of the instructors; and

1 4. A summary of the courses to be taught at the continuing
2 education seminar.

3 B. ~~No later than sixty (60) calendar days after submission of~~
4 ~~the application, the Board of Chiropractic Examiners shall either~~
5 ~~approve or reject the continuing education seminar~~ Prior to approval
6 of an application, the Board may authorize the Executive Director to
7 temporarily approve applications, or amendments to an application,
8 pursuant to the requirements specified by this statute and the rules
9 approved by the Board for continuing education programs. Continuing
10 education credits may only be counted for seminars receiving final
11 Board approval.

12 C. A continuing education program shall offer seminars
13 providing continuing education on those subjects within the scope of
14 practice of chiropractic as well as those technical, professional,
15 and practical subjects that relate to the practice of chiropractic
16 as included in Section 161.8 of ~~Title 59 of the Oklahoma Statutes~~
17 this title. Instructors at continuing education seminars may sell
18 products as long as the sale of such products is ancillary to the
19 purpose of the seminar.

20 D. Each year a chiropractic physician must attend sixteen (16)
21 hours of continuing education. Twelve (12) hours must be within the
22 scope of practice of chiropractic as well as those technical,
23 professional, and practical subjects that relate to the practice of

1 chiropractic as included in Section 161.8 of this title. A maximum
2 of four (4) hours may be non-clinical in nature.

3 E. ~~Beginning January 1, 2006, a~~ A maximum of eight (8) hours of
4 the annual Oklahoma continuing education requirements may be
5 obtained by a continuing education program outside this state if the
6 out-of-state continuing education program is approved by the Board.

7 F. Chiropractic physicians who have not been in active practice
8 during the previous year shall be exempt from that calendar year's
9 continuing education requirements. However, prior to returning to
10 active practice, the chiropractor must have attended the required
11 continuing education during the previous calendar year.

12 G. All licensed chiropractic physicians must attend a minimum
13 of eight (8) hours of in-state continuing education programs
14 approved by the Board of Chiropractic Examiners.

15 H. The Board may waive the requirements for continuing
16 education, if the licensee was prevented from attending by illness
17 or extenuating circumstances, as determined by the Board. In
18 waiving the continuing education requirements for any given year,
19 the Board may require the licensee to make up the hours in the
20 succeeding year as a condition for license renewal.

21 SECTION 2. This act shall become effective November 1, 2023.
