8	An Act relating to professions and occupations; amending 59 O.S. 2011, Section 1850.8, which relates
9	to Mechanical Licensing Act; authorizing certain apprentices to take limited residential journeyman
10	examination; and providing an effective date.

13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. AMENDATORY 59 O.S. 2011, Section 1850.8, is
15	amended to read as follows:
16	Section 1850.8 A. The Construction Industries Board shall
17	issue a license as a mechanical journeyman or mechanical contractor
18	to any person who:
19	1. Has been certified by the Committee of Mechanical Examiners
20	as having successfully passed the appropriate examination; and
21	2. Has paid the license fee and has otherwise complied with the
22	provisions of the Mechanical Licensing Act. The license fees shall
23	be established by rule by the Board pursuant to Section 1000.5 of
24	this title.

1 A registered apprentice working under the supervision of a в. 2 mechanical contractor may sit for any journeyman license 3 examination, except for the unlimited journeyman license 4 examination, without satisfying the training or experience 5 requirements in the Mechanical Licensing Act if the mechanical 6 contractor certifies to the Construction Industries Board that the 7 registered apprentice has the skills necessary to sit for the 8 journeyman license examination.

9 C. All licenses shall be nontransferable. No license shall be 10 issued for longer than one (1) year and all licenses shall expire on 11 the last day in the birth month of the licensee. Licenses renewed 12 more than thirty (30) days following the date of expiration may only 13 be renewed upon application and payment of the required fees and 14 payment of any penalty for late renewal, as shall be established by 15 the Board. No journeyman or contractor license shall be renewed 16 unless the licensee has completed the required hours of continuing 17 education as determined by the Committee. Persons who are licensed 18 as contractors under the Mechanical Licensing Act may have their 19 license placed on inactive status by paying the annual renewal fee 20 and eliminating the bonding and insurance requirements. No late fee 21 shall be charged to renew a license which expired while the 22 applicant was in military service, if application is made within one 23 (1) year of discharge from the military service.

1	C. D. The Board is authorized to establish and issue, subject
2	to the provisions of the Mechanical Licensing Act, limited licenses
3	in each area of mechanical work based on the experience, ability,
4	examination scores and the education of the applicant. The limited
5	licenses shall authorize the licensee to engage in only those
6	activities and within the limits specified in the license.
7	SECTION 2. This act shall become effective November 1, 2021.
