10	funds; providing budgetary and expenditure procedures; requiring the promulgation of rules for

15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. NEW LAW A new section of law to be codified
17	in the Oklahoma Statutes as Section 1-580 of Title 63, unless there
18	is created a duplication in numbering, reads as follows:
19	A. 1. There is hereby created in the State Treasury a
20	revolving fund for the State Department of Health to be designated
21	the "Pediatric Cancer Research and Resources Revolving Fund". The
22	fund shall be a continuing fund, not subject to fiscal year
23	limitations, and shall consist of all monies designated for deposit
24	to the fund by law and any public donations otherwise eligible for

1 deposit in such fund. All monies accruing to the credit of said
2 fund are hereby appropriated and may be budgeted and expended by the
3 State Department of Health for the purposes of:

- 4 a. providing grants to entities engaging in research
 5 related to pediatric cancer, and
- b. providing grants to entities assisting families
 confronted with financial challenges associated with
 pediatric cancer treatment.

9 2. Expenditures from said fund shall be made upon warrants
10 issued by the State Treasurer against claims filed as prescribed by
11 law with the Director of the Office of Management and Enterprise
12 Services for approval and payment.

B. The State Department of Health shall establish eligibility
and application requirements for the award of grants authorized
under the provisions of this section. In no event shall the
Department award grants in excess of the unencumbered balance of the
Pediatric Cancer Research and Resources Revolving Fund.

18 C. The State Department of Health shall promulgate rules for 19 the proper administration of the Pediatric Cancer Research and 20 Resources Revolving Fund in accordance with the requirements of this 21 section.

SECTION 2. This act shall become effective July 1, 2023.
 SECTION 3. It being immediately necessary for the preservation
 of the public peace, health or safety, an emergency is hereby
