9	An Act relating to elections; amending 26 O.S. 2011, Section 13A-103, which relates to election dates;
10	providing for primary and general elections for candidates for the board of education; providing
11	procedures; and providing an effective date.

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 26 O.S. 2011, Section 13A-103, is
16	amended to read as follows:
17	A. <u>1.</u> The election general election of members of the board of
18	education of every school district and technology center school
19	district shall be conducted on the first Tuesday of April of each
20	<u>year.</u>
21	2. The primary election of members of the board of education of
22	every school district and technology center school district, if
23	necessary, shall be conducted on the second Tuesday in February of
24	each year, except in any year when a Presidential Preferential

Primary is held in February, then the election shall be held on the
 same day as the Presidential Preferential Primary.

3 <u>3. If only two candidates qualify to have their names appear on</u>
4 <u>the ballot, the names of both candidates shall appear on the ballot</u>
5 at the board of education general election.

6 4. If more than two candidates qualify to have their names 7 appear on the ballot, the names of all such candidates shall appear on the ballot at the board of education primary election. A 8 9 candidate receiving more than fifty percent (50%) of the votes cast 10 in the board of education primary election shall be elected to the 11 office. If no candidate receives more than fifty percent (50%) of 12 the votes cast in the election provided for in this subsection, an election between board of education primary election, then the two 13 candidates with the highest number of votes shall be conducted on 14 15 the first Tuesday in April of that year appear on the ballot at the 16 board of education General Election.

B. Elections on the question of making a levy or levies for
schools under Section 9, Section 9B or Section 10 of Article X of
the Oklahoma Constitution shall be held on the second Tuesday in
February of each year, except in any year when a Presidential
Preferential Primary is held in February, then the election shall be
held on the same day as the Presidential Preferential Primary.

4	SECTION 2. This act shall become effective November 1, 2018.
