18 ~~BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:~~

19 SECTION 1. AMENDATORY 70 O.S. 2011, Section 11-103.6, as  
20 last amended by Section 33, Chapter 54, O.S.L. 2015 (70 O.S. Supp.  
21 2015, Section 11-103.6), is amended to read as follows:

22 Section 11-103.6 A. 1. The State Board of Education shall  
23 adopt subject matter standards for instruction of students in the  
24 public schools of this state that are necessary to ensure there is  
attainment of desired levels of competencies in a variety of areas

1 to include language, mathematics, science, social studies and  
2 communication.

3 2. School districts shall develop and implement curriculum,  
4 courses and instruction in order to ensure that students meet the  
5 skills and competencies as set forth in this section and in the  
6 subject matter standards adopted by the State Board of Education.

7 3. All students shall gain literacy at the elementary and  
8 secondary levels. Students shall develop skills in reading,  
9 writing, speaking, computing and critical thinking. For purposes of  
10 this section, critical thinking means a manner of analytical  
11 thinking which is logical and uses linear factual analysis to reach  
12 a conclusion. They also shall learn about cultures and environments  
13 - their own and those of others with whom they share the earth.  
14 Students, therefore, shall study social studies, literature,  
15 languages, the arts, mathematics and science. Such curricula shall  
16 provide for the teaching of a hands-on career exploration program in  
17 cooperation with technology center schools.

18 4. The subject matter standards shall be designed to teach the  
19 competencies for which students shall be tested as provided in  
20 Section 1210.508 of this title, and shall be designed to prepare all  
21 students for active citizenship, employment and/or successful  
22 completion of postsecondary education without the need for remedial  
23 coursework at the postsecondary level.

1           5. The subject matter standards shall be designed with rigor as  
2 defined in paragraph 3 of subsection F of this section.

3           6. The subject matter standards for English Language Arts shall  
4 give Classic Literature and nonfiction literature equal  
5 consideration to other literature. In addition, emphasis shall be  
6 given to the study of complete works of literature.

7           7. At a minimum, the subject matter standards for mathematics  
8 shall require mastery of the standard algorithms in mathematics,  
9 which is the most logical, efficient way of solving a problem that  
10 consistently works, and for students to attain fluency in Euclidian  
11 geometry.

12           B. Subject to the provisions of subsection C of this section,  
13 in order to graduate from a public high school accredited by the  
14 State Board of Education with a standard diploma, students shall  
15 complete the following college preparatory/work ready curriculum  
16 units or sets of competencies at the secondary level:

17           1. Four units or sets of competencies of English to include  
18 Grammar, Composition, Literature, or any English course approved for  
19 college admission requirements;

20           2. Three units or sets of competencies of mathematics, limited  
21 to Algebra I, Algebra II, Geometry, Trigonometry, Math Analysis,  
22 Calculus, Advanced Placement Statistics, or any mathematics course  
23 with content and/or rigor above Algebra I and approved for college  
24 admission requirements;

1           3. Three units or sets of competencies of laboratory science,  
2 limited to Biology, Chemistry, Physics, or any laboratory science  
3 course with content and/or rigor equal to or above Biology and  
4 approved for college admission requirements;

5           4. Three units or sets of competencies of history and  
6 citizenship skills, including one unit of American History, 1/2 unit  
7 of Oklahoma History, 1/2 unit of United States Government and one  
8 unit from the subjects of History, Government, Geography, Economics,  
9 Civics, or non-Western culture and approved for college admission  
10 requirements;

11           5. Two units or sets of competencies of the same foreign or  
12 non-English language or two units of computer technology approved  
13 for college admission requirements, whether taught at a high school  
14 or a technology center school, including computer programming,  
15 hardware, and business computer applications, such as word  
16 processing, databases, spreadsheets, and graphics, excluding  
17 keyboarding or typing courses;

18           6. One additional unit or set of competencies selected from  
19 paragraphs 1 through 5 of this subsection or career and technology  
20 education courses approved for college admission requirements; and

21           7. One unit or set of competencies of fine arts, such as music,  
22 art, or drama, or one unit or set of competencies of speech.

23           C. In lieu of the requirements of subsection B of this section  
24 which requires a college preparatory/work ready curriculum, a

1 student may enroll in the core curriculum as provided in subsection  
2 D of this section upon written approval of the parent or legal  
3 guardian of the student. School districts may require a parent or  
4 legal guardian of the student to meet with a designee of the school  
5 prior to enrollment in the core curriculum. The State Department of  
6 Education shall develop and distribute to school districts a form  
7 suitable for this purpose, which shall include information on the  
8 benefits to students of completing the college preparatory/work  
9 ready curriculum as provided for in subsection B of this section.

10 D. For those students subject to the requirements of subsection  
11 C of this section, in order to graduate from a public high school  
12 accredited by the State Board of Education with a standard diploma,  
13 students shall complete the following core curriculum units or sets  
14 of competencies at the secondary level:

15 1. Language Arts - 4 units or sets of competencies, to consist  
16 of 1 unit or set of competencies of grammar and composition, and 3  
17 units or sets of competencies which may include, but are not limited  
18 to, the following courses:

- 19 a. American Literature,
- 20 b. English Literature,
- 21 c. World Literature,
- 22 d. Advanced English Courses, or
- 23 e. other English courses with content and/or rigor equal  
24 to or above grammar and composition;

1           2. Mathematics - 3 units or sets of competencies, to consist of  
2 1 unit or set of competencies of Algebra I or Algebra I taught in a  
3 contextual methodology, and 2 units or sets of competencies which  
4 may include, but are not limited to, the following courses:

- 5           a. Algebra II,
- 6           b. Geometry or Geometry taught in a contextual  
7           methodology,
- 8           c. Trigonometry,
- 9           d. Math Analysis or Precalculus,
- 10          e. Calculus,
- 11          f. Statistics and/or Probability,
- 12          g. Computer Science,
- 13          h. (1) contextual mathematics courses which enhance  
14             technology preparation, or  
15             (2) a science, technology, engineering and math  
16             (STEM) block course meeting the requirements for  
17             course competencies listed in paragraph 2 of  
18             subsection B of this section, whether taught at  
19             a:
  - 20             (a) comprehensive high school, or
  - 21             (b) technology center school when taken in the  
22             tenth, eleventh or twelfth grade, taught by  
23             a certified teacher, and approved by the  
24

1 State Board of Education and the independent  
2 district board of education,

- 3 i. mathematics courses taught at a technology center  
4 school by a teacher certified in the secondary subject  
5 area when taken in the tenth, eleventh or twelfth  
6 grade upon approval of the State Board of Education  
7 and the independent district board of education, or  
8 j. equal to or above Algebra I;

9 3. Science - 3 units or sets of competencies, to consist of 1  
10 unit or set of competencies of Biology I or Biology I taught in a  
11 contextual methodology, and 2 units or sets of competencies in the  
12 areas of life, physical, or earth science or technology which may  
13 include, but are not limited to, the following courses:

- 14 a. Chemistry I,
- 15 b. Physics,
- 16 c. Biology II,
- 17 d. Chemistry II,
- 18 e. Physical Science,
- 19 f. Earth Science,
- 20 g. Botany,
- 21 h. Zoology,
- 22 i. Physiology,
- 23 j. Astronomy,
- 24 k. Applied Biology/Chemistry,

- 1           1.    Applied Physics,
- 2           m.    Principles of Technology,
- 3           n.    qualified agricultural education courses,
- 4           o.    (1)   contextual science courses which enhance
- 5                        technology preparation, or
- 6                        (2)   a science, technology, engineering and math
- 7                                (STEM) block course meeting the requirements for
- 8                                course competencies listed in paragraph 3 of
- 9                                subsection B of this section, whether taught at
- 10                              a:
- 11                              (a)   comprehensive high school, or
- 12                              (b)   technology center school when taken in the
- 13                                        tenth, eleventh or twelfth grade, taught by
- 14                                        a certified teacher, and approved by the
- 15                                        State Board of Education and the independent
- 16                                        district board of education,
- 17           p.    science courses taught at a technology center school
- 18                        by a teacher certified in the secondary subject area
- 19                        when taken in the tenth, eleventh or twelfth grade

- 22           q.    other science courses with content and/or rigor equal

1 4. Social Studies - 3 units or sets of competencies, to consist  
2 of 1 unit or set of competencies of United States History, 1/2 to 1  
3 unit or set of competencies of United States Government, 1/2 unit or  
4 set of competencies of Oklahoma History, and 1/2 to 1 unit or set of  
5 competencies which may include, but are not limited to, the  
6 following courses:

- 7 a. World History,
- 8 b. Geography,
- 9 c. Economics,
- 10 d. Anthropology, or
- 11 e. other social studies courses with content and/or rigor  
12 equal to or above United States History, United States  
13 Government, and Oklahoma History; and

14 5. Arts - 2 units or sets of competencies which may include,  
15 but are not limited to, courses in Visual Arts and General Music.

16 E. 1. In addition to the curriculum requirements of either  
17 subsection B or D of this section, in order to graduate from a  
18 public high school accredited by the State Board of Education  
19 students shall complete the requirements for a personal financial  
20 literacy passport as set forth in the Passport to Financial Literacy  
21 Act and any additional course requirements or recommended elective  
22 courses as may be established by the State Board of Education and  
23 the district school board. School districts shall strongly  
24 encourage students to complete two units or sets of competencies of

1 foreign languages and two units or sets of competencies of physical  
2 and health education.

3 2. No student shall receive credit for high school graduation  
4 more than once for completion of the same unit or set of  
5 competencies to satisfy the curriculum requirements of this section.

6 3. A school district shall not be required to offer every  
7 course listed in subsections B and D of this section, but shall  
8 offer sufficient courses to allow a student to meet the graduation  
9 requirements during the secondary grade years of the student.

10 F. For purposes of this section:

11 1. "Contextual methodology" means academic content and skills  
12 taught by utilizing real-world problems and projects in a way that  
13 helps students understand the application of that knowledge;

14 2. "Qualified agricultural education courses" means courses  
15 that have been determined by the State Board of Education to offer  
16 the sets of competencies for one or more science content areas and  
17 which correspond to academic science courses. Qualified  
18 agricultural education courses shall include, but are not limited  
19 to, Horticulture, Plant and Soil Science, Natural Resources and  
20 Environmental Science, and Animal Science. The courses shall be  
21 taught by teachers certified in agricultural education and comply  
22 with all rules of the Oklahoma Department of Career and Technology  
23 Education;

24

1           3. "Rigor" means a level of difficulty that is thorough,  
2 exhaustive and accurate and is appropriate for the grade level;

3           4. "Sets of competencies" means instruction in those skills and  
4 competencies that are specified in the subject matter standards  
5 adopted by the State Board of Education and other skills and  
6 competencies adopted by the Board, without regard to specified  
7 instructional time; and

8           5. "Unit" means a Carnegie Unit as defined by the North Central  
9 Association's Commission on Schools.

10          G. 1. The State Board of Education shall adopt a plan to  
11 ensure that rigor is maintained in the content, teaching  
12 methodology, level of expectations for student achievement, and  
13 application of learning in all the courses taught to meet the  
14 graduation requirements as specified in this section.

15          2. The State Board of Education shall allow as much flexibility  
16 at the district level as is possible without diminishing the rigor  
17 or undermining the intent of providing these courses. To accomplish  
18 this purpose, the State Department of Education shall work with  
19 school districts in reviewing and approving courses taught by  
20 districts that are not specifically listed in subsections B and D of  
21 this section. Options may include, but shall not be limited to,  
22 courses taken by concurrent enrollment, advanced placement, or  
23 correspondence, or courses bearing different titles. Any courses  
24 approved by the State Board of Education to meet the unit or

1 competency requirements in subsections B and D of this section shall  
2 meet the sets of competencies requirements as defined in paragraph 4  
3 of subsection F of this section.

4 3. The State Board of Education shall approve an advanced  
5 placement computer science course to meet the requirements of course  
6 competencies listed in paragraph 2 of subsection B of this section  
7 if the course is taken in a student's senior year and the student is  
8 concurrently enrolled in or has successfully completed Algebra II.

9 4. Technology center school districts may offer programs  
10 designed in cooperation with institutions of higher education which  
11 have an emphasis on a focused field of career study upon approval of  
12 the State Board of Education and the independent district board of  
13 education. Students in the tenth grade may be allowed to attend  
14 these programs for up to one-half (1/2) of a school day and credit  
15 for the units or sets of competencies required in paragraphs 2 and 3  
16 of subsection B or D of this section shall be given if the courses  
17 are taught by a teacher certified in the secondary subject area;  
18 provided, credit for units or sets of competencies pursuant to  
19 subsection B of this section shall be approved for college admission  
20 requirements.

21 5. If a student enrolls in a concurrent course, the school  
22 district shall not be responsible for any costs incurred for that  
23 course, unless the school district does not offer enough course  
24 selection during the student's secondary grade years to allow the

1 student to receive the courses needed to meet the graduation  
2 requirements of this section. If the school district does not offer  
3 the necessary course selection during the student's secondary grade  
4 years, it shall be responsible for the cost of resident tuition at  
5 an institution in The Oklahoma State System of Higher Education,  
6 fees, and books for the concurrent enrollment course, and providing  
7 for transportation to and from the institution to the school site.

8 It is the intent of the Legislature that for students enrolled  
9 in a concurrent enrollment course which is paid for by the school  
10 district pursuant to this paragraph, the institution charge only the  
11 supplementary and special service fees that are directly related to  
12 the concurrent enrollment course and enrollment procedures for that  
13 student. It is further the intent of the Legislature that fees for  
14 student activities and student service facilities, including the  
15 student health care and cultural and recreational service fees, not  
16 be charged to such students.

17 6. Credit for the units or sets of competencies required in  
18 subsection B or D of this section shall be given when such units or  
19 sets of competencies are taken prior to ninth grade if the teachers  
20 are certified or authorized to teach the subjects for high school  
21 credit and the required rigor is maintained.

22 7. The three units or sets of competencies in mathematics  
23 required in subsection B or D of this section shall be completed in  
24 the ninth through twelfth grades. If a student completes any

1 required courses or sets of competencies in mathematics prior to  
2 ninth grade, the student may take any other mathematics courses or  
3 sets of competencies to fulfill the requirement to complete three  
4 units or sets of competencies in grades nine through twelve after  
5 the student has satisfied the requirements of subsection B or D of  
6 this section.

7 8. All units or sets of competencies required for graduation  
8 may be taken in any sequence recommended by the school district.

9 H. As a condition of receiving accreditation from the State  
10 Board of Education, all students in grades nine through twelve shall  
11 enroll in a minimum of six periods, or the equivalent in block  
12 scheduling or other scheduling structure that allows for instruction  
13 in sets of competencies, of rigorous academic and/or rigorous  
14 vocational courses each day, which may include arts, vocal and  
15 instrumental music, speech classes, and physical education classes.

16 I. 1. Academic and vocational-technical courses designed to  
17 offer sets of competencies integrated or embedded within the course  
18 that provide for the teaching and learning of the appropriate skills  
19 and knowledge in the subject matter standards, as adopted by the  
20 State Board of Education, may upon approval of the Board, in  
21 consultation with the Oklahoma Department of Career and Technology  
22 Education if the courses are offered at a technology center school  
23 district, be counted for academic credit and toward meeting the  
24 graduation requirements of this section.

1           2. Internet-based courses offered by a technology center school  
2 that are taught by a certified teacher and provide for the teaching  
3 and learning of the appropriate skills and knowledge in the subject  
4 matter standards may, upon approval of the State Board of Education  
5 and the independent district board of education, be counted for  
6 academic credit and toward meeting the graduation requirements of  
7 this section.

8           3. Internet-based courses or vocational-technical courses  
9 utilizing integrated or embedded skills for which no subject matter  
10 standards have been adopted by the State Board of Education may be  
11 approved by the Board, in consultation with the Oklahoma Department  
12 of Career and Technology Education if the courses are offered at a  
13 technology center school district, if such courses incorporate  
14 standards of nationally recognized professional organizations and  
15 are taught by certified teachers.

16           4. Courses offered by a supplemental education organization  
17 that is accredited by a national accrediting body and that are  
18 taught by a certified teacher and provide for the teaching and  
19 learning of the appropriate skills and knowledge in the subject  
20 matter standards may, upon approval of the State Board of Education  
21 and the school district board of education, be counted for academic  
22 credit and toward meeting the graduation requirements of this  
23 section.

24

1 J. The State Board of Education shall provide an option for  
2 high school graduation based upon attainment of the desired levels  
3 of competencies as required in tests pursuant to the provisions of  
4 Section 1210.508 of this title. Such option shall be in lieu of the  
5 amount of course credits earned.

6 K. The State Board of Education shall prescribe, adopt and  
7 approve a promotion system based on the attainment by students of  
8 specified levels of competencies in each area of the core  
9 curriculum.

10 L. Children who have individualized education programs pursuant  
11 to the Individuals with Disabilities Education Act (IDEA), and who  
12 satisfy the graduation requirements through the individualized  
13 education program for that student shall be awarded a standard  
14 diploma.

15 M. Students who enter the ninth grade in or prior to the 2007-  
16 08 school year who are enrolled in an alternative education program  
17 and meet the requirements of their plans leading to high school  
18 graduation developed pursuant to Section 1210.568 of this title  
19 shall be awarded a standard diploma.

20 N. Any student who completes the curriculum requirements of the  
21 International Baccalaureate Diploma Program shall be awarded a  
22 standard diploma.

23 O. Any student who successfully completes an advanced  
24 mathematics or science course offered pursuant to Section 1210.404



1 of this title shall be granted academic credit toward meeting the  
2 graduation requirements pursuant to paragraph 2 or 3, as  
3 appropriate, of subsection B or D of this section.

4 P. For purposes of this section, the courses approved for  
5 college admission requirements shall be courses which are approved  
6 by the Oklahoma State Regents for Higher Education for admission to  
7 an institution within The Oklahoma State System of Higher Education.

8 Q. The State Department of Education shall collect and report  
9 data by school site and district on the number of students who  
10 enroll in the core curriculum as provided in subsection D of this  
11 section.

12 SECTION 2. AMENDATORY 70 O.S. 2011, Section 1210.507, as  
13 last amended by Section 7, Chapter 430, O.S.L. 2014 (70 O.S. Supp.  
14 2015, Section 1210.507), is amended to read as follows:

15 Section 1210.507 A. The State Board of Education shall  
16 promulgate rules necessary for the implementation and administration  
17 of the provisions of the Oklahoma School Testing Program Act.

18 B. The State Board of Education shall require school district  
19 boards of education to annually provide information to the  
20 district's students, parents of students, and the public at large  
21 about the proper meaning and use of tests administered pursuant to  
22 the provisions of the Oklahoma School Testing Program Act. The  
23 Department shall develop materials and make them available to school  
24 districts regarding the Oklahoma School Testing Program.

1 C. 1. Students enrolled in an online course or program that is  
2 offered by a school district or charter school that is not the  
3 district of residence or is not located in the district of residence  
4 of the student shall be provided the opportunity to take any test  
5 required pursuant to the Oklahoma School Testing Program Act or any  
6 other test generally required of students by the school district in  
7 which the student is enrolled at an alternative testing location  
8 approved by the State Board of Education. The alternative testing  
9 locations may be at sites that are not in the school district that  
10 is offering the online course or program or the district of  
11 residence. Alternative testing locations may include technology  
12 center school sites or any other testing location selected by the  
13 school district or charter school offering the online course or  
14 program. All alternative testing locations shall be subject to  
15 testing location rules promulgated by the State Board of Education.  
16 The school district or charter school offering the online course or  
17 program shall be responsible for any cost incurred in providing an  
18 alternative testing location and any additional cost of  
19 administering a test at an alternative testing location. In order  
20 to provide alternative testing locations at geographically dispersed  
21 sites, the school district or charter school offering the online  
22 course or program shall, at a minimum, provide not less than six  
23 alternative testing locations, with at least one location in each  
24 quadrant of the state and in each of the two metropolitan areas in

1 the state. Additional alternative testing locations may be provided  
2 by the school district or charter school offering the online course  
3 or program.

4 2. The performance of students on any test required pursuant to  
5 the Oklahoma School Testing Program Act or any other test generally  
6 required of students by the school district who are enrolled full-  
7 time in an online program that is offered by a school district or  
8 charter school that is not the district of residence or is not  
9 located in the district of residence of the student shall be  
10 reported separately by the school district or charter school and  
11 shall not be included when determining the performance levels of the  
12 school district or charter school in the Oklahoma School Testing  
13 Program as reported in the Oklahoma Educational Indicators Program.

14 D. The State Board of Education shall seek to establish and  
15 post on the Internet a sample test item bank that will be made  
16 available to teachers and will allow them to create and deliver  
17 classroom assessments throughout the school year to check for  
18 student mastery of key concepts assessed by the criterion-referenced  
19 tests administered to students pursuant to the Oklahoma School  
20 Testing Program Act. Subject to the availability of funds, the  
21 Board shall annually release end-of-instruction test items and make  
22 them available to the public.

23 E. The State Board of Education shall post on the Internet  
24 criterion-referenced sample tests for each grade level and subject

1 matter test administered to students pursuant to the Oklahoma School  
2 Testing Program Act for the purpose of communicating expectation  
3 concerning test difficulty level and format to teacher, parents and  
4 students. The Board shall maintain the sample tests on the Internet  
5 throughout the year and, as changes are made in the state academic  
6 content standards, shall update the sample tests. The Board shall  
7 seek to expand the number of sample test items each year and to  
8 revise test items as needed. The sample tests shall reflect the  
9 actual test administered to students and may contain questions used  
10 on actual tests given in previous years.

11 F. The State Board of Education ~~shall seek to~~ may implement an  
12 electronic delivery system for all tests administered pursuant to  
13 the Oklahoma School Testing Program Act that will allow students to  
14 participate in computer-based assessments in order to expedite the  
15 delivery and use of the test results. ~~Notwithstanding the~~  
16 ~~requirement to implement online or computer-based assessments as~~  
17 ~~otherwise provided by law, in~~ If the Board implements an electronic  
18 delivery system for tests, the Board shall continue to administer  
19 all tests by another means, including but not limited to printed  
20 tests if funds are available. If options are available, school  
21 districts shall have the authority to select the means of  
22 administration of all tests administered in that district. In  
23 circumstances where the administration or delivery of an online or  
24 computer-based assessment has been or will be disrupted, delayed or

1 cause problems with student participation, the Board may stop or  
2 cancel the online or computer-based assessment and administer the  
3 assessment by another means.

4 SECTION 3. AMENDATORY 70 O.S. 2011, Section 1210.508, as  
5 last amended by Section 8, Chapter 430, O.S.L. 2014 (70 O.S. Supp.  
6 2015, Section 1210.508), is amended to read as follows:

7 Section 1210.508 A. 1. The State Board of Education shall  
8 develop and administer a series of criterion-referenced tests  
9 designed to indicate whether the subject matter standards, as  
10 defined by the State Board of Education, which Oklahoma public  
11 school students are expected to have attained have been achieved.  
12 The Board may develop and administer any criterion-referenced test  
13 in any subject not required by federal law, contingent upon the  
14 availability of funding. Students who do not perform at least at  
15 the proficient level on tests shall be remediated, subject to the  
16 availability of funding.

17 2. Contingent upon the availability of state and federal funds,  
18 the Board, in accordance with federal law, shall administer  
19 criterion-referenced tests for grades three and four in:

- 20 a. reading, and
- 21 b. mathematics.

22 3. Contingent upon the availability of funds, the Board shall  
23 administer criterion-referenced tests for grade five in:

- 24 a. reading,

- 1           b.    mathematics,
- 2           c.    science,
- 3           d.    social studies, which shall consist of the history,
- 4                 Constitution and government of the United States, and
- 5                 geography, and
- 6           e.    writing of English; provided, that the Board may elect
- 7                 to not administer the writing of English test until
- 8                 the 2017-2018 school year or until the Board has
- 9                 developed the statewide student assessments for
- 10                English Language Arts and Mathematics as provided for

20 assessed in a valid and reliable manner with the state academic
