An Act relating to counties and county officers; amending 19 O.S. 2011, Section 517.1, as last amended by Section 8 of Enrolled House Bill No. 1189 of the 1st Session of the 56th Oklahoma Legislature, which relates to departmental records; providing time period that certain recordings from equipment attached to law enforcement officers shall be kept; and providing an effective date.

SUBJECT: County records

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 19 O.S. 2011, Section 517.1, as last amended by Section 8 of Enrolled House Bill No. 1189 of the 1st Session of the 56th Oklahoma Legislature, is amended to read as follows:

Section 517.1 \underline{A} . The governing body of each county may establish a length of time for the county to keep departmental records and authorize the sheriff to properly dispose of or digitize all records not specifically addressed in other statutes. Such

B. Except as otherwise provided in this section, records shall be kept for a minimum of seven (7) years; provided, however.

However, if the sheriff is the sole source for such records, the records shall be kept for a minimum of seven (7) years; provided, that any audio or video recordings from recording equipment attached to the person of a law enforcement officer that depict anything other than an officer-involved shooting, use of lethal force, incidents involving medical treatment, incidents where a written application is received for the preservation of the specific event, or upon request of the district attorney may be kept at a minimum of one (1) year to be determined by the county sheriff.

SECTION 2. This act shall become effective November 1, 2017.
