11 COMMITTEE SUBSTITUTE

12 An Act relating to the Office of Juvenile Affairs;
13 requiring budgeting in certain categories and
14 amounts; requiring certain performance measures;
15 providing for duties and compensation of employees;
16 authorizing certain attorney position; providing
17 budgetary limitations; authorizing certain requests
18 for exemptions from expenditure limitations and
19 budgetary limitations; requiring certain procedures;
20 requiring certain filings; requiring certain
21 approvals; requiring written notice; providing lapse
22 dates; requiring and prohibiting certain budget
23 procedures; providing an effective date; and
24 declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. For the fiscal year ending June 30, 2016, the Office
of Juvenile Affairs shall budget all funds in the following
categories and amounts:

14 The agency shall develop outcome-based performance measures for
15 each budget category.

16 SECTION 2. The duties and compensation of employees, not
17 otherwise prescribed by law, necessary to perform the duties imposed
18 upon the Office of Juvenile Affairs by law shall be set by the
19 Director. The Office of Juvenile Affairs is hereby authorized one
20 (1) FTE for an attorney position. This shall be in addition to the
21 position of General Counsel. The Office of Juvenile Affairs for the
22 fiscal year ending June 30, 2016, shall be subject to the following
23 budgetary limitations on expenditures excluding expenditures for
24 capital and special projects, except as may be authorized pursuant

1 to the provisions of Section 3603 of Title 74 of the Oklahoma
2 Statutes:

5 SECTION 3. A. The Director of the Office of Juvenile Affairs
6 may request that receipt and expenditure of unanticipated federal
7 funds awarded after July 1, 2015, be exempt from expenditure
8 limitations and from budgetary limitations.

9 1. The Director shall make a request for exemption to the
10 Director of the Office of Management and Enterprise Services in
11 writing and file a revised budget work program.

12 2. The Director shall also file copies of the request for
13 exemption and budget work program revisions with the Chair and Vice-
14 chair of the Joint Legislative Committee on Budget and Program
15 Oversight. The Committee shall notify the Director of the Office of
16 Management and Enterprise Services of any noncompliance of the
17 request with legislative intent within twelve (12) calendar days of
18 their receipt of the exemption request.

19 B. The Director of the Office of Management and Enterprise
20 Services shall approve the request for exemption unless both the
21 Chair and Vice-chair of the Joint Legislative Committee on Budget
22 and Program Oversight provide written notification to the Director
23 of the Office of Management and Enterprise Services within twelve
24 (12) calendar days of the Committee's receipt of the exemption

1 request that the exemption subverts the intention and objectives of
2 the Legislature in establishing the original limit. The Director of
3 the Office of Management and Enterprise Services shall give written
4 notice of approval or disapproval of each exemption to the agency,
5 the Governor and the Chair and Vice-chair of the Joint Legislative
6 Committee on Budget and Program Oversight within eighteen (18)
7 calendar days of receiving the request.

8 SECTION 4. Appropriations made by Section 74 of House Bill No.
9 2242 of the 1st Session of the 55th Oklahoma Legislature, not
10 including appropriations made for capital outlay purposes, may be
11 budgeted for the fiscal year ending June 30, 2016 (hereafter FY-16),
12 or may be budgeted for the fiscal year ending June 30, 2017
13 (hereafter FY-17). Funds budgeted for FY-16 may be encumbered only
14 through June 30, 2016, and must be expended by November 15, 2016.
15 Any funds remaining after November 15, 2016, and not budgeted for
16 FY-17, shall lapse to the credit of the proper fund for the then
17 current fiscal year. Funds budgeted for FY-17 may be encumbered
18 only through June 30, 2017. Any funds remaining after November 15,
19 2017, shall lapse to the credit of the proper fund for the then
20 current fiscal year. These appropriations may not be budgeted in
21 both fiscal years simultaneously. Funds budgeted in FY-16, and not
22 required to pay obligations for that fiscal year, may be budgeted
23 for FY-17, after the agency to which the funds have been
24 appropriated has prepared and submitted a budget work program

1 revision removing these funds from the FY-16 budget work program and
2 after such revision has been approved by the Office of Management
3 and Enterprise Services.

4 SECTION 5. This act shall become effective July 1, 2015.

5 SECTION 6. It being immediately necessary for the preservation
6 of the public peace, health and safety, an emergency is hereby
7 declared to exist, by reason whereof this act shall take effect and
8 be in full force from and after its passage and approval.
