Except as otherwise provided, a student who 16 enrolls transfers, pursuant to the Education Open Transfer Act or 17 pursuant to Section 2 8-113 of this act title, in to a school 18 district in which the student is not a resident shall not be 19 eligible to participate in school-related extramural athletic 20 competition governed by the Oklahoma Secondary School Activities 21 Association for a period of one (1) year from on the first day of 22 attendance at the receiving school unless the transfer is from a 23 school district which does not offer the grade the student is 24 entitled to pursue if the student did not letter in the school1 related extramural athletic competition at the student's prior
2 school.

3	B. A student who transfers prior to his or her sophomore year
4	of high school, pursuant to the Education Open Transfer Act or
5	Section 8-113 of this title, shall be eligible to participate in
6	school-related extramural athletic competition governed by the
7	Oklahoma Secondary School Activities Association on the first day of
8	attendance at the receiving school.

9 C. If the student is granted an emergency transfer pursuant to 10 Section 8-104 of this title, was granted a transfer for any reason 11 prior to January 1, 2000, or enrolls pursuant to the Education Open Transfer Act and qualifies for a hardship waiver pursuant to the 12 13 rules of the Oklahoma Secondary School Activities Association, 14 eligibility to participate in school-related extramural athletic 15 competition shall be determined by the Oklahoma Secondary School 16 Activities Association. If the student does not meet the criteria 17 provided in subsection A or B of this section and does not qualify 18 for a hardship waiver, the student shall not be eligible to 19 participate in school-related extramural athletic competition 20 governed by the Oklahoma Secondary School Activities Association for 21 a period of one (1) year from the first day of attendance at the 22 receiving school. 23 SECTION 2. This act shall become effective November 1, 2023. 24
