10	to the Uniform Controlled Dangerous Substances Act; providing for the annulment of registrations;
11	allowing for the impounding and preserving of controlled dangerous substances upon revocation of
12	registration; requiring registrants to maintain controlled dangerous substances not subject to
13	impoundment or revocation; declaring controlled dangerous substances forfeited to the state as waste
14	and subject to destruction; deleting authorization for assessing administrative penalties; deleting
15	exception and construing provision; modifying and deleting procedures for denying, suspending, or
16	revoking registrations; requiring the issuance and service of written orders prior to annulling,
17	conditioning, suspending, or revoking registrations; requiring specificity within written orders;
18	authorizing the use of disciplinary actions; stating procedures for issuing written orders and initiating
19	administrative proceedings; providing construing provisions; declaring circumstances when abatement is
20	inapplicable; providing for the delegation of certain duties; authorizing the immediate suspension of
21	registrations; providing procedures for suspensions; authorizing the assessment of penalties for
22	noncompliance; allowing registrants to apply for a hearing; authorizing the assessment of administrative
23	penalties for certain violations; deeming controlled dangerous substances as contraband under certain
24	circumstances; providing for seizures and

1 forfeitures; authorizing assessment of eradication or destruction fine; prohibiting registrants from reapplying for certain period of time; amending 63 2 O.S. 2021, Section 2-325, which relates to the Precursor Substances Act; providing for the annulment 3 of licenses or permits under certain circumstances; increasing time limit when ordering registrants to 4 appear for show cause hearings; providing construing 5 provision; and declaring an emergency. 6 7 8 9 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 63 O.S. 2021, Section 2-304, is 10 SECTION 1. AMENDATORY amended to read as follows: 11 12 Section 2-304. A. A registration, pursuant to Section 2-303 of this title, to manufacture, distribute, dispense, prescribe, 13 administer or use for scientific purposes a controlled dangerous 14 substance shall be limited, conditioned, denied, suspended, 15 annulled, or revoked by the Director upon a finding that the 16 registrant: 17 1. Has materially falsified any application filed pursuant to 18 the Uniform Controlled Dangerous Substances Act or required by the 19 Uniform Controlled Dangerous Substances Act. It shall be unlawful 20 to knowingly and willfully: 21 make false statements, include false data or omit 22 a. material information on an application for a 23 24

1 registration with the Oklahoma State Bureau of 2 Narcotics and Dangerous Drugs Control, or provide false data or omit material information in any 3 b. records or reports required by rule or law to be 4 5 created, maintained or submitted to the Bureau. Any registrant or applicant for a registration or any official, 6 agent or employee of any registrant or applicant for a registration 7 who violates the provisions of this paragraph shall be guilty of a 8 9 misdemeanor and additionally subject to administrative action;

Has been found guilty of, entered a plea of guilty or
 entered a plea of nolo contendere to a misdemeanor relating to any
 substance defined herein as a controlled dangerous substance or any
 felony under the laws of any state or the United States;

14 3. Has had his or her federal registration retired, suspended
15 or revoked by a competent federal authority and is no longer
16 authorized by federal law to manufacture, distribute, dispense,
17 prescribe, administer or use for scientific purposes controlled
18 dangerous substances;

Has failed to maintain effective controls against the
 diversion of controlled dangerous substances to unauthorized persons
 or entities;

5. Has prescribed, dispensed or administered a controlled dangerous substance from schedules other than those specified in his or her state or federal registration;

Has had a restriction, suspension, revocation, limitation,
 condition or probation placed on his or her professional license or
 certificate or practice as a result of a proceeding pursuant to the
 general statutes;

5 7. Is abusing or, within the past five (5) years, has abused or
6 excessively used drugs or controlled dangerous substances;

8. Has prescribed, sold, administered or ordered any controlled
<u>dangerous</u> substance for an immediate family member, himself or
herself; provided that this shall not apply to a medical emergency
when no other doctor is available to respond to the emergency;

9. Has possessed, used, prescribed, dispensed or administered
 drugs or controlled dangerous substances for other than legitimate
 medical or scientific purposes or for purposes outside the normal
 course of his or her professional practice;

10. Has been under the influence of alcohol or another
intoxicating substance which adversely affected the central nervous
system, vision, hearing or other sensory or motor functioning to
such degree the person was impaired during the performance of his or
her job; or

11. Has violated any federal law relating to any controlled
<u>dangerous</u> substances, any provision of the Uniform Controlled
Dangerous Substances Act or any rules of the Oklahoma State Bureau
of Narcotics and Dangerous Drugs Control.

In the event the Director suspends or revokes a registration granted under Section 2-303 of this title, all controlled dangerous 2 substances owned or possessed by the registrant pursuant to such 3 registration at the time of denial revocation or suspension or the 4 5 effective date of the revocation order, as the case may be, may in the discretion of the Director be impounded and preserved. 6 All controlled dangerous substances not impounded or preserved by the 7 Director shall be maintained by the registrant. No disposition, 8 9 purchase, distribution, sale, or transfer may be made of substances 10 impounded and preserved until the time for taking an appeal has elapsed or until all appeals have been concluded unless a court, 11 12 upon application therefor, orders the sale of perishable substances and the deposit of the proceeds of the sale with the court. Upon a 13 revocation order becoming final, all such controlled dangerous 14 substances shall be forfeited to the state or otherwise considered 15 waste and submitted to a licensed medical marijuana waste disposal 16 service for destruction pursuant to Section 430 of this title. 17 The Drug Enforcement Administration shall promptly be 18 С. notified of all orders suspending or revoking registration and all 19 forfeitures of controlled dangerous substances. 20 D. In lieu of or in addition to any other remedies available to 21

21	shall serve upon the applicant or registrant an order to show cause
22	why registration should not be denied, revoked or suspended or why
23	the renewal should not be refused. The order to show cause shall
24	contain a statement of the basis therefor and shall call upon the

1	applicant or registrant to appear before the appropriate person or
2	agency at a time and place within thirty (30) days after the date of
3	service of the order, but in the case of a denial or renewal of
4	registration the show cause order shall be served within thirty (30)
5	days before the expiration of the registration. These has reason to
6	believe is operating inconsistent with any provision of Section 2-
7	303 or 2-304 of this title or otherwise, where there has been a
8	violation of any federal law, any rule or regulation of the Drug
9	Enforcement Administration, any provision of the Uniform Controlled
10	Dangerous Substances Act, or any rules or regulations of the
11	Oklahoma State Bureau of Narcotics and Dangerous Drugs Control. The
12	provisions of this subsection shall not apply to a violation of
13	federal law regarding marijuana or any rule or regulation of the
14	Drug Enforcement Administration regarding marijuana.
15	B. The written order shall state with specificity the nature of
16	the violation or basis for the action. The Director may impose any
17	disciplinary action authorized by the Uniform Controlled Dangerous
18	Substances Act or rules of the Bureau including, but not limited to,
19	the assessment of monetary penalties.
20	C. Any written order issued pursuant to the provisions of this
21	section shall become a final order unless the registrant requests an
22	administrative hearing in accordance with the rules and regulations
23	promulgated by the Director within thirty (30) days of issuance.
24	Upon such request, the Director shall promptly initiate

1 administrative proceedings and serve formal notice of said proceedings pursuant to Section 309 of Title 75 of the Oklahoma 2 Statutes. Nothing in this section shall be construed so as to 3 require an individual proceeding for the denial of a new application 4 5 for registration. The Director may authorize the Deputy Director or the 6 D. general counsel of the Bureau to initiate any individual proceedings 7 under this title. Nothing in this section shall be construed so as 8 9 to delegate the authority of the Director to issue a final agency 10 order adverse to a party. E. 1. All proceedings shall be conducted in accordance with 11 12 the Administrative Procedures Act and the rules and regulations of the Bureau without regard to any criminal prosecution or other 13 proceeding. Proceedings to refuse renewal of, revoke, or suspend a 14 registration shall not abate the existing registration which shall 15 remain in effect pending the outcome of the administrative hearing 16 proceedings. 17 B. The This abatement shall not apply when the Director shall 18 suspend, without an order to show cause, any registration 19 simultaneously with the institution of proceedings under Section 2-20 304 of this title, if he or she finds there is an imminent danger to 21 the public health or safety which warrants this action. The 22 requiring an immediate suspension shall continue in effect until the 23 conclusion of the proceedings, including judicial review thereof, 24

1 unless sooner withdrawn by the Director or dissolved by a court of 2 competent jurisdiction.

3 <u>2. The Director may delegate to an administrative hearing</u>
4 <u>officer the authority to conduct hearings and recommend action for</u>
5 <u>final agency orders in accordance with the rules and regulations of</u>
6 the Bureau.

F. The Director may issue an order immediately suspending a 7 registration, without notice or a hearing, when he or she finds 8 9 there is imminent danger to the public health or safety which warrants this action. The suspension shall continue in effect until 10 the conclusion of any administrative proceedings, including judicial 11 12 review thereof, unless sooner withdrawn by the Director or dissolved by a court of competent jurisdiction. The order shall state the 13 existence of an emergency requiring action be taken that the 14 Director deems necessary to meet the emergency. Such action may 15 include, but is not limited to, ordering the registrant to 16 17 immediately cease and desist operations. The order shall be effective immediately upon issuance. Any person to whom the order 18 is directed shall comply immediately with the provisions of the 19 order. The Director may assess a penalty not to exceed Ten Thousand 20 Dollars (\$10,000.00) per day of noncompliance with the order. In 21 assessing such a penalty, the Director shall consider the 22 seriousness of the violation and any efforts to comply with 23 applicable requirements. Upon application to the Director, the 24

1	registrant shall be offered a hearing within thirty (30) days of the
2	issuance of the order.
3	G. 1. In lieu of, or in addition to any other remedies
4	available to the Director, if a finding is made that a registrant
5	has committed any act in violation of federal law relating to any
6	controlled dangerous substance, any provision of the Uniform
7	Controlled Dangerous Substances Act, or any rules of the Bureau, the
8	Director is hereby authorized to assess an administrative penalty
9	not to exceed Five Thousand Dollars (\$5,000.00) per day for each
10	such act. The provisions of this subsection shall not apply to
11	violations of subsection G of Section 2-309D of this title. Nothing
12	in this section shall be construed so as to permit the Director of
13	the Bureau to assess administrative fines for violations of the
14	provisions of subsection G of Section 2-309D of this title.
15	2. If a judge of competent jurisdiction finds probable cause
16	that a registrant has possessed, transferred, sold, or offered for
17	sale any controlled dangerous substance in violation of the Uniform
18	Controlled Dangerous Substances Act, any controlled dangerous
19	substance in Schedule I of Section 2-204 of this title, and any
20	controlled dangerous substance in Schedules II, III, IV, and V that
21	is not in properly labeled containers in accordance with the Uniform
22	Controlled Dangerous Substances Act then in the possession of the
23	registrant, shall be deemed contraband and shall be seized and
24	summarily forfeited pursuant to Section 2-505 of this title.

1 Samples shall be retained of all controlled dangerous substances seized in accordance with Section 2-508 of this title as required. 2 The Director is authorized to assess an eradication or destruction 3 4 fine not to exceed Fifty Thousand Dollars (\$50,000.00) against the 5 registrant. H. Upon an annulment, revocation, or denial of a registration, 6 the Director may prohibit the registrant or applicant from 7 reapplying for registration for a period up to five (5) years 8 9 following the date of the final order. The length of any 10 prohibition shall not be used as grounds to contest the validity of the annulment, revocation, or denial of a registration. 11 12 SECTION 3. AMENDATORY 63 O.S. 2021, Section 2-325, is amended to read as follows: 13 Section 2-325. A. A license or permit, obtained pursuant to 14 Sections 5 Section 2-323 or 6 2-324 of this act title, shall be 15 denied annulled, suspended, or revoked by the Director upon finding 16 that the licensee or permit holder has: 17 1. Materially falsified any application filed pursuant to this 18 act or required by this act; 19 2. Been convicted of a misdemeanor relating to any precursor 20 substance defined in Section 4 2-322 of this act title or any felony 21 under the laws of this state or the United States; or 22 3. Failed to maintain effective controls against the diversion 23 24 of said precursors to unauthorized persons or entities.

B. Before denying annulling, suspending, or revoking a license 1 2 or permit, the Director shall cause to be served upon the applicant, licensee, or permit holder an order to show cause why a license or a 3 permit should not be denied annulled, suspended, or revoked. 4 The 5 order to show cause shall contain a statement of the basis therefor and shall call upon the  $\frac{applicant_{T}}{dr}$  licensee or permit holder to 6 appear before the appropriate person or agency at the time and place 7 within thirty (30) sixty (60) days after the date of service of the 8 9 order. The proceedings shall be conducted in accordance with the Administrative Procedures Act without regard to any criminal 10 prosecution or other proceeding. Nothing in this section shall be 11 construed so as to require an individual proceeding for the denial 12 of a new license or permit. 13

С. The Director shall suspend, without an order to show cause, 14 any license or permit simultaneously with the institution of 15 proceedings described in subsection B of this section if he the 16 Director finds there is imminent danger to the public health or 17 safety which warrants this action. The suspension shall continue in 18 effect until the conclusion of the proceedings, including judicial 19 review thereof, unless withdrawn by the Director or dissolved by a 20 court of competent jurisdiction. 21

22 SECTION 4. It being immediately necessary for the preservation 23 of the public peace, health or safety, an emergency is hereby
