7	An Act relating to motor vehicles; amending 47 O.S. 2011, Sections 1102, as last amended by Section 1,
8	Chapter 57, O.S.L. 2016, 1113, as last amended by Section 4, Chapter 208, O.S.L. 2018, 1115.3, 1132, as
9	amended by Section 2, Chapter 337, O.S.L. 2012, 1134 and 1141.1, as amended by Section 4, Chapter 158,
10	O.S.L. 2012 (47 O.S. Supp. 2020, Sections 1102, 1113, 1132 and 1141.1), which relate to the Oklahoma
11	Vehicle License and Registration Act; defining and modifying terms; providing for one-time registration
12	of noncommercial trailers; establishing fee for registration of noncommercial trailers and providing
13	for apportionment; establishing registration requirement and fee for transfer of ownership of
14	noncommercial trailer; providing for penalty for failure to register; clarifying applicability of
15	certain fees; requiring certain noncommercial trailers for farm-related use to be registered;
16	providing for retention of certain fees by motor license agents; repealing 47 O.S. 2011, Section
17	1133.3, which relates to the optional registration of noncommercial trailers; and providing an effective
18	date.

22	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 2011, Section 1102, as
 last amended by Section 1, Chapter 57, O.S.L. 2016 (47 O.S. Supp.
 2020, Section 1102), is amended to read as follows:

4 Section 1102. As used in the Oklahoma Vehicle License and 5 Registration Act:

1. "All-terrain vehicle" means a vehicle manufactured and used
exclusively for off-highway use traveling on four or more nonhighway tires, and being fifty (50) inches or less in width;

9 2. "Carrying capacity" means the carrying capacity of a vehicle 10 as determined or declared in tons of cargo or payload by the owner; 11 provided, that such declared capacity shall not be less than the 12 minimum tonnage capacity fixed, listed or advertised by the 13 manufacturer of any vehicle;

14 3. "Certificate of title" means a document which is proof of 15 legal ownership of a motor vehicle as described and provided for in 16 Section 1105 of this title;

17 4. "Chips and oil" or the term "road oil and crushed rock" 18 means, with respect to materials authorized for use in the surfacing 19 of roads or highways in this title or in any equivalent statute 20 pertaining to road or highway surfacing in the State of Oklahoma, 21 any asphaltic materials. Wherever chips and oil or road oil and 22 crushed rock are authorized for use in the surfacing of roads or 23 highways in this state, whether by the Department of Transportation, 24 or by the county commissioners, or other road building authority

1 subject to the Oklahoma Vehicle License and Registration Act,
2 asphaltic materials are also authorized for use in such surfacing
3 and construction;

4 5. "Combined laden weight" means the weight of a truck or
5 station wagon and its cargo or payload transported thereon, or the
6 weight of a truck or truck-tractor plus the weight of any trailers
7 or semitrailers together with the cargo or payload transported
8 thereon;

9 6. "Commercial trailer" means any trailer, as defined in 10 Section 1-180 of this title, or semitrailer, as defined in Section 11 1-162 of this title, when such trailer or semitrailer is used 12 primarily for business or commercial purposes;

13 7. "Commercial trailer dealer" means any person, firm or
14 corporation engaged in the business of selling any new and unused,
15 or used, or both new and used commercial trailers;

16 8. "Commercial vehicle" means any vehicle over eight thousand 17 (8,000) pounds combined laden weight used primarily for business or 18 commercial purposes. Each motor vehicle being registered pursuant 19 to the provisions of this section shall have the name of the commercial establishment or the words "Commercial Vehicle" 20 21 permanently and prominently displayed upon the outside of the 22 vehicle in letters not less than two (2) inches high. Such letters 23 shall be in sharp contrast to the background and shall be of 24 sufficient shape and color as to be readily legible during daylight

1 hours, from a distance of fifty (50) feet while the vehicle is not 2 in motion;

3 9. "Commission" or "Tax Commission" means the Oklahoma Tax4 Commission;

5 10. "Construction machinery" means machines or devices drawn as 6 trailers which are designed and used for construction, tree trimming 7 and waste maintenance projects, which derive no revenue from the 8 transportation of persons or property, whose use of the highway is 9 only incidental and which are not mounted or affixed to another 10 vehicle; provided, construction machinery shall not include 11 implements of husbandry as defined in Section 1-125 of this title;

12 11. "Dealer" means any person, firm, association, corporation 13 or trust who sells, solicits or advertises the sale of new and 14 unused motor vehicles and holds a bona fide contract or franchise in 15 effect with a manufacturer or distributor of a particular make of 16 new or unused motor vehicle or vehicles for the sale of same;

17 12. "Mini-truck" means a foreign-manufactured import or 18 domestic-manufactured vehicle powered by an internal combustion 19 engine with a piston or rotor displacement of one thousand cubic 20 centimeters (1,000 cu cm) or less, which is sixty-seven (67) inches 21 or less in width, with an unladen dry weight of three thousand four 22 hundred (3,400) pounds or less, traveling on four or more tires, 23 having a top speed of approximately fifty-five (55) miles per hour,

1 equipped with a bed or compartment for hauling, and having an 2 enclosed passenger cab;

3 13. "Interstate commerce" means any commerce moving between any 4 place in a state and any place in another state or between places in 5 the same state through another state;

6 14. "Laden weight" means the combined weight of a vehicle when 7 fully equipped for use and the cargo or payload transported thereon; 8 provided, that in no event shall the laden weight be less than the 9 unladen weight of the vehicle fully equipped for use, plus the 10 manufacturer's rated carrying capacity;

11 15. "Local authorities" means every county, municipality or 12 local board or body having authority to adopt police regulations 13 under the Constitution and laws of this state;

14 16. "Low-speed electrical vehicle" means any four-wheeled 15 electrical vehicle that is powered by an electric motor that draws 16 current from rechargeable storage batteries or other sources of 17 electrical current and whose top speed is greater than twenty (20) 18 miles per hour but not greater than twenty-five (25) miles per hour 19 and is manufactured in compliance with the National Highway Traffic 20 Safety Administration standards for low-speed vehicles in 49 C.F.R. 21 571.500;

17. "Manufactured home" means a residential dwelling built in accordance with the National Manufactured Housing Construction and Safety Standards Act of 1974, 42 U.S.C., Section 5401 et seq., and

1 rules promulgated pursuant thereto and the rules promulgated by the 2 Oklahoma Used Motor Vehicle and Parts Commission pursuant to Section 3 582 of this title. Manufactured home shall not mean a park model 4 recreational vehicle as defined in this section;

5 18. "Manufactured home dealer" means any person, firm or corporation engaged in the business of selling any new and unused, 6 7 or used, or both new and used manufactured homes. Such information and a valid franchise letter as proof of authorization to sell any 8 9 such new manufactured home product line or lines shall be attached 10 to the application for a dealer license to sell manufactured homes. "Manufactured home dealer" shall not include any person, firm or 11 12 corporation who sells or contracts for the sale of the dealer's own 13 personally titled manufactured home or homes. No person, firm or 14 corporation shall be considered a manufactured home dealer as to any 15 manufactured home purchased or acquired by such person, firm or 16 corporation for purposes other than resale; provided, that the 17 restriction set forth in this sentence shall not prevent an 18 otherwise qualified person, firm or corporation from utilizing a 19 single manufactured home as a sales office;

19. "Medium-speed electrical vehicle" means any self-propelled, electrically powered four-wheeled motor vehicle, equipped with a roll cage or crush-proof body design, whose speed attainable in one (1) mile is more than thirty (30) miles per hour but not greater than thirty-five (35) miles per hour;

20. "Motor license agent" means any person appointed,
 designated or authorized by the Oklahoma Tax Commission to collect
 the fees and to enforce the provisions provided for in the Oklahoma
 Vehicle License and Registration Act;

5 21. "New vehicle" or "unused vehicle" means a vehicle which has 6 been in the possession of the manufacturer, distributor or 7 wholesaler or has been sold only by the manufacturer, distributor or 8 wholesaler to a dealer;

9 22. <u>"Noncommercial trailer" means a trailer not used for</u>
10 business or commercial purposes;

11 <u>23.</u> "Nonresident" means any person who is not a resident of 12 this state;

13 23. 24. "Off-road motorcycle" means any motorcycle, as defined 14 in Section 1-135 of this title, when such motorcycle has been 15 manufactured for and used exclusively off roads, highways and any 16 other paved surfaces;

17 24. 25. "Owner" means any person owning, operating or 18 possessing any vehicle herein defined;

19 25. 26. "Park model recreational vehicle" means a vehicle that
20 is:

- a. designed and marketed as temporary living quarters for
 camping, recreational, seasonal or travel use,
- b. not permanently affixed to real property for use as apermanent dwelling,

1	c. built on a single chassis mounted on wheels with a
2	gross trailer area not exceeding four hundred (400)
3	square feet in the setup mode, and
4	d. certified by the manufacturer as complying with
5	standard A119.5 of the American National Standards
6	Institute, Inc.;
7	26. <u>27.</u> "Person" means any individual, copartner, joint
8	venture, association, corporation, limited liability company,
9	estate, trust, business trust, syndicate, the State of Oklahoma, or
10	any county, city, municipality, school district or other political
11	subdivision thereof, or any group or combination acting as a unit,
12	or any receiver appointed by the state or federal court;
13	27. 28. "Rebodied vehicle" means a vehicle:
14	a. which has been assembled using a new body or new major
15	component which is of the identical type as the
16	original vehicle and is licensed by the manufacturer
17	of the original vehicle and other original, new or
18	reconditioned parts. For purposes of this paragraph,
19	"new body or new major component" means a new body,
20	cab, frame, front end clip or rear end clip,
21	b. which is not a salvage, rebuilt, or junked vehicle as
22	defined by paragraph 1, 2, or 6 of subsection A of
23	Section 1105 of this title, and
24

c. for which the Tax Commission has assigned or will assign a new identifying number;

3 28. 29. "Recreational off-highway vehicle" means a vehicle
4 manufactured and used exclusively for off-highway use, traveling on
5 four or more non-highway tires, and being sixty-five (65) inches or
6 less in width;

7 29. 30. "Recreational vehicle" means every vehicle which is built on or permanently attached to a self-propelled motor chassis 8 9 or chassis cab which becomes an integral part of the completed 10 vehicle and is capable of being operated on the highways. In order 11 to qualify as a recreational vehicle pursuant to this paragraph such 12 vehicle shall be permanently constructed and equipped for human 13 habitation, having its own sleeping and kitchen facilities, 14 including permanently affixed cooking facilities, water tanks and 15 holding tank with permanent toilet facilities. Recreational vehicle 16 shall not include manufactured homes or any vehicle with portable 17 sleeping, toilet and kitchen facilities which are designed to be 18 removed from such vehicle. Recreational vehicle shall include park 19 model recreational vehicles as defined in this section;

20 <u>30. 31.</u> "Remanufactured vehicle" means a vehicle which has been 21 assembled by a vehicle remanufacturer using a new body and which may 22 include original, reconditioned, or remanufactured parts, and which 23 is not a salvage, rebuilt, or junked vehicle as defined by

1 paragraphs 1, 2, and 6, respectively, of subsection A of Section 2 1105 of this title;

3 31. 32. "Rental trailer" means all small or utility trailers or 4 semitrailers constructed and suitable for towing by a passenger 5 automobile and designed only for carrying property, when the 6 trailers or semitrailers are owned by, or are in the possession of, 7 any person engaged in renting or leasing such trailers or 8 semitrailers for intrastate or interstate use or combined intrastate 9 and interstate use;

10 32. 33. "Special mobilized machinery" means special purpose 11 machines or devices, either self-propelled or drawn as trailers or 12 semitrailers, which derive no revenue from the transportation of 13 persons or property, whose use of the highway is only incidental, 14 and whose useful revenue producing service is performed at 15 destinations in an area away from the traveled surface of an 16 established open highway;

17 33. 34. "State" means the State of Oklahoma;

18 <u>34.</u> <u>35.</u> "Station wagon" means any passenger vehicle which does 19 not have a separate luggage compartment or trunk and which does not 20 have open beds, and has one or more rear seats readily lifted out or 21 folded, whether same is called a station wagon or ranch wagon;

22 <u>35.</u> <u>36.</u> "Travel trailer" means any vehicular portable structure 23 built on a chassis, used as a temporary dwelling for travel, 24 recreational or vacational use, and, when factory-equipped for the

1 road, it shall have a body width not exceeding eight (8) feet and an 2 overall length not exceeding forty (40) feet, including the hitch or 3 coupling;

4 36. 37. "Travel trailer dealer" means any person, firm or 5 corporation engaged in the business of selling any new and unused, or used, or both new and used travel trailers. Such information and 6 7 a valid franchise letter as proof of authorization to sell any such new travel trailer product line or lines shall be attached to the 8 9 application for a dealer license to sell travel trailers. "Travel 10 trailer dealer" shall not include any person, firm or corporation 11 who sells or contracts for the sale of his or her own personally 12 titled travel trailer or trailers. No person, firm or corporation shall be considered as a travel trailer dealer as to any travel 13 14 trailer purchased or acquired by such person, firm or corporation 15 for purposes other than resale;

16 <u>37.</u> <u>38.</u> "Used motor vehicle dealer" means "used motor vehicle 17 dealer" as defined in Section 581 of this title;

18 <u>38. 39.</u> "Used vehicle" means any vehicle which has been sold, 19 bargained, exchanged or given away, or used to the extent that it 20 has become what is commonly known, and generally recognized, as a 21 "secondhand" vehicle. This shall also include any vehicle other 22 than a remanufactured vehicle, regardless of age, owned by any 23 person who is not a dealer;

1 <u>39. 40.</u> "Utility vehicle" means a vehicle powered by an 2 internal combustion engine, manufactured and used exclusively for 3 off-highway use, equipped with seating for two or more people and a 4 steering wheel, traveling on four or more wheels;

5 40. 41. "Vehicle" means any type of conveyance or device in, upon or by which a person or property is or may be transported from 6 7 one location to another upon the avenues of public access within the state. "Vehicle" does not include bicycles, trailers except travel 8 9 trailers and rental trailers, or implements of husbandry as defined 10 in Section 1-125 of this title which are self-propelled. All 11 implements of husbandry used as conveyances shall be required to 12 display the owner's driver license number or license plate number of 13 any vehicle owned by the owner of the implement of husbandry on the 14 rear of the implement in numbers not less than two (2) inches in 15 The use of the owner's Social Security number on the rear height. 16 of the implement of husbandry shall not be required; and

17 <u>41. 42.</u> "Vehicle remanufacturer" means a commercial entity
18 which assembles remanufactured vehicles.

SECTION 2. AMENDATORY 47 O.S. 2011, Section 1113, as last amended by Section 4, Chapter 208, O.S.L. 2018 (47 O.S. Supp. 2020, Section 1113), is amended to read as follows:

Section 1113. A. 1. Except for all-terrain vehicles, utility vehicles and motorcycles used exclusively off roads and highways, upon the filing of a registration application and the payment of the

1 fees provided for in the Oklahoma Vehicle License and Registration Act, the Oklahoma Tax Commission or Corporation Commission, as 2 3 applicable, shall assign to the vehicle described in the application 4 a distinctive number, and issue to the owner of the vehicle a 5 certificate of registration, one license plate and a yearly decal. The Oklahoma Tax Commission shall assign an all-terrain vehicle, 6 7 utility vehicle or motorcycle used exclusively off roads and highways a distinctive number and issue to the owner a certificate 8 9 of registration and a decal but not a license plate. For each 10 subsequent registration year, the Tax Commission shall issue a 11 yearly decal to be affixed to the license plate, except for an all-12 terrain vehicle, utility vehicle or motorcycle used exclusively off 13 roads and highways. The initial decal for an all-terrain vehicle, 14 utility vehicle or motorcycle shall be attached to the front of the 15 vehicle and shall be in clear view. The decal shall be on the front 16 or on the front fork of the motorcycle used exclusively off roads 17 and highways and the decal shall be in clear view. The yearly decal 18 shall have an identification number and the last two numbers of the 19 registration year for which it shall expire. Except as provided by 20 Section 1113A of this title, the license plate shall be affixed to 21 the exterior of the vehicle until a replacement license plate is 22 applied for. If the owner applies for a replacement license plate, 23 the Tax Commission shall charge the fee provided for in Section 1114 24 of this title. The yearly decal will validate the license plate for

1 each registration period other than the year the license plate is 2 issued. The license plate and decal shall be of such size, color, 3 design and numbering as the Tax Commission may direct. However, 4 yearly decals issued to the owner of a vehicle who has filed an 5 affidavit with the appropriate motor license agent in accordance with Section 7-607 of this title shall be a separate and distinct 6 7 color from all other decals issued under this section. Before the effective date of this act, the Tax Commission shall also issue a 8 9 monthly decal which shall include a two-letter abbreviation 10 corresponding to the county in which the vehicle is registered. The 11 Tax Commission shall issue all decals in the possession of the Tax Commission on the effective date of this act before issuing any 12 13 decals which do not contain the county abbreviation.

14 2. The license plate shall be securely attached to the rear of 15 the vehicle, except truck-tractor plates which shall be attached to 16 the front of the vehicle. The Tax Commission may, with the 17 concurrence of the Department of Public Safety, by Joint Rule, 18 change and direct the manner, place and location of display of any 19 vehicle license plate when such action is deemed in the public 20 interest. The license plate, decal and all letters and numbers 21 shall be clearly visible at all times. The operation of a vehicle 22 in this state, regardless of where such vehicle is registered, upon 23 which the license plate is covered, overlaid or otherwise screened

with any material, whether such material be clear, translucent,
 tinted or opaque, shall be a violation of this paragraph.

3 3. Upon payment of the annual registration fee provided in 4 Section 1133 of this title, the Tax Commission or Corporation 5 Commission, as applicable, or a motor license agent may issue a 6 permanent nonexpiring license plate to an owner of one hundred or 7 more commercial motor vehicles and for vehicles registered under the 8 provisions of Section 1120 of this title. Upon payment of the 9 annual registration fee, the Tax Commission or Corporation 10 Commission shall issue a certificate of registration that shall be 11 carried at all times in the vehicle for which it is issued. 12 Provided, if the registrant submits its application through electronic means, such qualified owners of one hundred or more 13 14 commercial motor vehicles, properly registered pursuant to the 15 provisions of Section 1133 of this title, may elect to receive a 16 permanent certificate of registration that shall be carried at all 17 times in the vehicle for which it is issued.

Every vehicle owned by an agency of this state shall be
 exempt from the payment of registration fees required by this title.
 Provided, such vehicle shall be registered and shall otherwise
 comply with the provisions of the Oklahoma Vehicle License and
 Registration Act.

B. The license plates required under the provisions of this title shall conform to the requirements and specifications listed hereinafter:

Each license plate shall have a space for the placement of
 the yearly decals for each succeeding year of registration after the
 initial issue;

7 2. The provisions of the Oklahoma Vehicle License and
8 Registration Act regarding the issuance of yearly decals shall not
9 apply to the issuance of apportioned license plates, including
10 license plates for state vehicles, and exempt plates for
11 governmental entities and fire departments organized pursuant to
12 Section 592 of Title 18 of the Oklahoma Statutes;

3. All license plates and decals shall be made with reflectorized material as a background to the letters, numbers and characters displayed thereon. The reflectorized material shall be of such a nature as to provide effective and dependable brightness during the service period for which the license plate or decal is issued;

4. Except as otherwise provided in this subsection, the Tax Commission shall design appropriate official license plates for all state vehicles. Such license plates shall be permanent in nature and designed in such manner as to remain with the vehicle for the duration of the vehicle's life span or until the title is transferred to a nongovernmental owner;

5. Within the limits prescribed in this section, the Tax
 Commission shall design appropriate official license plates for
 vehicles of the Oklahoma Highway Patrol. The license plates shall
 have the legend "Oklahoma OK" and shall contain the letters "OHP"
 followed by the state seal and the badge number of the Highway
 Patrol officer to whom the vehicle is assigned. The words "Oklahoma
 Highway Patrol" shall also be included on such license plates;

6. Within the limits prescribed in this section, the Tax
9 Commission shall design appropriate official license plates for
10 vehicles of the Oklahoma Military Department. Such license plates
11 shall have the legend "Oklahoma OK" and shall contain the letters
12 "OMD" followed by the state seal and three numbers or letters as
13 designated by the Adjutant General. The words "Oklahoma Military
14 Department" shall also be included on such license plates;

15 7. Within the limits prescribed in this section, the Tax 16 Commission shall design appropriate official license plates for 17 vehicles of the Oklahoma Department of Corrections. Such license 18 plates shall contain the letters "DOC" followed by the Department of 19 Corrections badge and three numbers or letters or combination of 20 both as designated by the Director of the agency. The words 21 "Department of Corrections" shall also be included on such license 22 plates; and

8. Within the limits prescribed in this section, the Oklahoma
Tourism and Recreation Department shall design any license plates

required by the initiation of a license plate reissuance by the
Oklahoma Tax Commission at the request of the Department of Public
Safety pursuant to the provisions of Section 1113.2 of this title.
Any such new designs shall be submitted by the Oklahoma Tourism and
Recreation Department to the Department of Public Safety for its
approval prior to being issued by the Oklahoma Tax Commission.

7 C. Where the applicant has satisfactorily shown that the applicant owns the vehicle sought to be registered but is unable to 8 9 produce documentary evidence of the ownership, a license plate may 10 be issued upon approval by the Tax Commission or Corporation 11 Commission, as applicable. In such instances the reason for not 12 issuing a certificate of title shall be indicated on the receipt 13 given to the applicant. It shall still be the duty of the applicant 14 to immediately take all necessary steps to obtain the Oklahoma 15 certificate of title and it shall be unlawful for the applicant to 16 sell the vehicle until the certificate has been obtained in the 17 applicant's name.

D. The certificate of registration provided for in this section shall be in convenient form, and the certificate of registration, or a certified copy or photostatic copy thereof, duly authenticated by the Tax Commission or Corporation Commission, as applicable, shall be carried at all times in or upon all vehicles so registered, in such manner as to permit a ready examination thereof upon demand by any peace officer of the state or duly authorized employee of the

1 Department of Public Safety. Any such officer or agent may seize 2 and hold such vehicle when the operator of the same does not have the registration certificate in the operator's possession or when 3 any such officer or agent determines that the registration 4 5 certificate has been obtained by misrepresentation of any essential or material fact or when any number or identifying information 6 7 appearing on such certificate has been changed, altered, obliterated or concealed in any way, until the proper registration or 8 9 identification of such vehicle has been made or produced by the 10 owner thereof.

11 Ε. The purchaser of a new or used manufactured home shall, 12 within thirty (30) days of the date of purchase, register the home 13 with the Tax Commission or a motor license agent pursuant to the 14 provisions of Section 1117 of this title. For a new manufactured 15 home, it shall be the responsibility of the dealer selling the home 16 to place a temporary license plate on the home in the same manner as 17 provided in Section 1128 of this title for other new motor vehicles. 18 For the first year that any manufactured home is registered in this 19 state, the Tax Commission shall issue a metal license plate which 20 shall be affixed to the manufactured home. The temporary dealer 21 license plate or the metal license plate shall be displayed on the 22 manufactured home at all times when upon a public roadway; provided, 23 a repossession affidavit issued pursuant to Sections 1110 and 1126 24 of this title shall be permissible in lieu of a current license

1 plate and decal for the purposes of removing a repossessed manufactured home to a secure location. Manufactured homes 2 3 previously registered and subject to ad valorem taxation as provided 4 by law shall have a decal affixed at the time ad valorem taxes are 5 paid for such manufactured home; provided, for a manufactured home permanently affixed to real estate, no decal or license plate shall 6 7 be required to be affixed and the owner thereof shall be given a receipt upon payment of ad valorem taxes due on the home. 8 The Tax 9 Commission shall make sufficient plates and decals available to the 10 various motor license agents of the state in order for an owner of a 11 manufactured home to acquire the plate or decal. A one-dollar fee 12 shall be charged for issuance of any plate or decal. The fee shall 13 be apportioned each month to the General Revenue Fund of the State 14 Treasury.

15 The decal shall be easily visible for purposes of F. 16 verification by a county assessor that the manufactured home is 17 properly assessed for ad valorem taxation. In the first year of 18 registration, a decal shall be issued for placement on the license 19 plate indicating payment of applicable registration fees and excise 20 taxes. A duplicate manufactured home registration decal shall be 21 affixed inside the window nearest the front door of the manufactured 22 home. In the second and all subsequent years for which the 23 manufactured home is subject to ad valorem taxation, an annual decal 24 shall be affixed inside the window nearest the front door as

evidence of payment of ad valorem taxes. The Tax Commission shall issue decals to the various county treasurers of the state in order for a manufactured home owner to obtain such decal each year. Upon presentation of a valid ad valorem tax receipt, the manufactured home owner shall be issued the annual decal.

G. Upon the registration of a manufactured home in this state
for the first time or upon discovery of a manufactured home
previously registered within this state for which the information
required by this subsection is not known, the Tax Commission shall
obtain:

11 1. The name of the owner of the manufactured home;

The serial number or identification number of the
 manufactured home;

14 3. A legal description or address of the location for the home;
15 4. The actual retail selling price of the manufactured home
16 excluding Oklahoma taxes;

17 5. The certificate of title number for the home; and
18 6. Any other information which the Tax Commission deems to be
19 necessary.

The application for registration shall also include the school district in which the manufactured home is located or is to be located. The information shall be entered into a computer data system which shall be used by the Tax Commission to provide information to county assessors upon request by the assessor. The

assessor may request any information from the system in order to
 properly assess a manufactured home for ad valorem taxation.

3 H. Upon the filing of a registration application and the 4 payment of the fees provided for in Section 1132 of this title, the 5 Tax Commission shall assign to the noncommercial trailer described in the application and issue to the owner of the trailer a 6 7 nonexpiring certificate of registration and license plate. All noncommercial trailers shall be registered within thirty (30) days 8 9 of purchase or transfer of ownership or, if a noncommercial trailer 10 is not registered prior to the effective date of this act, within 11 thirty (30) days of the effective date of this act.

12SECTION 3.AMENDATORY47 O.S. 2011, Section 1115.3, is13amended to read as follows:

Section 1115.3 A. Except as otherwise provided by this section, all-terrain vehicles, utility vehicles and motorcycles used exclusively off roads or highways shall be registered once with the Oklahoma Tax Commission within thirty (30) days after purchase.

B. For all-terrain vehicles or motorcycles used exclusively off roads or highways purchased prior to July 1, 2005, registration, as otherwise required by Section 1115 of this title, shall not be required, but shall be allowed at the option of the owner of the all-terrain vehicle or motorcycle used exclusively off roads or highways.

C. For utility vehicles used exclusively off roads or highways
 purchased prior to July 1, 2008, registration, as otherwise required
 by Section 1115 of this title, shall not be required but shall be
 allowed at the option of the owner of the utility vehicle used
 exclusively off roads or highways.

D. All-terrain vehicles, utility vehicles or motorcycles used
exclusively off roads or highways owned or purchased by a person
that possesses an agricultural exemption pursuant to Section 1358.1
of Title 68 of the Oklahoma Statutes may be registered as provided
by this section, but shall not require registration.

11E. Noncommercial trailers shall be registered once with the12Oklahoma Tax Commission within thirty (30) days of purchase or13transfer of ownership or, if purchased or transferred before

14 November 1, 2021, by December 1, 2021.

SECTION 4. AMENDATORY 47 O.S. 2011, Section 1132, as amended by Section 2, Chapter 337, O.S.L. 2012 (47 O.S. Supp. 2020, Section 1132), is amended to read as follows:

Section 1132. A. For all vehicles, unless otherwise specifically provided by the Oklahoma Vehicle License and Registration Act, a registration fee shall be assessed at the time of initial registration by the owner and annually thereafter, for the use of the avenues of public access within this state in the following amounts:

For the first through the fourth year of registration in
 this state or any other state, Eighty-five Dollars (\$85.00);

Nine Dollars (\$9.00) of the registration 23 fee shall be deposited in the Oklahoma Tax Commission Reimbursement 24 Fund. Two Dollars (\$2.00) of the registration fee shall be retained

For utility vehicles used exclusively for use off roads or 5 highways purchased on or after July 1, 2008, and for utility vehicles used exclusively for use off roads or highways purchased 6 7 prior to July 1, 2008, which the owner chooses to register pursuant to the provisions of Section 1115.3 of this title, an initial and 8 9 nonrecurring registration fee of Eleven Dollars (\$11.00) shall be 10 assessed at the time of initial registration by the owner. Nine 11 Dollars (\$9.00) of the registration fee shall be deposited in the Oklahoma Tax Commission Reimbursement Fund. Two Dollars (\$2.00) of 12 13 the registration fee shall be retained by the motor license agent. 14 The fees required by subsection A of this section shall not be 15 required for utility vehicles used exclusively off roads and 16 highways.

D. For noncommercial trailers, a one-time registration fee of
Twenty-five Dollars (\$25.00) shall be assessed at the time of
registration by the owner. Registration revenue shall be
apportioned by the Oklahoma Tax Commission as provided in
subsections L through O of Section 1104 of this title.
<u>E.</u> There shall be a credit allowed with respect to the fee for

D. Before a party shall be allowed to purchase a license plate or claim an exception or exemption under this section, the party shall:

Show an income tax Schedule F for the preceding year; or
 Present a valid exemption card issued pursuant to the
