8                                   COMMITTEE SUBSTITUTE

9                   An Act relating to Oklahoma Historical Societies and  
10                   Associations; amending 53 O.S. 2011, Section 201B,  
11                   which relates to the J.M. Davis Memorial Commission;  
12                   modifying authority of the Commission; and declaring  
13                   an emergency.

15   BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16           SECTION 1.        AMENDATORY        53 O.S. 2011, Section 201B, is  
17   amended to read as follows:

18           Section 201B. The J.M. Davis Memorial Commission is authorized  
19   to:

20           1. Acquire and hold real estate or interest therein or personal  
21   property in the name of the Commission;

22           2. Act in cooperation and enter into contracts and agreements  
23   with the ~~J.M. Davis Foundation, Inc.~~ owner or owners of the J.M.

24   Davis Gun Collection;

1 3. Furnish suitable quarters to house, display and preserve the  
2 J.M. Davis Gun Collection and other historical artifacts;

3 4. In the administration of the J.M. Davis Gun Collection,  
4 maintain or lease to the ~~J.M. Davis Foundation, Inc.~~ owner or owners  
5 of the J.M. Davis Gun Collection, or to a third party, an outlet for  
6 the sale to the public of such items as shall, in the judgment of  
7 the Commission or the lessee, be appropriate for sale at prices set  
8 by the Commission, including, but not limited to, literature, in  
9 book or pamphlet form, brochures, periodicals, books, artifacts and  
10 statuary;

11 5. Accept gifts, grants and donations from governmental sources  
12 or any individual, person, firm, corporation or foundation for the  
13 use and purpose of building, constructing, operating, maintaining,  
14 preserving or displaying the J.M. Davis Gun Collection and other  
15 historical artifacts. The location of the display and other  
16 historical artifacts shall be within the city limits of Claremore,  
17 Oklahoma, in Rogers County. The site for the display of the J.M.  
18 Davis Gun Collection shall not be moved from its current location at  
19 333 North Lynn Riggs Boulevard, Claremore, Oklahoma, unless a  
20 declaratory judgment has first been issued by the District Court of  
21 Rogers County stating that any such relocation is in compliance with  
22 the lease dated April 25, 1967, between the J.M. Davis Foundation,  
23 Inc. and the J.M. Davis Memorial Commission; provided, the  
24 Commission may appeal any final declaratory judgment issued by the

1 district court authorizing or directing the relocation of the  
2 current location of the site to the Supreme Court within thirty (30)  
3 days of the filing of the declaratory judgment; and

4 6. Maintain donation receptacles for the purpose of the  
5 collection of voluntary donations to the J.M. Davis Memorial  
6 Commission and to the ~~J.M. Davis Foundation, Inc~~ owner or owners of  
7 the J.M. Davis Gun Collection. Funds donated to the J.M. Davis  
8 Memorial Commission shall be deposited into the J.M. Davis Memorial  
9 Commission Revolving Fund.

10 SECTION 2. It being immediately necessary for the preservation  
11 of the public peace, health or safety, an emergency is hereby  
12 declared to exist, by reason whereof this act shall take effect and  
13 be in full force from and after its passage and approval.
