An Act relating to certificates of need; repealing 63 O.S. 2021, Sections 1-880.1, 1-880.2, 1-880.3, 1-880.4, 1-880.5, 1-880.6, as amended by Section 1, Chapter 98, O.S.L. 2022, 1-880.7, 1-880.8, 1-880.9, 1-880.10, and 1-880.11 (63 O.S. Supp. 2023, Section 1-880.6), which relate to certificate of need for psychiatric and chemical dependency facilities; and declaring an emergency.

SUBJECT: Certificates of need

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. REPEALER 63 O.S. 2021, Sections 1-880.1, 1-880.2, 1-880.3, 1-880.4, 1-880.5, 1-880.6, as amended by Section 1, Chapter 98, O.S.L. 2022, 1-880.7, 1-880.8, 1-880.9, 1-880.10, and 1-880.11 (63 O.S. Supp. 2023, Section 1-880.6), are hereby repealed.

SECTION 2. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
