7 An Act relating to the Department of Human Services;
8 making appropriations; stating purposes; directing
9 certain transfers; establishing procedure; making
10 appropriations nonfiscal; making appropriations
11 exempt from certain agency category and budget
12 limits; and declaring an emergency.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. There is hereby appropriated to the Department of
15 Human Services from any monies not otherwise appropriated from the
16 Constitutional Reserve Fund of the State Treasury, the sum of Four
17 Million Two Hundred Three Thousand Five Hundred Two Dollars
18 (\$4,203,502.00) or so much thereof as may be necessary for the
19 Developmental Disabilities Services Division waivers.

20 SECTION 2. There is hereby appropriated to the Department of
21 Human Services from any monies not otherwise appropriated from the
22 Unclaimed Property Fund (711 Fund) of the State Treasury, the sum of
23 Eighteen Million Six Thousand Four Hundred Ninety-eight Dollars
24 (\$18,006,498.00) or so much thereof as may be necessary for the
Developmental Disabilities Services Division waivers.

1 SECTION 3. There is hereby appropriated to the Department of
2 Human Services from any monies not otherwise appropriated from the
3 Unclaimed Property Fund (711 Fund) of the State Treasury, the sum of
4 Eleven Million Seven Hundred Ninety Thousand Dollars
5 (\$11,790,000.00) or so much thereof as may be necessary for the
6 Aging Services Division waivers.

7 SECTION 4. The Director of the Office of Management and
8 Enterprise Services shall transfer monies appropriated in this act
9 from the Constitutional Reserve Fund and Unclaimed Property Fund to
10 the Department of Human Services' disbursing funds in the amounts
11 and ratios requested by the agency; provided, that the cumulative
12 amounts transferred shall not exceed the amounts of the
13 appropriations from the Constitutional Reserve Fund and Unclaimed
14 Property Fund.

15 SECTION 5. The appropriations made by this act shall not be
16 subject to fiscal year limitations and shall be available for
17 encumbrance and expenditure purposes for a period of thirty (30)
18 months from the date this act is approved.

19 SECTION 6. The appropriations made by this act shall not be
20 subject to fiscal years 2017 and 2018 agency category and budget
21 limits.

22 SECTION 7. It being immediately necessary for the preservation
23 of the public peace, health or safety, an emergency is hereby
24

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
