C. The Commission shall study, evaluate and make
 recommendations for any changes to state policy, rules or statutes
 to better combat opioid abuse in Oklahoma.

D. The Commission shall prepare and issue a report of its
findings and recommendations to the Governor, President Pro Tempore
of the Senate and the Speaker of the House of Representatives by
December 31, 2019, and each year thereafter no later than the 31st
day of December.

9 E. Members of the Commission shall receive no compensation for 10 serving on the Commission, but shall receive travel reimbursement as 11 follows:

State employees who are members of the Commission shall be
 reimbursed for necessary travel expenses incurred in the performance
 of their duties by their respective agencies in accordance with the
 State Travel Reimbursement Act;

16 2. Legislative members of the Commission shall be reimbursed 17 for necessary travel expenses incurred in the performance of their 18 duties in accordance with the provisions of Section 456 of Title 74 19 of the Oklahoma Statutes; and

3. All other members of the Commission shall be reimbursed by
the Office of Management and Enterprise Services for necessary
travel expenses incurred in the performance of their duties in
accordance with the State Travel Reimbursement Act.
