1 1. DISCOVERY METHODS. Parties may obtain discovery regarding 2 any matter that is relevant to any party's claim or defense by one or more of the following methods: Depositions upon oral examination 3 4 or written questions; written interrogatories; production of 5 documents or things or permission to enter upon land or other property, for inspection and other purposes; physical and mental 6 7 examinations; requests for admission; authorizations for release of records; and otherwise by court order upon showing of good cause. 8 9 Except as provided in this section or unless the court orders 10 otherwise under this section, the frequency of use of these methods is not limited. 11

2. INITIAL DISCLOSURES.

13 a. Except in categories of proceedings specified in 14 subparagraph b of this paragraph, or to the extent 15 otherwise stipulated or directed by order, a party, 16 without awaiting a discovery request, shall provide to 17 other parties a computation of any category of damages 18 claimed by the disclosing party, making available for 19 inspection and copying the documents or other 20 evidentiary material, not privileged or protected from 21 disclosure, on which such computation is based, 22 including materials bearing on the nature and extent 23 of injuries suffered. Subject to subsection B of this 24 section, in any action in which physical or mental

injury is claimed, the party making the claim shall provide to the other parties a release or authorization allowing the parties to obtain relevant medical records and bills, and, when relevant, a release or authorization for employment and scholastic records.

 - (1) an action for review of an administrative record,
 - (2) a petition for habeas corpus or other proceeding to challenge a criminal conviction or sentence,
 - (3) an action brought without counsel by a person in custody of the United States, a state, or a state subdivision,
 - (4) an action to enforce or quash an administrative summons or subpoena,
- (5) an action by the United States to recover benefit payments,
- 20 (6) an action by the United States to collect on a
 21 student loan guaranteed by the United States,
 - (7) a proceeding ancillary to proceedings in other courts, and
- 24 (8) an action to enforce an arbitration award.

1 Disclosures required under this paragraph shall be с. 2 made at or within sixty (60) days after service unless a different time is set by stipulation or court order, 3 4 or unless a party objects that initial disclosures are 5 not appropriate in the circumstances of the action and states the objection in a motion filed with the court. 6 7 In ruling on the objection, the court shall determine what disclosures, if any, are to be made and set the 8 9 time for disclosure. A party shall make its initial 10 disclosures based on the information then readily 11 available to it and is not excused from making its 12 disclosures because it has not fully completed its 13 investigation of the case or because it challenges the 14 sufficiency of another party's disclosures or because 15 another party has not made its disclosures.

B. DISCOVERY SCOPE AND LIMITS. Unless otherwise limited by order of the court in accordance with the Oklahoma Discovery Code, the scope of discovery is as follows:

21 privileged, which is relevant to any party's claim or
22 defense, reasonably calculated to lead to the

the issues at stake in the action, the amount in controversy, the parties' relative access to relevant information, the parties' resources, the importance of the discovery in resolving the issues, and whether the burden or expense of the proposed discovery outweighs its likely benefit. Information within this scope of discovery need not be admissible in evidence to be discoverable.

- 9 b. A party shall produce upon request pursuant to Section 3234 of this title, any insurance agreement under 10 11 which any person carrying on an insurance business may 12 be liable to satisfy part or all of a judgment which 13 may be entered in the action or to indemnify or 14 reimburse for payments made to satisfy the judgment. 15 Information concerning the insurance agreement is not 16 by reason of disclosure admissible in evidence at 17 trial. For purposes of this section, an application 18 for insurance shall not be treated as a part of an 19 insurance agreement.
- 20c.A party shall produce upon request pursuant to Section213234 of this title, any commercial litigation funding22agreement as defined in Section 2 of this act.23Information related to the commercial litigation24funding agreement is not by reason of disclosure

If information produced in discovery is subject to a 2 claim of privilege or of protection as trial preparation material, the party making the claim may 3 notify any party that received the information of the 4 5 claim and the basis for it. After being notified, a party shall promptly return, sequester, or destroy the 6 7 specified information and any copies the party has; shall not use or disclose the information until the 8 9 claim is resolved; shall take reasonable steps to retrieve the information if the party has disclosed it 10 11 before being notified; and may promptly present the 12 information to the court under seal for a 13 determination of the claim. dispute without court action, and for good cause shown, the court in which the action is pending or on matters relating to a deposition, the district court in the county where the deposition is to be taken may enter any order which justice requires to protect a party or person from annoyance, harassment, embarrassment, oppression or undue delay, burden or expense, including one or more of the following:

- 9 b. that the discovery may be had only on specified terms
 10 and conditions, including a designation of the time,
 11 place or the allocation of expenses,
- 12 c. that the discovery may be had only by a method of
 13 discovery other than that selected by the party

- d. that certain matters not be inquired into, or that the
 scope of the disclosure or discovery be limited to
 certain matters,
- e. that discovery be conducted with no one present except
 persons designated by the court,
- f. that a deposition after being sealed be opened only by
 order of the court,
- g. that a trade secret or other confidential research,
 development or commercial information not be disclosed
 or be disclosed only in a designated way, and

h. that the parties simultaneously file specified
 documents or information enclosed in sealed envelopes
 to be opened as directed by the court.

4 2. If the motion for a protective order is denied in whole or 5 in part, the court may, on such terms and conditions as are just, order that any party or person provide or permit discovery. 6 The 7 provisions of paragraph 4 of subsection A of Section 3237 of this title apply to the award of expenses incurred in relation to the 8 9 motion. Any protective order of the court which has the effect of 10 removing any material obtained by discovery from the public record shall contain the following: 11

- a. a statement that the court has determined it is
 necessary in the interests of justice to remove the
 material from the public record,
- b. specific identification of the material which is to be
 removed or withdrawn from the public record, or which
 is to be filed but not placed in the public record,
 and
- c. a requirement that any party obtaining a protective
 order place the protected material in a sealed manila
 envelope clearly marked with the caption and case
 number and is clearly marked with the word
 "CONFIDENTIAL", and stating the date the order was
 entered and the name of the judge entering the order.

9 4. The party or counsel which has received the protective order 10 shall be responsible for promptly presenting the order to 11 appropriate court clerk personnel for appropriate action.

12 5. All documents produced or testimony given under a protective 13 order shall be retained in the office of counsel until required by 14 the court to be filed in the case.

6. Counsel for the respective parties shall be responsible for

When a case is filed in which a party intends to seek a 19 protective order removing material from the public record, the 20 plaintiff(s) and defendant(s) shall be initially designated on the 21 petition under pseudonym such as "John or Jane Doe", or "Roe", and 22 the petition shall clearly indicate that the party designations are 23 fictitious. The party seeking confidentiality or other order 24 removing the case, in whole or in part, from the public record,

shall immediately present application to the court, seeking

D. SEQUENCE AND TIMING OF DISCOVERY. Unless the parties
stipulate or the court orders otherwise for the convenience of
parties and witnesses and in the interests of justice, methods of
discovery may be used in any sequence. The fact that a party is
conducting discovery, whether by deposition or otherwise, shall not
operate to delay discovery by any other party.

E. SUPPLEMENTATION OF RESPONSES. A party who has responded to a request for discovery with a response that was complete when it was made is under no duty to supplement the response to include information thereafter acquired, except as follows:

A party is under a duty seasonably to supplement the
 response with respect to any question directly addressed to:

- a. the identity and location of persons having knowledge
 of discoverable matters, and
- b. the identity of each person expected to be called as
 an expert witness at trial, the subject matter on
 which the person is expected to testify, and the
 substance of the testimony of the person;

22 2. A party is under a duty seasonably to amend a prior response
23 to an interrogatory, request for production, or request for
24 admission if the party obtains information upon the basis of which:

12	F. DISCOVERY CONFERENCE. At any time after commencement of an
13	action, the court may direct the attorneys for the parties to appear
14	for a conference on the subject of discovery. The court shall do so
15	upon motion by the attorney for any party if the motion includes:
16	1. A statement of the issues as they then appear;
17	2. A proposed plan and schedule of discovery;
18	3. Any limitations proposed to be placed on discovery;
19	4. Any other proposed orders with respect to discovery; and
20	5. A statement showing that the attorney making the motion has
21	made a reasonable effort to reach agreement with opposing attorneys
22	on the matters set forth in the motion.
23	Each party and his attorney are under a duty to participate in

24 good faith in the framing of a discovery plan if a plan is proposed

by the attorney for any party. Notice of the motion shall be served on all parties. Objections or additions to matters set forth in the motion shall be served not later than ten (10) days after service of the motion.

5 Following the discovery conference, the court shall enter an order tentatively identifying the issues for discovery purposes, 6 7 establishing a plan and schedule for discovery, setting limitations on discovery, if any; and determining such other matters, including 8 9 the allocation of expenses, as are necessary for the proper management of discovery in the action. In preparing the plan for 10 discovery the court shall protect the parties from excessive or 11 12 abusive use of discovery. An order shall be altered or amended whenever justice so requires. 13

Subject to the right of a party who properly moves for a discovery conference to prompt convening of the conference, the court may combine the discovery conference with a pretrial conference.

G. SIGNING OF DISCOVERY REQUESTS, RESPONSES AND OBJECTIONS. Every request for discovery, response or objection thereto made by a party represented by an attorney shall be signed by at least one of the party's attorneys of record in the party's individual name whose address shall be stated. A party who is not represented by an attorney shall sign the request, response or objection and state the party's address. The signature of the attorney or party constitutes

1 a certification that the party has read the request, response or 2 objection, and that it is:

3 1. To the best of the party's knowledge, information and belief 4 formed after a reasonable inquiry consistent with the Oklahoma 5 Discovery Code and warranted by existing law or a good faith 6 argument for the extension, modification or reversal of existing 7 law;

8 2. Interposed in good faith and not primarily to cause delay or9 for any other improper purpose; and

Not unreasonable or unduly burdensome or expensive, given the nature and complexity of the case, the discovery already had in the case, the amount in controversy, and other values at stake in the litigation. If a request, response or objection is not signed, it shall be deemed ineffective.

15 If a certification is made in violation of the provisions of 16 this subsection, the court, upon motion or upon its own initiative, 17 shall impose upon the person who made the certification, the party 18 on whose behalf the request, response or objection is made, or both, 19 an appropriate sanction, which may include an order to pay to the 20 amount of the reasonable expenses occasioned thereby, including a 21 reasonable attorney fee.

22 SECTION 2. NEW LAW A new section of law to be codified 23 in the Oklahoma Statutes as Section 3226.2 of Title 12, unless there 24 is created a duplication in numbering, reads as follows:

B. DISCOVERY SCOPE AND LIMITS. Unless otherwise limited by

After being notified, a 14 party shall promptly return, sequester, or destroy the 15 specified information and any copies the party has; 16 shall not use or disclose the information until the 17 claim is resolved; shall take reasonable steps to 18 retrieve the information if the party has disclosed it 19 before being notified; and may promptly present the 20 information to the court under seal for a 21 determination of the claim. The producing party shall 22 preserve the information until the claim is resolved. 23 This mechanism is procedural only and does not alter 24 the standards governing whether the information is

C. PROTECTIVE ORDERS.

5 1. Upon motion by a party or by the person from whom discovery is sought, accompanied by a certification that the movant has in 6 7 good faith conferred or attempted to confer, either in person or by telephone, with other affected parties in an effort to resolve the 8 9 dispute without court action, and for good cause shown, the court in 10 which the action is pending or on matters relating to a deposition, 11 the district court in the county where the deposition is to be taken 12 may enter any order which justice requires to protect a party or 13 person from annoyance, harassment, embarrassment, oppression or 14 undue delay, burden or expense, including one or more of the 15 following:

a. that the discovery not be had,

b. that the discovery may be had only on specified terms
and conditions, including a designation of the time,
place or the allocation of expenses,

c. that the discovery may be had only by a method of
discovery other than that selected by the party
seeking discovery,

- d. that certain matters not be inquired into, or that the
 scope of the disclosure or discovery be limited to
 certain matters,
- 4 e. that discovery be conducted with no one present except
 5 persons designated by the court,
- f. that a deposition after being sealed be opened only by

- g. that a trade secret or other confidential research,
 development or commercial information not be disclosed
 or be disclosed only in a designated way, and
- h. that the parties simultaneously file specified
 documents or information enclosed in sealed envelopes
 to be opened as directed by the court.

14 2. If the motion for a protective order is denied in whole or 15 in part, the court may, on such terms and conditions as are just, 16 order that any party or person provide or permit discovery. The 17 provisions of paragraph 4 of subsection A of Section 3237 of this 18 title apply to the award of expenses incurred in relation to the 19 motion. Any protective order of the court which has the effect of 20 removing any material obtained by discovery from the public record 21 shall contain the following:

a. a statement that the court has determined it is

When a case is filed in which a party intends to seek a 5 protective order removing material from the public record, the plaintiff(s) and defendant(s) shall be initially designated on the 6 7 petition under pseudonym such as "John or Jane Doe", or "Roe", and the petition shall clearly indicate that the party designations are 8 9 fictitious. The party seeking confidentiality or other order 10 removing the case, in whole or in part, from the public record, 11 shall immediately present application to the court, seeking 12 instructions for the conduct of the case, including confidentiality 13 of the records.

D. SEQUENCE AND TIMING OF DISCOVERY. Unless the parties stipulate or the court orders otherwise for the convenience of parties and witnesses and in the interests of justice, methods of discovery may be used in any sequence. The fact that a party is conducting discovery, whether by deposition or otherwise, shall not operate to delay discovery by any other party.

E. SUPPLEMENTATION OF RESPONSES. A party who has responded to a request for discovery with a response that was complete when it was made is under no duty to supplement the response to include information thereafter acquired, except as follows:

1 1. A party is under a duty seasonably to supplement the 2 response with respect to any question directly addressed to: the identity and location of persons having knowledge 3 a. of discoverable matters, and 4 5 b. the identity of each person expected to be called as an expert witness at trial, the subject matter on 6 7 which the person is expected to testify, and the substance of the testimony of the person; 8 9 2. A party is under a duty seasonably to amend a prior response to an interrogatory, request for production, or request for 10 11 admission if the party obtains information upon the basis of which: (1) the party knows that the response was incorrect 12 a. 13 in some material respect when made, or 14 the party knows that the response, which was (2)15 correct when made, is no longer true in some 16 material respect, and 17 b. the additional or corrective information has not 18 otherwise been made known to the other parties during 19 the discovery process or in writing; and 20 3. A duty to supplement responses may be imposed by order of 21 the court, agreement of the parties, or at any time prior to trial 22 through new requests for supplementation of prior responses. 23 DISCOVERY CONFERENCE. At any time after commencement of an F. 24 action, the court may direct the attorneys for the parties to appear

1 for a conference on the subject of discovery. The court shall do so upon motion by the attorney for any party if the motion includes: 2 A statement of the issues as they then appear; 3 1. 4 2. A proposed plan and schedule of discovery; 5 3. Any limitations proposed to be placed on discovery; Any other proposed orders with respect to discovery; and 6 4. 7 A statement showing that the attorney making the motion has 5. made a reasonable effort to reach agreement with opposing attorneys 8 9 on the matters set forth in the motion.

Each party and his attorney are under a duty to participate in good faith in the framing of a discovery plan if a plan is proposed by the attorney for any party. Notice of the motion shall be served on all parties. Objections or additions to matters set forth in the motion shall be served not later than ten (10) days after service of the motion.

16 Following the discovery conference, the court shall enter an 17 order tentatively identifying the issues for discovery purposes, 18 establishing a plan and schedule for discovery, setting limitations 19 on discovery, if any; and determining such other matters, including 20 the allocation of expenses, as are necessary for the proper 21 management of discovery in the action. In preparing the plan for 22 discovery the court shall protect the parties from excessive or 23 abusive use of discovery. An order shall be altered or amended 24 whenever justice so requires.

Subject to the right of a party who properly moves for a
 discovery conference to prompt convening of the conference, the
 court may combine the discovery conference with a pretrial
 conference.

SIGNING OF DISCOVERY REQUESTS, RESPONSES AND OBJECTIONS. 5 G. Every request for discovery, response or objection thereto made by a 6 7 party represented by an attorney shall be signed by at least one of the party's attorneys of record in the party's individual name whose 8 9 address shall be stated. A party who is not represented by an 10 attorney shall sign the request, response or objection and state the party's address. The signature of the attorney or party constitutes 11 12 a certification that the party has read the request, response or 13 objection, and that it is:

14 1. To the best of the party's knowledge, information and belief 15 formed after a reasonable inquiry consistent with the Oklahoma 16 Discovery Code and warranted by existing law or a good faith 17 argument for the extension, modification or reversal of existing 18 law;

Interposed in good faith and not primarily to cause delay or
 for any other improper purpose; and

3. Not unreasonable or unduly burdensome or expensive, given the nature and complexity of the case, the discovery already had in the case, the amount in controversy, and other values at stake in 24

the litigation. If a request, response or objection is not signed,
 it shall be deemed ineffective.

3	If a certification is made in violation of the provisions of
4	this subsection, the court, upon motion or upon its own initiative,
5	shall impose upon the person who made the certification, the party
6	on whose behalf the request, response or objection is made, or both,
7	an appropriate sanction, which may include an order to pay to the
8	amount of the reasonable expenses occasioned thereby, including a
9	reasonable attorney fee.
10	SECTION 5. This act shall become effective November 1, 2023.
