6	AS INTRODUCED
7	An Act relating to prisons and reformatories; amending 57 O.S. 2011, Section 332.2, as last amended
8	by Section 5, Chapter 459, O.S.L. 2019 (57 O.S. Supp. 2020, Section 332.2), which relates to commutations;
9	prohibiting recommendations for commuting restitution; clarifying eligibility requirements for
10	commutations; defining term; updating internal citation; and declaring an emergency.

13	
14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 57 O.S. 2011, Section 332.2, as
16	last amended by Section 5, Chapter 459, O.S.L. 2019 (57 O.S. Supp.
17	2020, Section 332.2), is amended to read as follows:
18	Section 332.2 A. The Pardon and Parole Board, which shall meet
19	only on the call of the Chairman, is authorized, if and when an
20	application made to the Governor for a reprieve, commutation,
21	parole, pardon, or other act of clemency is certified thereto by the
22	Governor, to examine into the merits of said application and make
23	recommendations to the Governor in relation thereto, said
24	

1 recommendation recommendations being advisory to the Governor and 2 not binding thereon.

B. <u>1.</u> Any consideration for commutation shall be made only
after application is made to the Pardon and Parole Board pursuant to
the procedures set forth in this section. The Pardon and Parole
Board shall provide a copy of the application to the district
attorney, the victim or representative of the victim and the Office
of the Attorney General within ten (10) business days of receipt of
such application.

10 <u>2. The Pardon and Parole Board shall be prohibited from</u> 11 <u>recommending to the Governor any application that seeks to commute</u> 12 restitution owed by a person in a criminal case.

13 <u>3. Inmates in the custody of the Department of Corrections or</u> 14 <u>persons serving a probationary term as a result of the suspension of</u> 15 a sentence shall be eligible for commutation consideration.

16 C. An application for commutation, other than those provided 17 for in subsection F of this section, must be sent to the trial 18 officials, who shall have twenty (20) business days to provide a 19 written recommendation or protest prior to consideration of the 20 application. Trial officials shall include:

21 1. The current elected judge of the court where the conviction 22 was had;

23 2. The current elected district attorney of the jurisdiction24 where the conviction was had; or

3. The chief or head administrative officer of the arresting
 law enforcement agency.

D. In cases resolved prior to the tenure of the present
officeholders, the recommendation or protest of persons holding such
offices at the time of conviction may also be considered by the
Board.

7 E. The recommendation for commutation of a sentence by a trial8 official may include the following:

9 1. A statement that the penalty now appears to be excessive;
10 2. A recommendation of a definite term now considered by the
11 official as just and proper; and

3. A statement of the reasons for the recommendation based upon facts directly related to the case which were not available to the court or jury at the time of the trial or based upon there having been a statutory change in penalty for the crime which makes the original penalty appear excessive.

17 F. The Pardon and Parole Board shall establish an accelerated, 18 single-stage commutation docket for any applicant who has been 19 convicted of a crime that has been reclassified from a felony to a 20 misdemeanor under Oklahoma law. The Pardon and Parole Board shall 21 be empowered to recommend to the Governor for commutation, by 22 majority vote, any commutation application placed on the 23 accelerated, single-stage commutation docket that meets the eligibility criteria provided above. The Department of Corrections 24

1 shall certify a list of potentially eligible inmates to the Pardon 2 and Parole Board within thirty (30) days of the effective date of 3 this act. <u>As used in this subsection</u>, "any applicant" shall include 4 <u>inmates in the custody of the Department of Corrections or persons</u> 5 <u>serving a probationary term as a result of the suspension of a</u> 6 sentence.

G. The Pardon and Parole Board shall schedule the application on a commutation docket in compliance with the notice requirements set forth herein. The Board shall provide the victim or representative of the victim at least twenty (20) days to offer recommendations or protests before consideration of the application.

H. Applications for commutation shall be given impartial review as required in Section 10 of Article VI of the Oklahoma Constitution.

15 I. Any consideration for pardon shall be made only after 16 application is made to the Pardon and Parole Board. Upon receipt of 17 an application for pardon, the Board shall provide a copy of the 18 application to the district attorney, the victim or representative 19 of the victim and the Office of the Attorney General within twenty 20 (20) business days of receipt of such application. The district 21 attorney and the victim or representative of the victim shall have 22 twenty (20) business days to provide written recommendation or 23 protest prior to the consideration of the application. The Board

shall schedule the application on a pardon docket in compliance with
 the notice requirements set forth herein.

J. In accordance with Section 10 of Article VI of the Oklahoma Constitution, the Board shall communicate to the Legislature, at each regular session, by providing a summary of the activities of the Board. This summary shall include, but not be limited to, the following Board activity activities:

8 1. The approval or recommendation rates of the Board for both
9 violent and nonviolent offenses;

The parole approval rates for each individual Board member
 for both violent and nonviolent offenses; and

12 3. The percentage of public comments to and personal 13 appearances before the Board including victim protests and personal 14 appearances, district attorney protests and personal appearances, 15 and delegate recommendations and personal appearances on behalf of 16 the offender.

This summary shall be made available to the public throughpublication on the website of the Pardon and Parole Board.

19 K. The Pardon and Parole Board shall provide a copy of their 20 regular docket and administrative parole docket to each district 21 attorney in this state at least twenty (20) days before such docket 22 is considered by the Board, or in the case of a supplemental, 23 addendum or special docket, at least ten (10) days before such 24 docket is considered by the Board, and shall notify the district

attorney of any recommendations for commutations or paroles no later
 than twenty (20) days after the docket is considered by the Board.

The Pardon and Parole Board shall notify all victims or 3 L. 4 representatives of the victim in writing at least twenty (20) days 5 before an inmate is considered by the Board provided the Board has received a request from the victim or representatives of the victim 6 7 for notice. The Board shall provide all victims or representatives of the victim with the date, time and place of the scheduled meeting 8 9 and rules for attendance and providing information or input to the 10 Board regarding the inmate or the crime. If requested by the victim 11 or representatives of the victim, the Board shall allow the victim 12 or representatives of the victim to testify at the parole hearing of 13 the inmate for at least five (5) minutes.

M. The Pardon and Parole Board shall notify all victims or representatives of the victim in writing of the decision of the Board no later than twenty (20) days after the inmate is considered by the Board.

N. Any notice required to be provided to the victims or the representatives of the victim shall be mailed by first-class mail to the last-known address of the victim or representatives of the victim. It is the responsibility of the victims or representatives of the victim to provide the Pardon and Parole Board a current mailing address. The victim-witness coordinator of the district attorney shall assist the victims or representatives of the victim

1 with supplying their address to the Board if they wish to be notified. Upon failure of the Pardon and Parole Board to notify a 2 3 victim who has requested notification and has provided a current 4 mailing address, the final decision of the Board may be voidable, 5 provided, the victim who failed to receive notification requests a reconsideration hearing within thirty (30) days of the 6 7 recommendation by the Board for parole. The Pardon and Parole Board may reconsider previous action and may rescind a recommendation if 8 9 deemed appropriate as determined by the Board.

0. For purposes of this section, "victim" shall mean all persons who have suffered direct or threatened physical or emotional harm, or financial loss as the result of the commission or attempted commission of criminally injurious conduct, and "representatives of the victim" shall mean those persons who are members of the immediate family of the victim, including stepparents, stepbrothers, stepsisters, and stepchildren.

17 Ρ. All meetings of the Pardon and Parole Board shall comply 18 with Section 301 et seq. of Title 25 of the Oklahoma Statutes Open 19 Meeting Act; provided that the Board shall have the authority to 20 limit the number of persons attending in support of, or in 21 opposition to, any inmate being considered for parole and shall have 22 the authority to exclude persons from attendance in accordance with 23 prison security regulations and the capacity of the meeting room. 24 Persons excluded from attending the meeting under this provision

1 shall be informed of their right to be informed of the vote of the 2 Board in accordance with Section 312 of Title 25 of the Oklahoma 3 Statutes. Provided further, nothing in this section shall be 4 construed to prevent any member of the press or any public official 5 from attending any meeting of the Pardon and Parole Board, except as 6 provided by the Oklahoma Open Meeting Act. 7 Q. All victim information maintained by the Department of Corrections and the Pardon and Parole Board shall be confidential 8 9 and shall not be released. 10 SECTION 2.
