10 An Act relating to roads and bridges; designating the
11 Chief Jon Hansen Memorial Bridge; designating the
12 Veterans Memorial Bridge; designating the Deputy
13 Sheriff Douglas Hanna Memorial Bridge; designating
14 the Michael "Mike" Dale Russell Memorial Bridge;
15 designating the 2nd Lt Faythe McGinnis Memorial
16 Highway; designating the PFC Jackie Lindell Elston
17 Memorial Bridge; designating the Trooper Houston F.
18 "Pappy" Summers Memorial Bridge; designating the LCpl
19 Geoffrey Fisher, USMC Memorial Bridge; designating
20 the Veterans' Memorial Bridge; designating the Eugene
21 Woodrow Wicker Memorial Highway; amending Section 12,
22 Chapter 240, O.S.L. 2015 (69 O.S. Supp. 2017, Section
23 1698.223), which relates to the Bill Milroy Memorial
24 Bridge; clarifying bridge location; amending Section
11, Chapter 216, O.S.L. 2017 (69 O.S. Supp. 2017,
Section 1698.259), which relates to the Pearl Harbor
Veterans: CBM Doyle E. Winters, BM1c Jerry E. Roop
and S2c Donald G. Loe Memorial Highway; modifying
memorial highway name; providing for codification;
and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.269 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The bridge located on Interstate Highway 235 crossing N.E. 23rd
5 Street in Oklahoma City shall be designated as the "Chief Jon Hansen
6 Memorial Bridge". The Department of Transportation shall cause
7 suitable permanent markers bearing that name to be placed on the
8 bridge.

9 SECTION 2. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.272 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 The bridge located on State Highway 66 crossing Pryor Creek
13 approximately three-tenths (0.3) miles east of Chelsea in Rogers
14 County shall be designated as the "Veterans Memorial Bridge". The
15 Department of Transportation shall cause suitable permanent markers
16 bearing that name to be placed on the bridge.

17 SECTION 3. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 1698.273 of Title 69, unless
19 there is created a duplication in numbering, reads as follows:

20 The bridge located on State Highway 44 over South Elk Creek
21 approximately three and two-tenths (3.2) miles north of State
22 Highway 9 in Kiowa County shall be designated as the "Deputy Sheriff
23 Douglas Hanna Memorial Bridge". The Department of Transportation
24

1 shall cause suitable permanent markers bearing that name to be
2 placed on the bridge.

3 SECTION 4. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.274 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The bridge located on U.S. Highway 412A crossing over U.S.
7 Highway 412 in Delaware County shall be designated as the "Michael
8 "Mike" Dale Russell Memorial Bridge". The Department of
9 Transportation shall cause suitable permanent markers bearing that
10 name to be placed on the bridge.

11 SECTION 5. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 1698.275 of Title 69, unless
13 there is created a duplication in numbering, reads as follows:

14 The portion of U.S. Highway 69 beginning at the junction of U.S.
15 Highway 69 and W. Shawnee Street in Muskogee County extending north
16 to the junction of U.S. Highway 69 and W. Fern Mountain Road in
17 Muskogee County shall be designated as the "2nd Lt Faythe McGinnis
18 Memorial Highway". The Department of Transportation shall cause
19 suitable permanent markers bearing that name to be placed on the
20 highway.

21 SECTION 6. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 1698.277 of Title 69, unless
23 there is created a duplication in numbering, reads as follows:

1 The bridge located on State Highway 183 crossing Calvary Creek
2 south of New Cordell in Washita County shall be designated as the
3 "PFC Jackie Lindell Elston Memorial Bridge". The Department of
4 Transportation shall cause suitable permanent markers bearing that
5 name to be placed on the bridge.

6 SECTION 7. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 1698.278 of Title 69, unless
8 there is created a duplication in numbering, reads as follows:

9 The bridge located on U.S. Highway 412 approximately one-half
10 (0.5) mile west of N2820 Road in Garfield County shall be designated
11 as the "Trooper Houston F. "Pappy" Summers Memorial Bridge". The
12 Department of Transportation shall cause suitable permanent markers
13 bearing that name to be placed on the bridge.

14 SECTION 8. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 1698.280 of Title 69, unless
16 there is created a duplication in numbering, reads as follows:

17 The bridge located on U.S. Highway 69 crossing U.S. Highway 64E
18 in Muskogee County shall be designated as the "LCpl Geoffrey Fisher,
19 USMC Memorial Bridge". The Department of Transportation shall cause
20 suitable permanent markers bearing that name to be placed on the
21 bridge.

22 SECTION 9. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 1698.281 of Title 69, unless
24 there is created a duplication in numbering, reads as follows:

1 The bridge located on U.S. Highway 81 crossing over West
2 Chestnut Avenue within the municipal limits of Enid in Garfield
3 County shall be designated as the "Veterans' Memorial Bridge". The
4 Department of Transportation shall cause suitable permanent markers
5 bearing that name to be placed on the bridge.

6 SECTION 10. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 1698.282 of Title 69, unless
8 there is created a duplication in numbering, reads as follows:

9 The portion of State Highway 72 beginning at the junction of
10 State Highway 51 and State Highway 72 extending south to the
11 junction of State Highway 72 and East 151st Street South in the
12 municipal limits of Coweta in Wagoner County shall be designated as
13 the "Eugene Woodrow Wicker Memorial Highway". The Department of
14 Transportation shall cause suitable permanent markers bearing that
15 name to be placed on the highway.

16 SECTION 11. AMENDATORY Section 12, Chapter 240, O.S.L.
17 2015 (69 O.S. Supp. 2017, Section 1698.223), is amended to read as
18 follows:

19 Section 1698.223. The bridge located on State Highway 56 in
20 Okmulgee County approximately ~~five-tenths (0.5) of a mile~~ one and
21 one-half (1.5) miles west of the junction of State Highway 56 and S.
22 Madison Avenue in Okmulgee shall be designated as the "Bill Milroy
23 Memorial Bridge". The Department of Transportation shall cause
24

1 suitable permanent markers to be placed upon the bridge bearing that
2 name.

3 SECTION 12. AMENDATORY Section 11, Chapter 216, O.S.L.
4 2017 (69 O.S. Supp. 2017, Section 1698.259), is amended to read as
5 follows:

6 Section 1698.259. The portion of U.S. Highway 59 in LeFlore
7 County beginning at the intersection of U.S. Highway 59 and State
8 Highway 128 in Heavener extending north two (2) miles shall be
9 designated as the "Pearl Harbor ~~Veterans~~ Survivors: CBM Doyle E.
10 Winters, BM1c Jerry E. Roop ~~and~~, S2c Donald G. Loe and AM1 J.D.
11 Barnes Memorial Highway". The Department of Transportation shall
12 cause suitable permanent markers bearing that name to be placed on
13 the highway.

14 SECTION 13. This act shall become effective November 1, 2018.
