AMENDATORY 47 O.S. 2011, Section 11-705, is 15 amended to read as follows: 16 Section 11-705. A. The driver of a vehicle meeting or 17 overtaking a school bus that is stopped to take on or discharge 18 school children, and on which the red loading signals are in 19 operation, is to stop the vehicle before it reaches the school bus 20 and not proceed until the loading signals are deactivated and then 2.1 proceed past such school bus at a speed which is reasonable and with 22 due caution for the safety of such school children and other 23 occupants. Any person convicted of violating the provisions of this

subsection shall be punished by a fine of not less than One Hundred Dollars (\$100.00).

- B. Visual signals, meeting the requirements of Section 12-228 of this title, shall be actuated by the driver of said school bus whenever, but only whenever, such vehicle is stopped on the highway for the purpose of receiving or discharging school children.
- C. The driver of a vehicle upon a highway with separate roadways need not stop upon meeting or passing a school bus which is on a different roadway or when upon a controlled-access highway and the school bus is stopped in a loading zone which is a part of or adjacent to such highway and where pedestrians are not permitted to cross the roadway.
- D. If the driver of a school bus witnesses a violation of the provisions of subsection A of this section, within twenty-four (24) hours of the alleged offense, the driver shall report the violation, the vehicle color, license tag number, and the time and place such violation occurred to the law enforcement authority of the municipality where the violation occurred. The law enforcement authority of a municipality shall issue a letter of warning on the alleged violation to the person in whose name the vehicle is registered. The Office of the Attorney General shall provide a form letter to each municipal law enforcement agency in this state for the issuance of the warning provided for in this subsection. Such form letter shall be used by each such law enforcement agency in the

exact form provided for by the Office of the Attorney General. A warning letter issued pursuant to this subsection shall not be recorded on the driving record of the person to whom such letter was issued. Issuance of a warning letter pursuant to this section shall not preclude the imposition of other penalties as provided by law.

- E. 1. A school district may install and operate a videomonitoring system in or on the school buses operated by the district
 or contract with a private vendor to do so on behalf of the school
 district for the purpose of recording violations of subsection A of
 this section. If a citation is issued for violation of this section
 the person who receives the citation shall have at least thirty (30)
 business days from the date of the issuance of the citation to
 inspect information collected by a video-monitoring system in
 connection with the violation.
- 2. For the purposes of this subsection, "video-monitoring system" means a system with one or more camera sensors and computers installed and operated on a school bus that produces live digital and recorded video of motor vehicles being operated in violation of this section. The system shall, at a minimum, produce a recorded image of the license plate of the vehicle and shall record the activation status of at least one warning device as prescribed in Section 12-228 of this title and the time, date and location of the vehicle when the image is recorded.
