6	AS INTRODUCED
7	An Act relating to motor vehicles; amending 47 O.S.
8	2011, Section 11-801, as last amended by Section 1, Chapter 237, O.S.L. 2018 (47 O.S. Supp. 2018, Section
9	11-801), which relates to speed limits; prohibiting leniency for certain speeding violations; and
10	providing an effective date.
11	
12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. AMENDATORY 47 O.S. 2011, Section 11-801, as
14	last amended by Section 1, Chapter 237, O.S.L. 2018 (47 O.S. Supp.
15	2018, Section 11-801), is amended to read as follows:
16	Section 11-801. A. Any person driving a vehicle on a highway
17	shall drive the same at a careful and prudent speed not greater than
18	nor less than is reasonable and proper, having due regard to the
19	traffic, surface and width of the highway and any other conditions
20	then existing. No person shall drive any vehicle upon a highway at
21	a speed greater than will permit the driver to bring it to a stop
22	within the assured clear distance ahead.
23	B. Except when a special hazard exists that requires lower
24	speed for compliance with subsection A of this section, the limits

specified by law or established as hereinafter authorized shall be maximum lawful speeds, and no person shall drive a vehicle on a highway at a speed in excess of the following maximum limits:

On a highway or part of a highway, unless otherwise
 established in law, a speed established by the Department of
 Transportation on the basis of engineering and traffic
 investigations used to determine the speed that is reasonable and
 safe under the conditions found to exist on the highway or part of
 the highway;

10 2. For a school bus, fifty-five (55) miles per hour on paved 11 two-lane roads except on the state highway system, the interstate 12 highway system and the turnpike system where the maximum shall be 13 sixty-five (65) miles per hour;

14 3. On any highway outside of a municipality in a properly 15 marked school zone, twenty-five (25) miles per hour, provided the 16 zone is marked with appropriate warning signs placed in accordance 17 with the latest edition of the Manual on Uniform Traffic Control 18 The Department of Transportation may determine on the Devices. 19 basis of an engineering and traffic investigation that a speed limit 20 higher than twenty-five (25) miles per hour may be reasonable and 21 safe under conditions as they exist upon a highway, and post an 22 alternative school zone speed limit. The Department shall mark such 23 school zones, or entrances and exits onto highways by buses or 24 students, so that the maximum speed provided by this section shall

1 be established therein. Exits and entrances to controlled-access 2 highways which are within such school zones shall be marked in the same manner as other highways. The county commissioners shall mark 3 4 such school zones along the county roads so that the maximum speed 5 provided by this section shall be established therein. The signs may be either permanent or temporary. The Department shall give 6 7 priority over all other signing projects to the foregoing duty to 8 mark school zones. The Department shall also provide other safety 9 devices for school zones which are needed in the opinion of the 10 Department;

11 4. Twenty-five (25) miles per hour or a posted alternative 12 school zone speed limit through state schools located on the state-13 owned land adjoining or outside the limits of a corporate city or 14 town where a state educational institution is established;

15 5. Thirty-five (35) miles per hour on a highway in any state 16 park or wildlife refuge. Provided, however, that the provisions of 17 this paragraph shall not include the State Capitol park area, and no 18 person shall drive any vehicle at a rate of speed in excess of 19 fifty-five (55) miles per hour on any state or federal designated 20 highway within such areas; and

6. For any vehicle or combination of vehicles with solid rubber
or metal tires, ten (10) miles per hour.

The maximum speed limits set forth in this section may be altered as authorized in Sections 11-802 and 11-803 of this title.

1 С. The Transportation Commission is hereby authorized to 2 prescribe maximum and minimum speeds for all vehicles and any combinations of vehicles using controlled-access highways. Such 3 4 regulations shall become effective after signs have been posted on 5 these highways giving notice thereof. Such regulations may apply to an entirely controlled-access highway or to selected sections 6 7 thereof as may be designated by the Commission. It shall be a 8 violation of this section to drive any vehicle at a faster rate of 9 speed than such prescribed maximum or at a slower rate of speed than 10 such prescribed minimum. However, all vehicles shall at all times 11 conform to the limits set forth in subsection A of this section. 12 Copies of such regulations certified as in effect on any 13 particular date by the Secretary of the Commission shall be accepted 14 as evidence in any court in this state. Whenever changes have been 15 made in speed zones, copies of such regulations shall be filed with 16 the Commissioner of Public Safety.

17 D. The Oklahoma Turnpike Authority is hereby authorized to 18 prescribe maximum and minimum speeds for trucks, buses and 19 automobiles using turnpikes. The regulation pertaining to 20 automobiles shall apply to all vehicles not commonly classified as 21 either trucks or buses. Such regulations shall become effective 22 only after approval by the Commissioner of Public Safety, and after 23 Such signs have been posted on the turnpike giving notice thereof. regulations may apply to an entire turnpike project or to selected 24

sections thereof as may be designated by the Oklahoma Turnpike
 Authority. It shall be a violation of this section to drive a
 vehicle at a faster rate of speed than such prescribed maximum speed
 or at a slower rate of speed than such prescribed minimum speed.
 However, all vehicles shall at all times conform to the requirements
 of subsection A of this section.

Copies of such regulations, certified as in effect on any
particular date by the Secretary of the Oklahoma Turnpike Authority,
shall be accepted in evidence in any court in this state.

10 The driver of every vehicle shall, consistent with the Ε. 11 requirements of subsection A of this section, drive at an 12 appropriate reduced speed when approaching and crossing an 13 intersection or railway grade crossing, when approaching and going 14 around a curve, when approaching a hillcrest, when driving upon any 15 narrow or winding roadway, and when special hazard exists with 16 respect to pedestrians or other traffic, or by reason of weather or 17 highway conditions. The Oklahoma Department of Transportation and 18 the Oklahoma Turnpike Authority may post, by changeable message sign 19 or other appropriate sign, a temporary reduced speed limit for 20 maintenance operations or when special hazards with respect to 21 pedestrians, other traffic, an accident, by reason of weather or 22 when other hazardous highway conditions exist.

F. 1. No person shall drive a vehicle on a county road at a speed in excess of fifty-five (55) miles per hour unless posted

1 otherwise by the board of county commissioners, as provided in 2 subparagraphs a through c of this paragraph, as follows:

- a. the board of county commissioners may determine, by
 resolution, a maximum speed limit which shall apply to
 all county roads which are not otherwise posted for
 speed,
- 7 b. the board of county commissioners shall provide public notice of the speed limit on all nonposted roads by 8 9 publication in a newspaper of general circulation in 10 the county. The notice shall be published once weekly 11 for a period of four (4) continuous weeks, and 12 с. the board of county commissioners shall forward the 13 resolution to the Director of the Department of 14 Transportation and to the Commissioner of Public 15 Safety.

16 The Department shall post speed limit information, as 2. 17 determined pursuant to the provisions of subparagraphs a through c 18 of paragraph 1 of this subsection, on the county line marker where 19 any state highway enters a county and at all off-ramps where 20 interstate highways or turnpikes enter a county. The signs shall 21 read as follows: $\sim \sim$

2	The appropriate board of county commissioners shall reimburse
3	the Department the full cost of the signage required herein.
4	G. Any person convicted of a speeding violation pursuant to
5	subsection B or F of this section shall be punished by a fine as
6	follows:
7	1. a. For an offense occurring on or after the effective
8	date of this act and prior to November 1, 2022, one to
9	ten miles per hour over the speed limit as provided
10	for in Section $\frac{2}{2}$ <u>11-801e</u> of this act title, and
11	b. For an offense occurring on or after
12	November 1, 2022, one to ten miles per
13	hour over the limit\$10.00
14	2. Eleven to fifteen miles per hour over the
15	limit\$20.00
16	3. Sixteen to twenty miles per hour over the
17	limit\$35.00
18	4. Twenty-one to twenty-five miles per hour over
19	the limit\$75.00
20	5. Twenty-six to thirty miles per hour over the
21	limit\$135.00
22	6. Thirty-one to thirty-five miles per hour over
23	the limit\$155.00
24	

1	7. Thirty-six miles per hour or more over the
2	limit\$205.00
3	or by imprisonment for not more than ten (10) days; for a second
4	conviction within one (1) year after the first conviction, by
5	imprisonment for not more than twenty (20) days; and upon a third or
6	subsequent conviction within one (1) year after the first
7	conviction, by imprisonment for not more than six (6) months, or by
8	both such fine and imprisonment.
9	H. Any driver convicted of a speeding violation in excess of
10	fifteen (15) miles per hour over the posted speed limit in a school
11	zone shall not be granted leniency or excusal from paying the fine
12	required in subsection G of this section.
13	SECTION 2. This act shall become effective November 1, 2019.
