15	SECTION 1. AMENDATORY 68 O.S. 2011, Section 2368.2, as						
16	amended by Section 1, Chapter 112, O.S.L. 2017 (68 O.S. Supp. 2018,						
17	Section 2368.2), is amended to read as follows:						
18	Section 2368.2 A. Except as exempted in subsection B of this						
19	section, if on September 1 of any year the total contributions to						
20	any one of the funds created through donations or contributions from						
21	income tax refunds by checking the appropriate box on the income tax						
22	return forms do not equal Fifteen Thousand Dollars (\$15,000.00) or						
23	more for three (3) consecutive years, the explanations and spaces						
24	for designating contributions to the fund shall be removed from the

income tax return forms for the following and all subsequent years.
 All contributions to the removed fund after September 1 shall be
 refunded to the taxpayer.

B. The provisions of this section shall not apply to the:
<u>1. The</u> Income Tax Checkoff Revolving Fund for the Support of
the Folds of Honor Scholarship Program authorized in Section 2368.19
of this title; or

8 <u>2. The Oklahoma Silver Haired Legislature - Excellence in State</u>
9 Government Revolving Fund.

10SECTION 2.AMENDATORY68 O.S. 2011, Section 2368.4, is11amended to read as follows:

Section 2368.4 A. The Oklahoma Tax Commission shall include on each state individual income tax return form for tax years beginning after December 31, 2002 2019, and each state corporate tax return form for tax years beginning after December 31, 2002 2019, an opportunity for the taxpayer to donate from a tax refund for the benefit of the Oklahoma Silver Haired Legislature and the Oklahoma Silver Haired Legislature Alumni Association activities.

B. The monies generated from donations made pursuant to subsection A of this section shall be used by the Department of Human Services for the following purposes:

22 1. a. To fund all reasonable expenses of:

23 (1) Oklahoma Silver Haired Legislators,

- (2) Oklahoma Silver Haired Legislature training
 sessions,
 - (3) Silver Haired Legislature interim studies, and
 - (4) Silver Haired Legislature advocacy activities approved by the Oklahoma Silver Haired Legislature Alumni Association Executive Board, and
- b. Monies authorized by this paragraph may only be used 8 9 for expenses incurred by Silver Haired Legislators and 10 alternates and other members of the Oklahoma Silver 11 Haired Legislature Alumni Association as approved by 12 the Oklahoma Silver Haired Legislature Alumni Association Executive Board for reasonable expenses 13 14 incurred in activities described in this section; 15 provided, no monies shall be expended for salaries; 16 and

17 2. Monies generated in excess of Fifty Thousand Dollars
18 (\$50,000.00) shall be used to fund those programs or services for
19 senior citizens which are recommended to the Department for funding
20 by the Oklahoma Silver Haired Legislature Alumni Association.

C. All monies generated pursuant to subsection A of this section shall be paid to the State Treasurer and placed to the credit of the Oklahoma Silver Haired Legislature - Excellence in State Government Revolving Fund.
