

1 return forms do not equal Fifteen Thousand Dollars (\$15,000.00) or
2 more for three (3) consecutive years, the explanations and spaces
3 for designating contributions to the fund shall be removed from the
4 income tax return forms for the following and all subsequent years.
5 All contributions to the removed fund after September 1 shall be
6 refunded to the taxpayer.

7 B. The provisions of this section shall not apply to ~~the~~:

8 1. The Income Tax Checkoff Revolving Fund for the Support of
9 the Folds of Honor Scholarship Program authorized in Section 2368.19
10 of this title; or

11 2. The Oklahoma Silver Haired Legislature - Excellence in State
12 Government Revolving Fund.

13 SECTION 2. AMENDATORY 68 O.S. 2011, Section 2368.4, is
14 amended to read as follows:

15 Section 2368.4 A. The Oklahoma Tax Commission shall include on
16 each state individual income tax return form for tax years beginning
17 after December 31, ~~2002~~ 2019, and each state corporate tax return
18 form for tax years beginning after December 31, ~~2002~~ 2019, an
19 opportunity for the taxpayer to donate from a tax refund for the
20 benefit of the Oklahoma Silver Haired Legislature and the Oklahoma
21 Silver Haired Legislature Alumni Association activities.

22 B. The monies generated from donations made pursuant to
23 subsection A of this section shall be used by the Department of
24 Human Services for the following purposes:

1 1. a. To fund all reasonable expenses of:

2 (1) Oklahoma Silver Haired Legislators,

3 (2) Oklahoma Silver Haired Legislature training
4 sessions,

5 (3) Silver Haired Legislature interim studies, and

6 (4) Silver Haired Legislature advocacy activities
7 approved by the Oklahoma Silver Haired
8 Legislature Alumni Association Executive Board,
9 and

10 b. Monies authorized by this paragraph may only be used
11 for expenses incurred by Silver Haired Legislators and
12 alternates and other members of the Oklahoma Silver
13 Haired Legislature Alumni Association as approved by
14 the Oklahoma Silver Haired Legislature Alumni
15 Association Executive Board for reasonable expenses
16 incurred in activities described in this section;
17 provided, no monies shall be expended for salaries;
18 and

19 2. Monies generated in excess of Fifty Thousand Dollars
20 (\$50,000.00) shall be used to fund those programs or services for
21 senior citizens which are recommended to the Department for funding
22 by the Oklahoma Silver Haired Legislature Alumni Association.

23 C. All monies generated pursuant to subsection A of this
24 section shall be paid to the State Treasurer and placed to the

1 credit of the Oklahoma Silver Haired Legislature - Excellence in
2 State Government Revolving Fund.

3 SECTION 3. This act shall become effective November 1, 2019.
