AMENDATORY 20 O.S. 2011, Section 106.9, as 14 amended by Section 1, Chapter 31, O.S.L. 2019 (20 O.S. Supp. 2020, 15 Section 106.9), is amended to read as follows: 16 Section 106.9 A. Each court reporter regularly engaged by the 17 district court, the Workers' Compensation Court of Existing Claims, 18 or the Corporation Commission shall be paid a salary pursuant to the 19 salary schedule established by the annual appropriation for the 20 district courts and Corporation Commission and in accordance with 21 the job description for the position to which appointed. On October 22 1, 2021, each court reporter shall receive a one-time stipend of Two 23 Thousand Five Hundred Dollars (\$2,500.00).

1 In addition to their base salaries, official court reporters в. 2 who are certified or licensed shorthand reporters and those acting shorthand reporters pursuant to paragraph c of Section 106.3B of 3 4 this title shall be paid annually the sum of Four Hundred Dollars 5 (\$400.00) for each year of service to the district court, the Workers' Compensation Court, the Workers' Compensation Court of 6 7 Existing Claims and the Corporation Commission, with a maximum of twenty (20) years of service only to be used for the purpose of 8 9 longevity, not to exceed Eight Thousand Dollars (\$8,000.00) per 10 year, payable monthly. 2. The sum of One Thousand Five Hundred Dollars (\$1,500.00) per 8 9 year, payable monthly, to any official court reporter who is a 10 Registered Merit Reporter (RMR), as recognized by the State Board of 11 Examiners of Certified Shorthand Reporters. To qualify as a RMR, an 12 official court reporter shall have a proficiency level in reporting 13 testimony and proceedings of a speed of not less than two hundred 14 sixty (260) words per minute in taking a question-and-answer-type 15 dictation, two hundred forty (240) words per minute in taking a jury 16 charge and two hundred (200) words per minute in taking literary 17 material, shall pass a Written Knowledge Test with a score of at 18 least seventy percent (70%), all as determined by an examination 19 recognized by the Board, and shall complete thirty (30) hours of 20 continuing education per three-year cycle commencing at the date of 21 recognition;
