Supp. 2015, 16 Section 1-323), is amended to read as follows: 17 Section 1-323. A. To protect the integrity of vital statistics 18 records, to insure ensure their proper use, and to insure ensure the 19 efficient and proper administration of the vital statistics system, 20 it shall be unlawful for any person to permit inspection of, or to 21 disclose information contained in, vital statistics records, or to 22 copy or issue a copy of all or part of any such record except to the 23

person who is the subject of the record or in such person's interest

unless ordered to do so by a court of competent jurisdiction;

provided that death certificates shall be considered publicly
available records seventy-five (75) years after the death and birth
certificates shall be considered publicly available records one
hundred twenty-five (125) years after the birth. Certified copies
of birth certificates and death certificates shall be provided
without cost and without a court order to the Attorney General or to
any district attorney upon request in the course of a criminal
investigation.

- B. The State Registrar shall review and may authorize each applicant requesting an electronic verification of a birth or death certificate through a system for legal or administrative purposes when requested by:
 - a. a government agency in conduct of its official business,
 - b. a benefit-paying party, such as an annuity company, pension plan or life insurance company to determine benefit status,
 - c. physicians licensed to practice in the United States
 to determine if a patient has been lost to care,
 - <u>d.</u> attorneys licensed to practice in the United States
 who demonstrate the information is necessary in order
 to administer a client's estate, or
 - e. other entities for fraud prevention, as determined by the State Registrar.

C. Other than for an electronic record's intended use, as described in this section, any person or entity receiving an electronic version of a birth or death record is prohibited from disclosing any information contained in such record. The State Registrar shall charge a fee which shall not exceed Four Dollars (\$4.00) for each record requested as set forth in subsection B of this section. Additional fees may be charged by a subcontractor providing a computer system, billing and collection services for verifications processed using the subcontractor's services. The State Commissioner of Health may waive the state portion of the fee for governmental agencies of the State of Oklahoma.

D. No later than July 1, 2017, the State Department of Health shall make a public birth and death index available on its website which shall contain the subject's name, gender, date of the birth or death and the county in which the birth or death occurred. The entire birth and death index shall be in a digitized format. An individual record contained in the index may be accessed through a web portal on the Department's website at no cost. Any individual or entity that desires to obtain portions of or the entire birth or death index shall pay a fee established by the State Board of Health. The index shall include data for births and deaths occurring more than twenty-five (25) years after the year of the birth or death.

- $\underline{\text{E.}}$ The State Commissioner of Health may authorize the disclosure of data contained in vital statistics records for public health surveillance or research purposes.
- C. F. The State Department of Health shall transmit to the Department of Public Safety:
- 1. At the end of each quarter year, a list of all registered deaths which have occurred during such period of time. Upon receipt of such list the Department of Public Safety shall use such list solely to update Department of Public Safety records and to cancel the driver license for those deceased individuals with a valid Oklahoma driver license at the time of death;
- 2. At the end of each month, a report of all registered deaths that resulted from a motor vehicle collision which have occurred during such period of time. The report shall be used by the Department solely for the purpose of statistical analysis and reporting; and
- 3. Upon written request from the Department, a death certificate. The certificate shall be used solely by the Fatality Analysis Reporting System (FARS) Analyst of the Oklahoma Highway Safety Office to populate the federal FARS database.
- D. G. Each month, the Commissioner shall authorize the transmission to the Oklahoma Health Care Authority of a certified list of all registered deaths of residents of this state that have occurred within the state for the immediately preceding month. The

- 1 Oklahoma Health Care Authority shall use the transmitted list to
- 2 ascertain the names of those individuals participating in the state
- 3 | Medicaid program who are deceased, and shall thereafter terminate
- 4 | such deceased person's enrollment in the state Medicaid program.
- 5 E. H. For the purpose of assisting in the location and recovery
- 6 of missing children, information pertaining to birth certificates
- 7 and requests for copies of birth certificates shall be provided to
- 8 | the Oklahoma State Bureau of Investigation pursuant to the
