13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. NEW LAW A new section of law to be codified
15	in the Oklahoma Statutes as Section 6301 of Title 74, unless there
16	is created a duplication in numbering, reads as follows:
17	As used in this act:
18	1. "Extremely low-income household" means a household income
19	not in excess of thirty percent (30%) of the area median income,
20	adjusted for the size of the household, as determined by the United
21	States Department of Housing and Urban Development;
22	2. "Very low-income household" means a household income of more
23	than thirty percent (30%) of the area median income but no more than
24	fifty percent (50%) of the area median income, adjusted for the size

of the household, as determined by the United States Department of
 Housing and Urban Development;

3 3. "Low-income household" means a household income of more than
4 fifty percent (50%) of the area median income but no more than
5 eighty percent (80%) of the area median income, adjusted for the
6 size of the household, as determined by the United States Department
7 of Housing and Urban Development;

8 4. "Moderate-income household" means a household income of more
9 than eighty percent (80%) of the area median income but no more than
10 one hundred twenty percent (120%) of the area median income,
11 adjusted for the size of the household, as determined by the United
12 States Department of Housing and Urban Development; and

5. "Middle-income household" means a household that has an income of more than one hundred twenty percent (120%) of the area median income but no more than one hundred sixty percent (160%) of the area median income, adjusted for the size of the household, as determined by the United States Department of Housing and Urban Development.

19 SECTION 2. NEW LAW A new section of law to be codified 20 in the Oklahoma Statutes as Section 6302 of Title 74, unless there 21 is created a duplication in numbering, reads as follows:

A. There is hereby created until December 30, 2034, theOklahoma Affordable Housing Commission. The Commission shall be

8		defined by the Federal Reserve,
9	d.	one shall be an official serving in a municipality
10		with a population more than one hundred thousand
11		(100,000) persons according to the latest Federal
12		Decennial Census, and
13	e.	one shall represent an urban housing authority;
14	3. Five	members shall be appointed by the Speaker of the House
15	of Representa	atives:
16	a.	one shall be a House member from the majority party
17		who shall serve as co-chair of the Commission,
18	b.	one shall be a House member from the minority party
19		who shall serve as co-vice chair of the Commission,
20	c.	one shall represent a federally recognized tribe in
21		Oklahoma that provides affordable housing in rural
22		areas,
23	d.	one shall be a representative from a community housing
24		development organization, as determined by the United
	1	

1	States Department of Housing and Urban Development,
2	and
3	e. one shall represent a not-for-profit organization that
4	serves low-income Oklahomans experiencing difficulty
5	in obtaining affordable housing; and
6	4. The following shall be ex officio members:
7	a. one shall be from the Oklahoma Department of Commerce
8	Community Development Division, or his or her
9	designee,
10	b. one shall be an Oklahoma representative of the United
11	States Department of Agriculture, and
12	c. the Executive Director of the Oklahoma Housing Finance
13	Agency, or designee.
14	B. For the initial appointments of members to the Commission,
15	each appointment shall be for a two-year term. Thereafter, the
16	terms of the Commission shall be for three (3) years.
17	C. No member of the Commission shall receive a salary or
18	reimbursement for duties performed as a member of the Commission;
19	however, members may be eligible to receive travel reimbursement as
20	provided in the State Travel Reimbursement Act.
21	D. The meetings of the Commission shall be subject to the
22	Oklahoma Open Meeting Act.
23	E. The Commission shall utilize the resources available to it
24	in order to address the needs of extremely low-income households,

very low-income households, low-income households, moderate-income households, and middle-income households in order to promote a condition in which suitable housing is available to as many persons as possible pursuant to rules promulgated by the Oklahoma Housing Finance Agency pursuant to Section 3 of this act.

6 SECTION 3. NEW LAW A new section of law to be codified 7 in the Oklahoma Statutes as Section 6303 of Title 74, unless there 8 is created a duplication in numbering, reads as follows:

9 The Oklahoma Housing Finance Agency shall promulgate rules to 10 implement:

An initial comprehensive Oklahoma affordable housing
 environmental scan and needs assessment;

A comprehensive Oklahoma affordable housing annual report
 and action plan to be submitted electronically to the Governor and
 the Legislature;

16 3. A plan for long-term expansion of affordable housing across17 the state;

4. An update on the implementation and outcomes of the
investment in the Oklahoma Housing Stability Program created in
Section 2903 et seq. of Title 74 of the Oklahoma Statutes;

5. Evaluate and make recommendations to the Legislature on
policies and incentives to increase the development, inventory, and
diversification of affordable housing; and

2	mission of the Oklahoma Affordable Housing Commission pursuant to
3	Section 2 of this act.
