13 An Act relating to state government; amending 74 O.S.
14 2011, Section 4258, as last amended by Section 1,
15 Chapter 150, O.S.L. 2015 (74 O.S. Supp. 2018, Section
16 4258), which relates to the Ethics Commission Fund;
17 limiting annual deposits to Fund; providing for
18 deposit of collections in excess of limit; providing
19 an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 74 O.S. 2011, Section 4258, as
last amended by Section 1, Chapter 150, O.S.L. 2015 (74 O.S. Supp.
2018, Section 4258), is amended to read as follows:

Section 4258. A. There is hereby created in the State Treasury
a revolving fund for the Ethics Commission to be designated the

1 "Ethics Commission Fund". The ~~fund~~ Ethics Commission Fund shall be
2 a continuing fund, not subject to fiscal year limitations and shall
3 consist of ~~all~~ the first One Hundred Fifty Thousand Dollars
4 (\$150,000.00) of fees received by the Commission each fiscal year.
5 Fees collected each fiscal year in excess of One Hundred Fifty
6 Thousand Dollars (\$150,000.00) shall be placed to the credit of the
7 General Revenue Fund.

8 B. All monies accruing to the credit of the ~~fund~~ Ethics
9 Commission Fund are hereby appropriated and may be budgeted and
10 expended by the Commission for any expenses incurred in the
11 implementation of its duties as provided by law. Expenditures from
12 the fund shall be made upon warrants issued by the State Treasurer
13 against claims filed as prescribed by law with the Director of the
14 Office of Management and Enterprise Services for approval and
15 payment.

16 SECTION 2. This act shall become effective July 1, 2019.

17 SECTION 3. It being immediately necessary for the preservation
18 of the public peace, health or safety, an emergency is hereby
19 declared to exist, by reason whereof this act shall take effect and
20 be in full force from and after its passage and approval.
