15	SECTION 1. AMENDATORY 74 O	.S. 2011, Section 4258, as

17	2018, Section 4258), is amended to read as follows:		
18	Section 4258. A. There is hereby created in the State Treasury		
19	a revolving fund for the Ethics Commission to be designated the		
20	"Ethics Commission Fund". The fund Ethics Commission Fund shall be		
21	a continuing fund, not subject to fiscal year limitations and shall		
22	consist of all the first One Hundred Fifty Thousand Dollars		
23	(\$150,000.00) of fees received by the Commission each fiscal year.
