Enterprise Services shall submit reports to the Speaker of the
Oklahoma House of Representatives, the President Pro Tempore of the
Oklahoma State Senate, the Chair of the Appropriations and Budget
Committee of the Oklahoma House of Representatives and the Chair of
the Appropriations Committee of the Oklahoma State Senate detailing:

SECTION 2. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
